# **ENTRY ELIGIBILITY**

- 1. Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned
- 2. Dogs must be 6 months of age on the day of the event.
- 3. An unentered dog may not be substituted for an entered dog.
- 4. Temporary Listings (TL) are not available at the event. Please contact UKC directly prior to the event for a TL.

## **ENTRIES**

- 1. **Pre-Entries:** Licensed Classes: \$25.00 per entry, KSH members: \$22.00 per entry. CASH, E-TRANSFER or CHEQUE ONLY. US competitors only, contact us regarding using PayPal.
- 2. Entries open on March 1st, 2025.

Please do not send entries before this date – they will not be processed and you will be asked to re-submit once the trial opens.

Entries must be received by event staff before April 7th, 2024.

Entries received after April 7th will be charged Day of Show Price.

3. **Day of show entries (DOS):** \$28.00 per entry, KSH members \$25.00. CASH, E-TRANSFER or CHEQUE ONLY.

#### SUBMITTING ENTRIES

- 1. Entries must be submitted on the current Official UKC Nosework Entry Form. Downloaded copies or photocopies of these forms may be used as well. Please used the latest version of the entry form. If you use an outdated form, you will be asked to resubmit your entry on the correct form.
- 2. Incomplete entries will not be accepted.
- 3. Pre-entries may be mailed, scanned and emailed, or hand-delivered to the Event Secretary.
- 4. **Mailed Entries** must include the entire form and be signed. Mailed entries received without fees will not be accepted.

#### **PAYMENT**

1. Payment may be made by cash, e-transfer or cheque.

Fees must be in Canadian funds. No entry will be accepted without payment.

- 2. Make cheques payable to "Kootenay Scent Hounds".
- 3. Returned cheques do not constitute valid entry fees.
- 4. US competitors only, please contact us about using PayPal for entry fees.

#### **REFUNDS**

- 1. Entry fees will be fully refunded up to the day before the trial begins provided that a written request is made to the Trial Secretary. Should the event be cancelled, entry fees will be refunded
- 2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Event Committee.
- 3. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.
- 4. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.
- 5. If, in the opinion of the host club, the wellbeing of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

## **Site Information:**

There will be indoor crating space available on Saturday afternoon for competitors whose vehicles are in use for the trial. In all other instances, dogs must be crated in vehicles. Owners are expected to pick up after their dogs.

Food will not be available on site, restaurants and grocery stores are within a 5 min drive. There is cell service at Mt. Sentinel Secondary School.

#### **Driving Directions:**

From Castlegar, head towards Nelson on Highway 3A. Stay on Highway 3A for approximately 16 km (if coming from north Castlegar) until you come to the Highway 3A/6 junction (signs for Slocan/Nakusp/New Denver). Turn left onto Highway 6. Take your first right onto Osachoff Road, and

turn right onto Eden Road. The school will be on your left (there are two entrances). This is a dead-end road.

From Nelson, head towards Castlegar on Highway 3A. Stay on Highway 3A for approximately 21 km until you come to the Highway 3A/6 junction (signs for Slocan/Nakusp/New Denver). Turn right onto Highway 6. Take your first right onto Osachoff Road, and turn right onto Eden Road. The school will be on your left (there are two entrances). This is a dead-end road.

**Hotel Information:** Several pet friendly hotels/motels are located within Castlegar, as well as within Nelson. Castlegar options include the SureStay Hotel, Canada's Best Choice, Sandman Hotel, and Super 8 Hotel. In Nelson, pet-friendly options include the Mountain Hound Inn, Alpine Inn and Suites, Best Western, and the Hume Hotel.

**Liability:** Neither KSH, L2P, nor the United Kennel Club, Inc. is responsible for the theft, loss, accident or injury to any dog, person or property at any of their events. Absolutely no alcoholic beverages or drugs are allowed. Due to space limitations, only dogs entered will be allowed on the show grounds.

#### Awards to be Presented:

Kootenay Scent Hounds will award a qualifying ribbon for each element leg earned, ribbons for placements from 1<sup>st</sup> to 4<sup>th</sup>, and rosettes for Nosework Element titles and Nosework titles completed.

# **Move-Up Policy:**

Participants may move up to the next level provided that the level is offered at this event. A completed Class Change form must accompany the request and the request is to be made while DOS entries are being accepted.

#### **Show Veterinarian (on-call):**

There are limited veterinary services available in this region. Local competitors – please see your regular veterinarian.

Out-ot-town competitors – we will have a list of clinics who MAY be available to take emergencies, depending on their case load on that particular day.

Please note that there are no 24/7 emergency vet clinics in this region – the closest emergency vet services are located in Spokane WA and Kelowna BC.
