Trial Site & Information

The show site is outdoors on grass. The ring is fenced 110'x110'. Crating will be outdoors. Please bring your own crate, clean up supplies, & water for your dog. You may crate or set a tent adjacent to the agility field, or crate out of your car in the designated parking areas. Parking is located adjacent to field 1 & 2. The site will be open Friday night 7:00 and 9:00 pm for tent set up only. A warm up jump will be provided on grass in a fenced area for all exhibitors.

All dogs must be on leash at all times, except when in the ring. Exercise and toilet your dog in designated areas. Please poop and scoop and use garbage containers on the site. Please be courteous to others using the area. Sleeping Giant Dog Sports assumes no liability for loss or damage to items left unattended at the trial site, all belongings are left at your own risk

Trial Site Rules

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. No alcohol on the premises as per the rental agreement of the facility.

Helpers

We can't do it without volunteers! Volunteers help the day run smoothly, your entry in the trial acknowledges that you are willing to volunteer as necessary. Please come prepared to work when you are not running, warming up or cooling down your dog. An online sign-up will be available prior to the trial. Please check in with the Volunteer Coordinator on site to confirm your assignment on the day. Beverages, and snacks are available to all workers, lunch is provided for volunteers. If you are able to volunteer to help or will be accompanied by a non competing volunteer please note their name and contact information on your entry. Questions? Equipment – Plastic pvc jumps, ascending spread jump, long jump, saloon style tire, rubberized contacts, slatted aframe and slatted dog walk.

Bitches in Season -

May run at this trial. To be able to run a BIS, you must immediately tell the trial secretary, who will mark BIS on the running orders. The BIS will remain in their running order. If the dog is not wearing BIS pants, they will start on a mat provided by the show. It is the handler's responsibility to ensure the mat is available for their runs. The handler/owner acknowledges the inherent risk of running a dog on an agility course with BIS pants on and assumes all risk by doing so, and the potential risks with slips from starting from a mat.

They will be posted at the trial site.

Measuring: Measuring will take place each morning between 8:00 and 8:30. All registered dogs are measured free of charge. All newly registered dogs or a dog without a permanent measure, not jumping full height (24", 22", 20" select) must be measured by a UKI judge or approved UKI measurer to determine the dog's jump height. All handlers are solely responsible for the behavior of their dogs including during measuring. If there is doubt as to how a dog will react towards the measurer, the dog will need to wear a muzzle while being measured. Handlers must prevent any aggressive behavior during measuring. A 1st measurement must be obtained and sent to the UKI office by the dog's 3rd trial. A measurement from another organization may be used for this first measure if it is an actual measurement and is not within .25" (6mm) of a jump height cut off. A 2nd measure must be obtained between 12 months and by a maximum of 18 months after the dog's first recorded measurement. If this timeframe is not met, the dog is unable to compete at any UKI event until this is done. If a newly registered dog is aged three years and older, the dog will only need one measurement, and this must be by a UKI measurer. No other organization's measure may be used for this. If a dog is found to have achieved results when it has not complied with the measurement

NFC Reward Box-

Competitors running NFC may use the Reward Box to provide food rewards for their dog. Food rewards will be allowed in the Reward box only for NFC runs (except for Masters Series). The Reward box will have a gate that is closed when not in use and the food must be placed on a table or raised platform. The dog may not leave the area until the food given has been swallowed. If any handler is found to have carried, dropped (or their dog has carried or dropped) food in the ring whether accidentally or deliberately therefore potentially impeding another competitors run, the handler will be unable to use this option for the remainder of the trial with any dog. This also must be reported to UKI. If a handler has multiple offences, they will be barred from using this option at any further UKI trials. A ring steward must be available to close this area off from the ring upon the end of the NFC run. After each run where the food option has been utilized, the steward should also visibly check the immediate area inside the ring to help ensure nothing has been dropped. If anything is found, the steward must also notify the judge before cleaning up the area.

Crating info-

Crating will be outdoors. You may crate or set a tent adjacent to the agility field, or crate out of your car in the designated parking areas. Please bring your own crate, clean up supplies, & water for your dog. A chair and sunshade or similar are recommended.

rules, all results that have been gained while breaking these rules will be void and any progression will be rescinded. Dogs will be measured using official measuring devices while the dog is placed in a standing stacked position on a flat surface such as a table. The measurement is taken from the perpendicular line from the highest point at the top of the dog's withers to the flat surface. At the time of measuring, the measurement will be recorded and sent to the UKI office. If there is controversy over a dog's measurement then the owner/handler may ask for an appointed UKI official to re-measure the dog's height, which will be the determining measurement. An owner/handler may only dispute the measurement once.

About UKI

Speedstakes Titling Program

SS Beginners: For dogs that are not eligible for SS Novice, SS Senior and SS Champion levels in the Speed Stakes Program.

SS Novice: For dogs that have gained a minimum of 12 points in the SS Beginners classes. Or a newly registered dog who is eligible for Beginners, but the owner/handler currently runs a Champ level dog in the International Program.

SS Senior: For dogs that have gained a minimum of 20 points in the SS Novice classes.

SS Champion: For dogs that have gained a minimum of 36 points in the SS Senior classes.

International Titling Program

Beginners: For dogs that are not eligible for Novice, Senior and Champion levels in the International Program.

Novice: For dogs that have gained a minimum of 12 points, where 8 of those points must be obtained in agility classes. Or a newly registered dog who is eligible for Beginners, but the owner/handler currently runs a Champ level dog in the International Program.

Senior: For dogs that have gained a minimum of 20 points in the Novice classes, where 12 of those points must be obtained in agility classes, 4 from jumping, and 4 from games.

Champion: For dogs that have gained a minimum of 36 points in Senior classes, where 12 of those points must be obtained in agility classes, 12 from jumping, & 12 from games.

Measuring Dogs - Please ensure you understand the new criteria regarding dogs being measured. [UKI Rule Book edition 10](#)

If a dog is under 3 and newly registered, a temporary measure or proof of the dog's height must be done by the dog's 3rd trial. A permanent measure must be obtained by a UKI official measurer between 12-18 months after the dog's first/ temporary measure. Any registered dog that only has a temporary measure, must follow the above rule. If a newly registered dog is over 3, they must obtain a measure by an official UKI measurer by their 3rd trial and this measurement will be permanent.

BY ENTERING UKI EVENTS, COMPETITORS AGREE TO the following, and the terms and conditions listed on page 11

UK Agility International Rules and Regulations apply to the whole event and all people and dogs must comply with these at all times. As a competitor it is your responsibility to be aware of the rules and regulations as they stand at the time of the show. This show will run under the current edition UK Agility International rules found on the UKI web page. Each competitor acknowledges through their entry to the UKI event that their participation is a privilege and not a right.

Competitors through submission of entry acknowledge that they are knowledgeable of **UK Agility International rules and regulations** including but not limited to the following rules regarding entry.

Please ensure to read the **move up rules – section 2.0**. At a UKI trial where the dog is competing for more than one day and the dog completes the requirements for a level on a prior day, they must move up the following day.

All dogs and handlers must be registered with UK Agility International to compete. UK Agility International's official rules & regulations are available to view free from the UKI web page. If you or your dog is not already registered, please register online at www.ukagilityinternational.com

All dogs are entered at this show at their owners' risk and whilst every care will be taken the show management and UKI will not accept responsibility for loss, damage or injury however caused to dogs, persons or property while at the UKI event.

Dogs under 18 calendar months of age on the day of the Show are not eligible to compete in UKI Trials, with the exception of dogs over 15 calendar months of age eligible to compete in Nursery Classes & Speedstakes classes.

A dog shall be withdrawn from competition without refund if it is: suffering from any infectious or contagious disease, interfering with the safety of any person or other animal or if it is likely to cause itself damage or its welfare is in danger if it continues competing.

It is expressly understood that competitors alone are responsible for the behavior of their dogs, children and guests. Any competitor whose dogs, children, or guests create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior, will at the discretion of the show management, be asked to remove the offending dogs, children, guests from the event grounds. Any competitor or competitor's dog that is dismissed from the show by the judge and or show manager in accordance with UKI rules and regulations will have no recourse to any refund of fees paid such as entry fees, camping fees, crating fees and any other fees associated with the event.

It is the competitor's responsibility to be available for their class and running order. Handlers working more than one dog in a class **must ensure that the dogs compete in the sequence in which they are drawn**. Failure to do so will result in elimination.

Dogs left in hot cars, or dogs appearing to be in distress, will be dealt with as seen fit by the Show Management.

Should a judge be unable to fulfill the appointment to judge, the show management reserves the right to appoint another judge. Should circumstances so dictate the show manager, in consultation with the Judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them must be reported to UK Agility International. In the event of abandonment of the show through circumstances beyond our control, the SHOW MANAGEMENT may defray such expenses from the entry fee to cover the cost of the show preparation. These accounts will then be made public.

Rules of Conduct:

UKI promotes dog agility pursuant to regulations consistent with international standards as a competitive, spectator sport. All competitors, officials, and event personnel shall conduct themselves in a professional and sportsmanlike manner consistent with the foregoing statement of purpose and seek to uphold, and enhance where possible, the image of the sport and UKI through such conduct and actions including on social media platforms.

By virtue of their entry, competitors acknowledge and agree to comply with all UKI rules and regulations and agree to accept any sanctions that are imposed for failure to comply. The judge has responsibility for determining when it is appropriate to excuse a dog and competitor from the ring. The show officials have responsibility for determining when an infraction should result in a

verbal warning, written warning and/or expulsion of a competitor, dog, or any person from the event by conducting the procedure outlined in the UKI rule book. UKI head officials, through further investigation, may impose sanctions including suspension or expulsion from future events.

The following is a partial list of infractions on which the judge or trial officials will take action: Abuse of a dog on the grounds; actions that may have the appearance of abuse of a dog; willful misconduct or interference with a competitor's right to show; any acts of poor sportsmanship; violation of procedural rules; compulsive, correctional training on the grounds; willful misrepresentation on entry forms; willful misrepresentation of animals; dog aggression; failure to exercise diligence in the control of the behavior of their dog including a dog clearly not under the control of the handler; concerns for the welfare of a dog or who is unfit for competing; intimidation and/or impolite confrontation of judges, event officials, event helpers, or other competitors; creating excessive delays as a failure to respect the authority of event officials.

Social Media Conduct

Cyber bullying of any kind towards UKI, trial management & staff, competitors, judges, helpers or volunteers will not be tolerated. Examples of cyber bullying include but are not limited to, communications that seek to intimidate, manipulate, falsely discredit, put down, try to control, rudely confront, demand, and comments that try to incite further issues. Further, UKI is committed to maintaining an environment that is built on mutual respect and is free from racism, discrimination and harassment. In keeping with this goal, any behavior that is hateful towards race, color, religion, creed, national origin or ancestry, ethnicity, sex, and gender will not be tolerated. Any of these cases may sanction removal from all associated social media pages and even lead to expulsion of UKI events and even further expulsion of organization membership.

Refund and Entry Cancellation Policy

Entries will not be accepted, changed, or altered after the closing date or capping level has been reached except for the purpose of moving to a higher level. A full refund is available for any membership that is not older than 14 days from the date of account creation. A full refund is available before the closing date or capping level is met for any show. There will be no cost if refund money is to be left in your UKI account. If a refund is requested, a 5% administration fee for a credit card refund will be assessed, per transaction. ***After the closing date, a partial entry may be available for extraordinary circumstances, but this lies with the individual show management based on their own policies. Contact the show management for details, NOT UKI.***

Payment of entry fees and Instant Account Top up Fees must be made directly to the UKI member account or directly to the trial before a competitor may compete. PLEASE BE AWARE – at the closing date of entries, If you are paying by check, your account balance under “My Account” will show as \$0.00 USD. A note will confirm that you are paying the trial directly. This enables you to enter and pay for other trials online. If you have a \$0.00 USD zero balance display on your UKI Home page, it does not constitute a cancelled entry. Only you are responsible to cancel your entry online by going back into the show you entered and clicking CANCEL MY ENTIRE ENTRY. UKI will not cancel any entries. If in doubt, you must check your entries from the My Entries link as well as reviewing your account transactions. If you have not cancelled your entry as above before the closing date, you are still responsible to pay the entry fee.

Additional administration charges may be imposed to a member's account due to negligence that result in administration time to correct. Possible infractions, not limited to, are submitting incorrect trial entry information, including incorrect handler and dog number, creating duplicate membership or dog accounts and late payment fees. Charges are based on an hourly rate of \$20 per hour.

Media & Sponsor Rights Release

Through the entry into this event, all competitors grant to UKI and its affiliated companies, representatives, agents and assigns, all rights and permission to use or appropriate his/her and their dog's name, biography, likeness, photograph, voice, performing persona, or other indicia of identity for broadcast, telecast, cablecast, transmission or distribution in any format or media known now or in the future. Further, I hereby release UKI and its affiliates, representatives, agents and assigns from any claim or cause of action for invasion of the rights of privacy, right of publicity, right of personality, or any similar right. Sponsors of UKI events may email entrants with their product and or service information. If a competitor does not wish to receive emails from these sponsors, they must email the show management before the close of the trial entry date to declare this, ensuring they receive a receipt email that this information has been received by the trial management.

Speedstakes:

The object of this class is to negotiate a course made up with only tunnels and regular jumps (excluding the tire, wall, spread jump and long jump), with a minimum of 16 obstacles for Beginners and Novice and a minimum of 17 obstacles for Senior and Champion and a maximum of 20 obstacles for all levels. **The Speedstakes course should be a fast and flowing set up.** All obstacles must be performed in order and direction defined by number. The numbers should be placed on the side of the obstacle to designate the direction the obstacle should be taken. If a number is placed in the middle of an obstacle such as a curved tunnel, the obstacle may be taken in either direction. In order to receive a clear round, also known as a qualifying Score (Q), the dog must run the course under standard course time (SCT) and have not been faulted. **Dogs must be at least 15 calendar months of age to compete in this class.**

Agility:

The object of this class is to negotiate a full course of agility equipment with a minimum of 16 obstacles for Beginners and Novice and a minimum of 17 obstacles for Senior and Champion and a maximum of 20 obstacles for all levels with the exception of Masters Series Agility and other tournament classes, which allow a maximum of 22 obstacles. All obstacles must be performed in order and direction defined by number. The numbers should be placed on the side of the obstacle to designate the direction the obstacle should be taken. If a number is placed in the middle of an obstacle such as a curved tunnel, the obstacle may be taken in either direction. The class must include the dogwalk, A-frame, teeter, and one set of weave poles for a maximum of 12 poles. In some cases, one of the contacts may be omitted and replaced by repeating one of the other 2 contacts still giving a total of three contact obstacles. If this option is used, it will be stated in the show information. In order to receive a clear round, also known as a qualifying Score (Q), the dog must run the course under standard course time (SCT) and have not been faulted.

Jumping:

The object of this class is to negotiate a course, without contact equipment, with a minimum of 16 obstacles for Beginners and Novice and a minimum of 17 obstacles for Senior and Champion and a maximum of 20 obstacles for all levels, with the exception of Masters Series Jumping and other tournament classes, which allow a maximum of 22 obstacles. All obstacles must be performed in order and direction defined by number. The numbers should be placed on the side of the obstacle to designate the direction the obstacle should be taken. If a number is placed in the middle of an obstacle such as a curved tunnel, the obstacle may be taken in either direction. The class can include all equipment with the exception of the 3 contacts. **A set of weave poles (maximum of 12) must be included unless unsatisfactory conditions cause the use of the obstacle to be unsafe.** In order to receive a clear round, also known as a qualifying Score (Q), the dog must run the course under standard course time (SCT) and have not been faulted.

Gamblers:

The goal of the game is to accumulate as many points as possible within the time allotted and then to make a decision and perform **one of the two** short closing sequences 'the gamble'. The Gambler's course is set up with the obstacles placed randomly throughout the ring, without specific flow. Each obstacle is worth points and is awarded to the dog if successfully completed. Points can only be awarded twice for each obstacle. The game consists of two parts. The first is the opening period that has a designated time of 25, 30, 35 or 40 seconds. This is the time to gather as many points as possible by successfully completing obstacles before the period ends. This is then followed by the selected 10 or 15 point gamble which is only awarded if the dog crosses the finish within the total course time, without fault.

Snooker:

The object of the game snooker is to score as many points within the maximum course time set by the judge. The scoring is similar to the game snooker. However, the judge may place the obstacles in the ring in any way. The judge will design a course consisting of 3 or 4 red jumps and one of each of the other snooker colours. Snooker consists of two sections. The opening section allows the dog and handler to collect as many points as possible by completing each red jump followed by any colored obstacle. The second part, the closing, requires the dog and handler to complete the coloured obstacles 2 through 7 in sequential order before course time has elapsed. Once the dog has completed the last obstacle, the handler must direct the dog to the finish line to stop the clock. If a dog does not stop the clock (barring timing failure) then zero points will be scored. A snooker course should be run as follows:

- Red jump, any colored obstacle,
- Red jump (different from first red), any colored obstacle,
- Red jump (different from first and second red), any colored obstacle,
- Yellow 2, green 3, brown 4, blue 5, pink 6, black 7
- Finish line.

About UKI Repeat & Move On (RMO): During a run, a competitor may immediately repeat any obstacle one time at the competitor's discretion.

This is an immediate elimination. In so doing, the competitor may repeat one or a maximum of two relevant preceding obstacle(s) prior to the point of error if it is beneficial to their performance of the obstacle. If the error is a knocked bar, a competitor may reset a maximum of 1 jump bar.

The handler can either continue to work the remainder of the course in normal competitive spirit or immediately head to the exit of the ring.

If a handler attempts to repeat another obstacle or the judge deems that the handler is continuing to train on the remainder of the course, the judge must immediately dismiss the handler and the competitor must go to the exit of the ring. It is strictly understood by competitors that no harsh punitive correction shall be used at any time during their attendance at a UKI event and this is also including RMO. Competitors that use the RMO feature do so entirely at their own risk and cannot under any circumstances hold the judge, trial or UKI responsible for any risk or injury that occurs during a run.

About Not For Competition Runs (NFC):

The aim of Not for Competition (NFC) is to reinforce behaviors in the trial ring environment. It is only for dogs that can compete safely and are fully under the control of the handler. All dogs participating in NFC runs must adhere to the policy stated in section 1.2 of the rule book and must also abide by the policy listed in 4.16. Dogs running NFC are required to follow the dog measuring rules referred to in section 4.5.

A handler may choose to participate in any class they are eligible to compete in as NFC unless stated in the premium's rules. This must be stated in advance to the run and noted on the scoring with NFC. This will allow the handler to use the standard course time to train and practice the course. The handler may use the SCT to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. Shows with high entry numbers may limit NFC course times to no less than 50 seconds. This must be announced/publicized to competitors at least 7 days before the show commences.

If a handler chooses to participate in a class for NFC, he/she may use a toy or other like training device for rewarding their dog's performance. They may also choose to have another person assist them in the ring during their course time. Targets are allowed if they are not placed on any piece of equipment and no additional time is taken to position or remove these. Handlers may not alter equipment in any way by putting something on it, under it or over it, including mats or stride regulators. **No audible training aids such as sound touch pads & clickers or audible toys will be allowed. No food is allowed in the ring.** A dog & handler may not leave the ring boundary for the purpose of rewarding the dog outside the ring in any manner, except for a designated area detailed in 4.12a. Should a handler choose to leave the ring at any time to reward their dog, the run ceases and they may not return into the ring. The judge shall not judge the dog but must continue to watch the handler to ensure safety, good judgment and fair treatment of the dog. If a handler does not state NFC and the judge deems them to be training, they will be eliminated. A dog may NOT run NFC in a Level they are not eligible for. A dog may jump lower than the dog's Select Height but only for NFC. The handler must contact the Show Manager to notify them of this wish before the show. If they opt for this, the dog may not also enter their competition height in those classes. The purpose of this is for dogs who may be recovering from injury or for other reasons are unable to jump their Select option height. Handlers may not ask the judge or any ring party to leave the ring. Handlers may not ask ring party to close off the ring or wait for the next dog to enter the ring before they exit.

NFC Food Reward Area

A food reward area may be available, which is set adjacent to the ring boundary for the purpose of giving food to a dog during an NFC run. The food area must be fully enclosed by fencing with an opening into the ring where the handler and dog enter. The food may only be delivered within this area. This area may not intrude into the ring boundaries, only set adjacent. The opening must have a gate that remains closed during all other runs. Show managers must apply for the NFC food area option through the UKI office for approval. When the show is granted permission, this option will be published in the show's premium. The food area must have a table where the food is placed and the food must be stored in a bag or container. A towel should be available in the area where the handler can quickly wipe their hands of any crumbs before continuing with their run. The dog may not leave the area until the food given has been swallowed. A ring steward must be available to close this area off from the ring upon the end of the NFC run. After each run where the food option has been utilized, the steward should also visibly check the immediate area inside the ring to help ensure nothing has been dropped. If anything is found, the steward must also notify the judge before cleaning up the area. If any handler is found to have carried, dropped (or their dog has carried or dropped) food in the ring whether accidentally or deliberately therefore potentially impeding another competitors run, the handler will be unable to use this option for the remainder of the trial with any dog. This also must be reported to UKI. If a handler has multiple offences, they will be barred from using this option at any further UKI trials. This option is not allowed for Masters Series Heats, Tournament classes, Cups, Classics and Opens.

Collars and Leads

Dogs must not wear any type of slip or half-slip lead, head collar, muzzle, harness or any collar not described below while under judge's orders. **A flat, close fitting leather, nylon or other webbing collar is permitted providing the only attachment is a plain identification panel as a part of the collar but not attached by a ring, therefore no tags that hang or dangle are allowed.** UKI encourages proper identification of each dog in case of escape or any other mishap and if running without a collar, once the run is complete, a collar with identification should be immediately placed on the dog. Stop pad protectors may be worn by a dog including hock protectors. Handlers that run dogs with collars and/or stop pad protectors do so at their own risk. Handlers that run dogs without identification do so at their own risk. These rules also apply to NFC dogs as well. Leashes are allowed to be placed at the end of the course either on the ground after the finish line or in a container or hook designated for leads. Leashes may not be thrown at the finish by any person before the dog has crossed the finish, nor can leads be used to lure or enhance a dog's performance by anyone outside the ring, or that dog will be eliminated. Judges should liaise with their ring party to sort the placement of the leads at the finish line. It is the judge's responsibility to ensure this placement is followed throughout the class by the ring party. Dogs are not allowed to wear electric collars, prong collars and choke collars of any kind on any UKI show site. Lemon Spray Collars or such devices are not permitted within 50 yards of a competition ring. Owners in breach of this collar rule will be asked to leave the showground immediately, whether finished competing or not. **Buckle collars, martingale collars, head collars, harnesses are allowed.**

Running Orders

All running orders will be randomly drawn and competitors are responsible for their own running order. If running multiple dogs, dogs must be run in the order drawn. Tournament running orders where strict running order is necessary due to seeding, will be detailed in the event premium.

Move Ups

Next-day move up rule – Handlers can move up on 2nd day of trial, but must keep track of their points and let the secretary know before leaving the trial site. It's a best practice to take picture of results for your records as only qualifying scores display in your account. Move up to the next level when requirements are achieved for the entire title track and not in individual classes. Automatic move-up for lower levels, handler must email UKI for certificate when Championship is earned.

Prizes & Awards

New Title Rosettes will be awarded for new titles achieved during this trial.

Each qualifying Score shall be awarded a qualifying rosette/ribbon.

A qualifying Score must be gained to be awarded a Ribbon/Rosette and numbers in class to be taken from the show's ring plan.

Placement rosettes/ribbons will be awarded up to the top 4 of each class and shall be provided in the following way:

Minimum Ribbon Structure

Classes of 5 and under – Clear Round Ribbon/Rosettes only

Classes of 6 -10 1st Place Ribbons/Rosettes & Clear Round Ribbon/Rosettes

Classes of 11-20 – 1st and 2nd Place Ribbons/Rosettes & Clear Round Ribbon/Rosettes

Classes of 21 and over – 1st, 2nd, 3rd, & 4th Place Ribbons/Rosettes Clear Round Ribbon/Rosettes

Shows may choose to give further awards and prizes on their own accord

Canadian Masters Series Tournament Rules

The aim of the Masters Series is to encourage more competitive running in UKI classes and improve the overall standard of top level agility. The Masters has been created for dogs and competitors whose goal is to compete at both National and International level.

- The Masters is considered one class made up of 2 rounds: an Agility and Jumping round with results combined.
- Entry open to ALL dogs of all levels.
- Separate competition for each jump height.
- Running order for second round will be in reverse order of the first runs results. If a handler has 2 dogs entered within a jump height, they may move their first dog up so that there are as many dogs as possible between their dogs. If this is not possible, they will receive a 6 minute break. If a handler has more than 2 dogs within a jump height and the entry is not large enough for a large enough gap in between all their dogs, the first of their dogs drawn will be allowed to run in between a jump height change, if a jump height change is available before their height. If it is not, the final decision will be made by the judge and show manager, taking into consideration fairness to the competitor and other entrants in the Masters Class. Day of Entries must run first within the running orders of the first class. The second class must run in reverse order of placing from first class. Handlers must run for competition in both rounds to receive a combined score and be eligible for the Final, awards & prizes. The dog must run in the height that it will compete at in the Canadian Masters Series Final. The same dog and handler must run both rounds. Any extraordinary circumstances to be ruled by UKI.
- Cumulative scoring; dog with the lowest score wins. Faults converted into seconds (5 faults = 5 seconds) and time faults treated the same as course faults but converted on a 1:1 ratio.
- Winners in each height of the Agility round and the Jumping round qualify for the Masters Series Final. Even if an elimination is scored in either round.
- Eliminations will result in 100 faults with a 60-second course time. Therefore, dogs that score 320 cumulative and over will not be placed nor awarded prize money.
- A no-show or NFC in either class will result in a disqualification from the heat and therefore will not be eligible for individual class placement, overall placement or eligibility to qualify for the Final, and will be scored 1000 faults.
- If 1-5 dogs are entered in a jump height 1st & 2nd place from the combined scores of Agility and Jumping rounds qualify for the Canadian Masters Series Final at the Canadian Open. If 6 – 10 dogs are entered in a jump height 1st - 3rd will qualify, above 10; 1st – 4th will qualify.
- Prize money to be paid out to at each heat for the combined winners per the prize fund below.
- **In the event there is not a monetary winner within a height, the prize money will be sent to UKI to be added to the Masters Series Final.**
- Winners (1st place only) Overall of any Canada Masters Series Heat are also eligible to receive a bye into the Masters Series Final at the US Open (Florida). This can only be used at one of the Opens. If going to both events, 2 byes will be necessary. In the event of a tie for the combined results, the result from the Agility round will be the deciding factor.
- If there is still a tie, the dogs will compete in a run-off on the 2nd rounds course. If there is a tie for the Individual class wins, a runoff will be required on that course to determine the winner and subsequent placings.
