# **ENTRIES and PAYMENT**

Listing fee: A listing fee of \$10.50, includes GST, as established by the CKC must accompany the

entry of a dog that has no valid CKC individual registration, an ERN or PEN shown on

the entry form.

Please note the CKC ruling: Canadian Resident non-CKC members running a wholly owned dog cannot win a placement unless they pay a non-member participation fee or a membership fee to the CKC. These fees apply only to dogs wholly owned by non-CKC

members and are not applicable to CKC members.

### **Check-in locations**

There will be two separate check-in locations for handlers, one for MH and one for JH/SH. Details will be forwarded closer to the event.

# **No Catalogues Distributed**

Catalogues and a Running Order will be emailed to handlers prior to the test. They will not be distributed at the test. A Running Order will be posted on site for hands free reference.

#### **GENERAL INFORMATION**

- 1. A **separate entry** form for each dog and each stake each day, must be completed. Only entries on official CKC forms (available from our web site: <a href="www.bclab.com">www.bclab.com</a> bcretrievernew.com or ckc.ca) accompanied by the appropriate payment will be accepted up to the closing date and time.
- 2. Entries must be typed. The B.C.L.R.C. does not assume any responsibility for incorrect information or errors due to illegibility of any entry form. Dog owners and / or their agents are responsible for requesting correction of errors contained in the catalogue.
- 3. The **running order** will be determined by a draw for each day and stake at the home of the Secretary after time of closing. The running order may be changed on the day of the tests as provided by the Hunt Test Rules.
- 4. **Entry fees** will not be refunded after July 29, 2020. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Test Committee or the Canadian Kennel Club, or because it has been entered incorrectly, or if it is impossible to open or complete the test, no refund of entry will be made.
- 5. **Bitches in season** are not eligible for entry and **are not allowed on the test grounds.**
- 6. Full refunds will be given for any dog withdrawn because of estrus, injury, illness or death and unless otherwise agreed by the trial committee must be accompanied by a Veterinarian's certificate. Other refunds (less a scratch fee of \$10.00 per dog) may be given for an extraordinary reason at the discretion of the trial committee. All requests for refund must be in writing and must be received by the trial secretary within 2 days of the last day of the trial.
- 7. Ducks, pheasants or chukars will be used on land, pigeons may be used on Master upland tests. Ducks will be used for all water tests.
- 8. Dogs are permitted to wear Neoprene vests for water marks and blinds.
- 9. All participants and spectators shall wear hunting attire or dark clothing.
- 10. Vehicles must be confined to designated roads only
- 11. Rosettes will be awarded for all qualifying dogs and will be presented immediately at the end of each test.

# **LEGAL MATTERS**

Hunt Test Rules & Regulations of the Canadian Kennel Club state in Section:

2.5.1: "There shall be no training of dogs on the grounds of a hunt test, except for single training bumpers which are thrown by hand by the handler, either within 24 hours of the commencement of the event, or at any time during the event. The Hunt Test Committee is responsible for enforcement of this provision."

20.7: "It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at a hunt test held under these regulations, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue."

#### Release and Indemnification:

By participating in these tests (as handler, spectator or in any other role) each participant agrees to assume all risk and hazards incidental to these tests and agrees to release and to save harmless and indemnify the British Columbia Labrador Retriever Club Society and its members, any volunteer and the owners of the property upon which the tests are held together with their officers, agents, employees and representatives from all claims, actions, cost expenses and demands in respect to death, injury, loss or damage to the person or property of the participant howsoever caused, arising out of or in connection with the participants use or entry upon the property. It is understood that this agreement is binding upon the participants, his or her heirs, executors and assigns.

#### **COVID GUIDELINES: PLEASE READ PRIOR TO ARRIVAL**

- All handlers will be notified to go directly to the site of their stake and avoid all congregating in central areas
- Social distancing practices will be in place. Be mindful when speaking with others
- Parking Please leave more space between your vehicles, within reason.
- Bring your own food and drinks, no lunches or snacks will be provided
- Remove all your garbage from the grounds. There will NOT be garbage bins available
- Bring your own duck call and whistle. These items will NOT be supplied
- You may be required to place the bird in the bucket and/or on the drying rack and/or on the ground. Judges will NOT be required to take the bird from the handler but it will be entirely up to the judge's discretion as to how this is handled at each stake
- Avoid putting items (leashes, jackets etc.) on the holding blinds to avoid cross contamination as well as ensuring that social distancing is maintained
- Bring your own mask and gloves (if you choose to wear them). If handlers choose to wear protective gloves to the
  line, they must dispose of the gloves after leaving the line and put on new gloves with each ensuing series. If
  handlers choose to wear a mask to the line, they cannot touch the mask to move it up or down to use their whistle.
  This is equivalent to touching their face/mouth and they MUST sanitize their hands immediately
- There will sanitizer spray and paper towel outside the washroom please ensure you sanitize surfaces after using the washroom
- Only the handler of the dog should attend the event. This helps to keep attendance numbers low and reduce the risk
- Handlers are expected to leave after their stake is over. Please don't put us in an awkward position.
- A hand hygiene station will be set up at each stake between the last holding blind and the line. The station will include a hand pump bottle of hand sanitizer. Hand hygiene is required to be performed by everyone when:
  - o on their way to the line
  - o after leaving the line
  - routinely throughout the day
- Please bring your own sanitizer for your personal use outside of the stake area. Commonly touched areas will be cleaned and disinfected regularly throughout the day.


# Test dog / gallery guidelines:

- Gallery must maintain social distancing at all times, handlers should only sit in their own personal chair and not use other people's chairs or umbrellas etc.
- Handlers will be expected to observe social distancing to watch test dog and plenty of time will be allowed for people to approach line one at a time to inspect the line in order to avoid crowding

# Bird delivery:

• Marks: handlers will hang their own birds or place directly in a bucket after delivery, it will be the judge's discretion to inspect and ensure sanitization procedures are followed if they have a question on a dog's bird handling

Quartering: handlers will take the birds from the dog and place them on the ground behind them; after the handler has moved on the judge will pick it up and replace it
