## **Trial and General Information:**

1. Exhibitors are responsible to be familiar with CKC Obedience and Rally Obedience Rules.
2. Exhibitors are advised to check Judge's Sheets when posted and to immediately advise of any inaccuracies.
3. When in the staging area, it is recommended that dogs should be leashed and under control. There will be a marked practice area set up in the staging room for one exhibitor at a time. Please be considerate of the next exhibitor should they want to use it.
4. No prong or spike collars permitted on site
5. Provided the dog has completed the requirements for the current level of competition, **Change of Entry** is available if made at least 30 minutes prior to the start of the next trial by completing the required CKC Form.
6. **Day of Entry** is not permitted for these trials.
7. **Trial Precincts:** The building and its surroundings.
8. **NO outdoor shoes** in the trialing area. **NO bare feet or just socks** in the trialing area
9. **Crating** will be available in the room adjacent to the Trialing area. There will be no crating in the trial area.
10. **Smoking or Vaping** is **not** permitted in or around the building.
11. **Parking.** Park only on the side of the venue building and in the parking lot. Parking is NOT permitted past the second side door as it is not owned by Ace It Canine Academy. Parking is NOT permitted on the opposite side of the street from the trialing building
12. Clean up after your dog and don't let them potty on anything manmade. NO exercising dogs on the opposite side of the street from Ace It.

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Obedience and Rally Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
16. If because of riot, civil disturbance, or other acts beyond control of the management, it is impossible to open or to complete the Trials, no refund of entries will be made.
17. **Health Protocols.** The Halifax Kennel Club will be following all Federal, provincial, and local health rules when holding the trials.
