8.6.1 The authorities of any show may decline to accept entries for just cause

4.1.5 No person may approach a judge wither directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.

19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

HONOURABLE JUDGES



JC Boulinguez Quebec

Jean-Christophe Boulinguez has been involved with purebred dogs since childhood when his parents bought their first whippet from Patricia Miller, Woodsmoke Whippets, in 1998. After graduating college in 2008, while still involved with Whippets, Mr. Boulinguez wanted to explore the hound group a bit more and got involved with Ibizan Hounds, a breed that ended up stealing his heart and became a true passion. Before becoming a judge, Mr. Boulinguez has handled all-breeds for about 10 years, specializing in Hounds and Toys, and has bred/co-bred Ibizan Hounds, Norwegian Elkhounds, Whippets and

Wire Haired Pointing Griffons. Dogs he owned and bred have won multiple All-Breed Best in Shows, Specialty Best In Shows, majors awards at Canadian and American National Specialties and Westminster Kennel Club. Mr. Boulinguez has also owned an Italian Greyhound, a Samoyed and a Bulldog. Mr. Boulinguez is currently the youngest CKC licensed judge and has already been judging across Canada and the US. Mr. Boulinguez is also a founding member and current President of the All Hound Club of Quebec and the Wire-Haired Pointing Griffon Club of Canada.



Linda Buckley Australia

Linda Buckley started judging in 1985 while living in Adelaide SA where she was breeding and showing English Cockers and Irish Setters. After moving to Canberra in 1988, she continued her trainee judging and became All Breeds in 2002. Other breeds she and her daughters have been involved with include German Shepherds, English Pointers, Doberman, GSP, Greyhounds, Bearded Collies, Wirehaired Fox Terriers, Whippets, Cavaliers, Jack Russells, Bulldogs and American Cockers. She now shows and breeds the Akitas and has had much success in her new Prefix "Blaqaviar" (previously Darqhorse) and judges several times a year both in Australia and overseas. Linda has judged throughout Australia, Indonesia, New Zealand, Philippines, Sweden, Thailand, United States, South Africa, Malaysia, India, Brazil, Japan, China and Canada.



Adrian Landarte Uruguay

I have been living with dogs pure bred or not, all my life. I started in the world of dog shows at age of 17, when I bought my first Afghan Hound. From that moment I got involved more and more in this hobby as breeder, exhibitor, judge, organizer, and director. I am currently president of the Kennel Club of Uruguay and I was President of the Uruguayan Cimarron and the Irish Setter Clubs. Member of the FCI Show commission, current President of FCI Judges commission. Vice-President of the Americas and Caribbean FCI Section. With Jorge Nallem we founded El Retorno kennel having great success breeding Irish Setters, Beagles, Schnauzers, Dachshunds, Fox Terriers, Whippets, Greyhounds and Cimarron Uruguayo. Achieved

more than 160 All Breed BIS, including FCI A&C section show, Sicalam, WDS Circuit, BISS FTW US National, BIG at WDS and FCI Section Shows, several world CH titles, and several top dog of the year all breed in 4 different countries. I am an all-breed judge and began my career as an Irish Setter judge in 1987. I had the pleasure to judge and meet friends in more than 50 countries of all continents and very glad and honored to judge at this very special event.



Jorge Nallem Uruguay

Jorge Nallem is the owner of "El Retorno" Kennels and the breeder of Wire and Smooth Fox Terriers, Standard Schnauzer, Whippet, Beagle, Boxer, Short hair Dachshunds, Greyhound, Irish Setter and Cimarron Uruguayo. He has achieved more than 200 all-breed Best in Shows with his dogs participating in many countries as well as many World Champion titles. Some of the winnings are: BIS South American's championship, BIS at World Dog Show circuit 1997, Group 1st and 2nd in working group at World Dog Show circuit 1999, BOB at World Dog

Show 2001, BIS at America's FCI show 2001, and BISS at National Fox T. Wire Club of America at Montgomery County 2002, Award of Merit Westminster K.C. 2003, Runner up BIS SICALAM Show 2003, BOB and 2nd in group World dog show 2004. Best in Terrier Group World Dog Show 2005. Number 1 all-breed dog Brazil 2006, Number 4 all-breed dog Brazil 2007, number 2 all-breed dog Argentina 2014. 3 He became a Fox Terrier judge in 1987, and an All-Breed FCI judge in 1996. He is a specialist judge on Dachshunds, Old English Sheepdogs, Boxers, Dobermans, Schnauzers, Fox Terriers, Basset Hounds, Irish Setters, Poodles, Shih-tzu and Afghan Hound. Member of the FCI Standard Commission (1999-2022) Current President. President of the Kennel Club Uruguayo (1996-2000, 2004-2008, 2014-2016) President of the judges committee of the KCU (2000-2004, 2010-2012 2013-2014, 2016-2018, 2019 2020) He has been President of the Cimarron Uruguayo Society, and councilor of the KCU several times since 1989. Trainer of new judges in Uruguay and expounder at the America's and Caribbean Judges Congress in 2003, 2004, 2006, 2009. Expounder on first FCI World Judges Congress on Kiev 2017 and Moscow 2020. FCI Delegate for Americas and Caribbean Show 1999, 2003, 2005 and for the World Dog Show 2005 (Argentina) He has judged in almost all countries of the world.



Yvonne Savard BC

Yvonne's start into the dog world was walking into the show ring as a Junior Handler with a big male Bouvier des Flandres at the 7-day benched Sportsman Show in Toronto Ontario in 1969. The love for bouviers and dog shows remained with her from that day forward. Breeding bouviers under the prefix "BARBU Perm Reg'd", JBB and BARJEN, she has had the excitement of winning BOW at the American National Bouvier Specialty 5 times and being the owner of the Top Dog all Breeds in Canada in 1984. Yvonne has bred and shown multiple Best in Show winners both in Canada and the US. Although her main focus was Bouviers she has owned and shown Irish Setters, Doberman Pinchers, German Shepherds, Pekingese and presently an Affenpinscher. Yvonne handled and trained various breeds in her

career with dogs. Yvonne's professional life has always involved animals in some way from Veterinary Medicine to Animal Welfare. Yvonne served on the ABdFC- Health Committee, is an approved Breed Mentor and is a 25+ year member ABdFC as well as Past President of the Canadian BdFC. She is one of the founding members of the Bouvier des Flandres Club of BC. Currently she is a Territory Manager for a Veterinary Pharmaceutical Company. She is an approved All Breeds Judge. She has had the great honor of judging both the American National Bouvier Specialty, the Canadian National Bouvier Specialty and the New Zealand Bouvier Specialty. She has had the pleasure of adjudicating in Canada, USA, Ireland, New Zealand, Australia and the Philippines. She is a member of the CKC, A Breeder of Merit with the AKC and is a member of each the CDJA, ADSJ and DJA. (Dog Judges Associations).

Eduardo Texiera Brazil



Coming from a family of dog breeders, from an early age he was involved with breeding and presenting dogs at exhibitions. Owner of the Prime Moon kennel, he initially started breeding and showing Wire Fox Terrier and Scottish terrier. Still in the 80s he discovered the Shih Tzu breed and since then he has dedicated himself to this breed to this day, together with the Yorkshire Terrier. He obtained several international titles and Best in Show in Brazil and other countries. For more than 30 years he worked as a professional handler, having experience with dogs of all groups and winner of more than countless BIS with different breeds. He stood out as a handler of the Lhasa Apso breed, having worked with renowned breeders and obtaining numerous significant achievements. Canada, Chile, Uruguay, Argentina, Costa Rica, Lithuania, Bolivia, Colombia

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by disciplinary action and cancellation of awards. A collection fee of \$25.00 will be added to the amount of any returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

Attention foreign exhibitors, please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you sent a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please DO NOT make cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.



CONFORMATION CLASSES

The following Regular CKC Classes (divided by sex) will be offered:

JUNIOR PUPPY CLASS - This class shall be for any dog 6 months of age and under 9 months of age on the day of the show

SENIOR PUPPY CLASS - This class shall be for any dog 9 months of age and under 12 months of age on the day of the show

12 to 18 MONTH CLASS- This class shall be for any dog 12 months but under 18 months of age on the day of the show

CANADIAN BRED CLASS - This class shall be for any dog born in Canada.
(Champions of any country excluded)

BRED BY EXHIBITOR CLASS - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler **MUST** be the owner/co- owner **AND** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

OPEN CLASS - This class shall be for all dogs

SPECIALS ONLY CLASS - This class shall be for any dog that has a recorded CKC Registration or Event Registration Number and has attained the required points for Championship status. Note: A Listed dog may be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE BREED JUDGING ON THE DAY OF THE SHOW ON THE DAY CONCERNED**. TCN Fees **WILL NOT** be refunded.

NON-REGULAR CLASSES

BABY PUPPY CLASS - This class shall be for any dog 4 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group

VETERANS CLASS - This class is for dogs 7 years of age and over on the day of the show. Dogs entered in these classes may be spayed or neutered.

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class **MAY NOT COMPETE** in any Regular class but may enter and compete in Non-Regular classes and/or Parades **ONLY**

Senior Puppy - 9 months and under 12 months
Juvenile Puppy - 12 months and under 18 months

For final judging the first place puppy from each of the classes will be brought together for the final judging of Best in Sweepstakes.

Section 3.4.1 "Junior Handler with the exception of Pee Wees, must apply to CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked."

Ring across from the show ring. 20 x 25 Can be shared but vehicles and x-pens must fit in the allotted space. This area does not have power but you can use your generators.

Van and ex-pens/ez ups can be left overnight for the entire weekend.



GENERAL RULES GOVERNING THESE SHOWS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the Conformation Rule book are available online at www.ckc.ca

1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
2. Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
6. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed. All start times are PACIFIC TIME.
7. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
8. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$115 plus GST (for Canadian residents) (\$230 non-resident), which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the Judging ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas.
11. No entry fee will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, or barred from competition by action of the Show Committee.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points Allocated*	0	1	2	3	4	5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed here under.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five (5) points at a single show. To earn a Canadian Championship, a dog must earn at least ten championship points under at least three different judges; and be individually registered with the Canadian Kennel Club, or have a CKC Event Registration Number (ERN) and have earned at least one 2-point win either at the breed or group level. In order to obtain a Grand Champion title, a dog must obtain a minimum of 20 points which must include a minimum of two wins of at least 2 points and at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points. (d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best in Show/ Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx) (48-06-12)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules", and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold Pacific Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
