Times are based on judging at the approximate rate of 25 dogs per hour for Conformation, 8 dogs per hour for Novice Obedience, and Brace Obedience, 7 dogs per hour for Open Obedience, and 6 dogs per hour for Utility Obedience.

Exhibitors and handlers are solely responsible for having their dogs at ringside when classes are called. It is not the responsibility of the Ring Steward to locate the dogs.
