Introducing Our Judges

SUSAN BELL

In 1974 my husband and I got our first Labrador puppy; little did we know at that time how our life would change.

1980 we had our first Labrador Retriever litter under the prefix "Pinebank Kennel" and in 1984 Pinebank Kennel became Permanent Registered with the CKC. Since then we strive to produce Labradors that can do it all! We had a couple of Irish Water spaniels and I trained a Cavalier King Charles Spaniel in Obedience. I love to work with my dogs and they teach us a lot about ourselves and life.

Training my pups has lead to teaching and now judging. I have enjoyed judging all levels of CKC Obedience, Rally Obedience, Working Certificate Tests, Hunt Tests and Canine Good Neighbour Tests and I have judged the Puppy Stake at the LOC Field Trial and Junior Handling for both Obedience and Conformation as well as Sweep Stakes for the Irish Water Spaniel Association of Canada and Atlantic Labrador Retriever Club. I have been the Canine Good Neighbour Rep for Zone 6 and have been the Obedience Rep for the CKC. A few years ago I was a Director for University of Guelph Pet Trust and held positions on the Board of LOC and Hamilton Dog Obedience Club and Labrador Retriever Club of Canada.

My dogs and I have worked together to achieve Conformation Championships, Grand Master Obedience Trial Champion, Rally Master Obedience, Grand Master Hunter, Working Certificate Excellent Titles, TDX Tracking Titles and Canine Good Neighbour Titles. Five different dogs I have trained have been in the top 10 Obedience Dogs in Canada.

Now that I am retired, my time is spent having fun with my dogs and helping others with their dogs, training my dogs and I love it.

To do performance sports a dog has to be put together properly with good Conformation and kept in good condition and loved!

TIMOTHY CATTERSON

Tim Catterson of New Castle, Indiana, began exhibiting Italian Greyhounds in the mid-1970's. With his partner, Chuck Scott, he has bred and finished many champions in the breed, including the home-red national-specialty winner Ch. Evergreen Buffet Man Integra. He also finished many champions as a professional handler. He was the top breeder of Chihuahua's in 1981 and has bred Pugs as far back as 1964.

Mr. Catterson has been a judge since the late 1980's and is approved for the Toy Group, Non-Sporting, Hounds and most of the Sporting Group, Juniors, and Best in Show. He has judged at many prestigious venues including the AKC/Eukanuba National Championship show. He also has judged in Africa, the "Royal Jubilee Toy Club" and Asia, several shows including the Moscow Kennel Club to his credits. He has judged several Toy Group shows in the United States and several Pug specialties including the National with entries of over 360 dogs.

Mr. Catterson has also served as a Trustee of 'Take the Lead' for 30 years.

Mr. Catterson is the President of the Anderson, Muncie, and past President of the Kokomo Kennel Clubs, and has been show chairman for the Muncie and Anderson shows for 25 years. He has served the Marion kennel Club as AKC delegate and Vice-President. He belongs to the Italian Greyhound and Brussels Griffon AKC parent clubs, and is a founding member of the Central Indiana Pomeranian Club and the Pug Dog Club of Central Indiana. ***Mr. Catterson is also judging the Pomeranian Club of Canada Specialty at this show as well as Supported Entries for Italian Greyhounds, Pugs and Yorkshire Terriers.***

PATRICIA CRUZ

Pat hails from America and Mexico and this year is her 53rd year as an approved judge for AKC and her 45th approved for all-breeds by the Federation Canofila Mexicana, the FCI member there. She has judged in Central and South America, Cuba, Sweden, Canada, Germany, India, Australia and New Zealand, and most recently in Korea and Thailand. In 2007 she judged at the World Dog Show and in **2025** judged the Borzoi and Scottish Deerhound breeds at the **Westminster Kennel Club**.

Pat has been elected to two terms as member of the AKC Board of Directors, and, served as the first female Vice-Chair of the Board. She assisted pro-handlers at shows in the mid-1960's and was an AKC Executive Field rep based in Texas, covering shows in the southwest and wherever needed in the USA.

As a member of the Dog Writers Association of America for nearly 40 years she was inducted into their Hall of Fame, having written on the sport of dogs for four major New York newspapers, and, is currently a member of their Board.

A member of the Afghan Hound Club of America since 1978, the Knickerbocker Bull Terrier club, and Heart of the Plains KC, serving as their Delegate to the AKC, and has held office in several Long island Kennel clubs.

Pat was a labor leader, marketing sales manager for a major market radio station, and is a proud mother, mother-in-law, and grandmother. ***Pat Cruz is also judging the Toy Dog Club of Alberta Specialty, the Bouvier des Flandres Club of Canada NATIONAL Specialty at this show and a Supported Entry for Bulldogs.***

LANA FERGUSON

Lana Ferguson began her judging career in 2016. She is currently licensed for Group 1, 2, 3 and 7.

As Lana writes ...

"My involvement in purebred dogs began in 1979. My first show dog was a Dalmatian, Ch. Aiglons Pixie, CD. In our very first show Pixie went Best Puppy in Group and, as they say, the rest is history. I was hooked. Going forward I spent many years showing Dalmatians in both Conformation and Obedience rings. During those years I occasionally handled Shetland Sheepdogs for my mother who was very involved in Obedience.

In 1999 I purchased her first Doberman Pinscher, BIS Ch. Devonquest Misdemeanor, CD, CGC (Devon). Dobermans have been my passion since Devon entered my life and I have been committed to the breed every since.

I have had the good fortune to produce many Canadian and American Champions as well as multiple Best in Show winning dogs. I am proud to include American top 20 Ranking AM/GCHG/CanGCHEX Legendale Lady Luk vGoldGrove, RN,CGN,Ratl, RatN,SD-S-SP as part of my breeding program.

Over the years I have bred Dalmatians and Dobermans under the Legendale prefix. I am currently active in Conformation, nosework, Obedience, lure coursing and barn hunt.

I am a Life Time member of CKC, and a member of both DPCA and DPCC.

I am a licensed Mortgage Broker and have been for over twenty years now. I am also an avid curler and enjoy golfing when time permits.

This is an exciting time for me as I work towards becoming an All-Breed Judge. I think it is such an honor when I have the opportunity to judge all the beautiful purebred dogs." ***Lana Ferguson is also judging the Alberta Boxer Club Specialty at this show as well as Boosters for Doberman Pinschers, Great Danes and Bouvier des Flandres.***

DEBRA GSCHWENDER

My life in dogs started when I was 16 years old, showing my Rough Collie in Obedience competition. I then went on to show and breed Rough Collies in Conformation.

I bought my first Bouvier des Flandres in 1982 and that became my primary breed. While I have not had many litters over the years I have had dogs that won Best of Breed, Select Dog, and Award of Merit at the Bouvier des Flandres National Specialty, and that are multiple Group Winners.

In 2000 I started my judging career with the Bouvier des Flandres. I currently judge the Herding Group, the Non-Sporting Group, nine Working Breeds, fourteen Sporting Breeds and seven Terrier breeds.

I was delighted to judge at Westminster in 2013, judging several of the Herding breeds.

I currently own an Lagotto Romagnolo, a Bouvier des Flandres, and a German Shorthair Pointer. I discovered Scentwork and love it! Both the Bouvier and the Lagotto are competing in Scent work. I love to garden and enjoy photography. I also have a horse that I used to ride and drive, but is now retired. My husband and I live on approximately 15 acres. **Debra Gschwender is also judging the Bouvier des Flandres Club of Canada Regional Specialty at this show as well as a Booster for Belgium Shepherds and Supported Entries for Rough Collies and Pumis.**

RICHARD GSCHWENDER

Rick Gschwender has been active in the dog show world since 1979, first with Rombo Bouviers and later under Rendezvous Bouviers when he married Debra in 1989. He has produced National Specialty winners and multiple Group winners.

Mr. Gschwender is retired. He was employed with Ford Motor Company for over 39 years.

Mr. Gschwender is approved to judge the Herding Group, the Working Group, the Sporting Group, Non-Sporting Group and Best in Show. He has had the honor of twice judging the Bouvier des Flandres National Specialty, Best of Breed at the Australian Shepherd National Specialty, the bitch classes at the Siberian National Specialty, the Canaan Dog, Komondor and Giant Schnauzer National Specialties. He has had the honor of judging both Herding and Working breeds and the Herding Group in 2006 and Working Group in 2024 at Westminster Kennel Club.

Mr. Gschwender lives in Nampa, Idaho with his wife Debbie, one Bouvier des Flandres, one German Shorthair Pointer, one Lagotto Romagnolo and several Scottish Highland cows. **Mr. Gschwender is also judging a Booster for Bouvier des Flandres at this show.**

LESLEY HILTZ

I started in the sport of Pure Bred dogs in Australia in 1967, with the purchase of a beagle. This dog whilst not a great beagle was a great show dog, and was responsible for involving me in the sport. I went to England on a working holiday in 1970 for 2 years, and during my stay in England I purchased 2 beagles and showed them all over Britain while I lived there. While there I became interested in Corgis, particularly Cardigan corgis, and took one home with me to Australia when I returned.

Main interest was always the Beagles however and over the years I was very successful in the show ring, with my breeding winning All Breed Best in shows, Specialty Best in shows, and many groups. I also provided the foundation stock for many of today's prominent beagle breeders.

I showed and bred a few Cardigan litters and also helped friends by showing many Pembroke Corgis over the years. In 1988 I moved to the USA and married my husband, David (a prominent Beagle breeder/owner/handler). I took 3 Australian beagles with me and we blended those into the American lines that my husband owned. In the early 1990's we added a couple of whippets to our household and found out how much we enjoyed the breed. We showed them but did not breed them at this time.

In 1995 my husband took early retirement and so we moved (with all our dogs) to Australia for 2 years. We took seven beagles and the first 2 American whippets to go to Australia. These 2 whippets changed the face of the breed in Australia (along with subsequent American imports by other people). We showed and bred both whippets and beagles with great success during this period and I also took the opportunity to show my husband many parts of Australia.

In 1997 we returned to the USA, and settled in SW Washington State (we had lived in Michigan before). We continued to breed and show Beagles. Over the years we have consistently produced Group and Specialty winning Beagles. And always have hopes of another star sitting in the whelping box.

I have been involved with Dog Clubs in many positions from Secretary to President and have run many specialty and all breed shows.

My judging career started in Australia where I was approved to judge the Hound group in 1974 and the Toy Hound group in 1979. Since moving to the USA I continued to study and have now been approved the AKC to judge the Hound, Herding, Non Sporting and Toy groups as well as 9 working breeds. I have been privileged to judge Beagle Specialties in Australia, United Kingdom, Sweden, Denmark, Norway, Germany, Mexico, Philippines and the Czech Republic, as well as in the US. I have judged the National Specialties for both Beagles and Basenji in the US along with regional specialties in many other breeds. I have judged Papillion & Newfoundland Specialties in Denmark. I have judged at All breeds shows in Australia, England, Chile, China, Denmark, Italy, New Zealand, Taiwan & Sweden as well as the US & Canada. **Lesley Hiltz is also judging the Beagle Club of Canada (Western Division) Specialty, the Alberta Bouvier des Flandres Specialty and a BOOSTER for Pomeranians at this show.**

VANDA HUBER

Dr. Vandra L. Huber has owned and bred more than 160 American Kennel Club (AKC) champion Scottish Terriers and more than 40 CKC champions. She is the only Scottish Terrier breeder and one of only five terrier breeders to have attained AKC's top breeder award namely Platinum Breeder of Merit. In November, 2024 she was named Terrier Breeder of the Year by the American Kennel Club.

Scottish Terriers owned or bred by Dr. Huber have gone Best in Show at four of the most prestigious dog shows in the world including Westminster Kennel Club, Crufts in England, Benelux World Dog Show and Eurasia World Show. McVan Scottish Terriers have won American breed's National specialty more than 12 times and the Canadian National several times. Three generations of McVan Scottish Terriers have won the breed at Crufts. McVan Scottish Terrier holds the record for the most breed-specific specialty wins in the USA.

McVan® Scottish Terriers is a boutique kennel located in the Pacific Northwest. The focus has always been on quality, not quantity. A believer in breed preservation through gene diversity, Vandra has partnered with breeders around the world. The results have produced No. 1 Scottish Terriers in Australia, Brazil, Chile, Denmark, England, Japan, Russia, People Republic of China, Singapore, and Taiwan. These champions have gone on to produce numerous other breed winners, and sires and dams. In addition to Scottish Terriers, Dr. Huber and her husband have bred/owned Border Terriers, Cairns, Russell Terriers, Parson Russell Terriers, Smooth and Wire Fox Terriers. She also has shown and owned Miniature Poodles, Bearded Collies, and an Affenpincher. She was a finalist for Dog New's Winki Award and McVan Scottish Terriers was featured in the Terrier Issue of Best in Show magazine.

Dr. Huber is active in the Olympic Kennel Club. She is President of the Washington State Scottish Terrier Club and was the founder of the Scottish Terrier Club of America (STCA) Top 20 competition. She is a frequent speaker on Scottish Terrier history, conformation and health and conducts comparative seminars on short legged terriers. She has frequently spoken to groups of judges and exhibitors on the topic of Decision-Making Biases associated with the sport of purebred dogs. She is a frequent contributor to dog magazines.

Internationally, she has judged in Australia, Canada, China, Denmark, Estonia, Finland, Germany, Japan, Mexico, New Zealand, Norway, Russia, South Korea, Sweden, and Thailand. She has judged specialties for Scottish Terrier, American Staffordshire, Cairn, Pomeranian, Poodles, Bearded Collies, Miniature Schnauzers, Soft Coated Wheatens, Chihuahuas.

Dr. Huber is licensed to judge AKC's Terrier, Toy, and Herding groups. She enjoys judging junior showmanship. She also is approved to judge French Bull Dogs, and all variety of poodles. In the non-sporting group, she is approved to French Bull Dogs and all variety of Poodles. She will be putting her application in to judge more non-sporting breeds (e.g., American Eskimos, Boston Terriers, Bull Dogs, Dalmatians, Lhaso Apsos, Low Chins, Tibetan Spaniels, Xoloitzcuintlis) in March 2024.

Dr. Huber is an Emeritus Full Professor of Human Resources and Management, Foster School of Business, University of Washington. She has published 4 books and written nearly 100 refereed articles. She has been a consultant to numerous companies such as Boeing, Microsoft, Utah Transit Authority and has been an expert witness regarding fair employment practices and compensation. ***Dr. Huber is also judging Boosters for Scottish Terriers and Bouvier des Flandres at this show.***

JOYCE LOVE

Rickway / De Niza Kennels. Chihuahuas were the first dogs that I have owned and bred starting in 1962 under the "De Niza" kennel prefix. After much tinkering with several prominent pedigrees I finally got things right and produced dogs for 20 years that went on to finish in the top three in Canada.

I have owned a very nice top ranked Best In Show winning Irish Setter as well.

My husband, Lorne introduced the Labradors to me in 1981 and the rest became Rickway history. We incorporated the two kennels and have bred under that banner for over 30 years.

We imported several good dogs from the Lachienvale Kennel in New South Wales Australia, and Bradking and Lewis in the UK. There has been much sharing between several American kennels as well over the years. The results have been very satisfactory and dogs out of these unions now can be found behind some top winning and producing dogs in both countries. It would be great to be able to take all the credit for these dogs but we in turn had used other kennels in order to develop these particular bloodlines. Credit in a major part is their due... it is just nice to be able to look at some pedigrees and know that we had a small part to play in a much larger picture.

We acquired our first French Bulldog in the early 90's and had the distinct pleasure of breeding and showing them. One of them attained #1 French Bulldog for the year. They have also become a joy to have around as I consider them Labrador Wannabees.

I started judging in 2005, took an almost 2 year hiatus and am now all-breed.

I was a Licensed Practical Nurse since 1966, and have just retired at the end of 2024.

I will now have the time to dedicate myself completely to breeding and judging!

LINDA SCANLON

Linda began in AKC Conformation as a teenager with Australian Terriers. She bred/owned/handled the first triple titled Aussie (Conformation, Obedience, Earth Dog). Saluki's entered her life in 1972 and from a small breeding program there have been multiple Champions in the ring and field, including Specialty winners, dual titlists, tracking and obedience titled dogs. Linda was the first person to earn the AKC UD on a Saluki (2 individuals) and also earned multiple Will Judy/Dog World Awards and all breed Highs in Trial in the US and Canada.

Initially, Linda was approved to judge Salukis and Australian Terriers and currently judges BIS, Hound and Herding Groups in the US, all levels of obedience and rally, lure coursing and junior showmanship. She is the only AKC judge fully approved for this combination of events. She has judged multiple specialties including having been twice selected by her peers to judge Conformation at the National Saluki Specialty. Out of country assignments include Australia, Belgium, Canada, China, England, Germany, Finland, New Zealand and Sweden, with multiple return trips to most of these countries.

Her other passions in life include her 2 adult sons, her husband of over 60 years and international travel. ***Linda Scanlon is also judging the Beagle Club of Canada NATIONAL Specialty and the Alberta Lure Coursing Association Specialty at this show.***

VICKIE UMPLEBY

SHOW RESULTS: The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s).

Obedience/Rally – entry fees will be refunded when a bitch comes into season (CKC Rule 6.5) **after** the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the show Secretary before the starting date and the time of the trial. The club will refund entry, recording and listing fees if the above conditions are met. No refunds will be given for the service fees provided by the dogshow.ca.

A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials for Performance events ONLY. The bitch must be available to be examined by the show superintendent to verify she is in season.

ATTENTION CANADIAN EXHIBITORS – CKC Non-Member Participation Fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

CLASSIFICATION

Please see CKC rule books for specific class descriptions. These rules may be viewed on the CKC website (<https://www.ckc.ca/en/Files/Forms/Shows-Trials/Event-Rules-Regulations/Conformation-Show-Rules-and-Regulations.aspx>). It is the responsibility of the exhibitor to be familiar with the Conformation, Obedience & Rally rules as set out by the Canadian Kennel Club

CONFORMATION

The following CKC conformation classes (divided by sex) will be offered:

Junior Puppy: for dogs 6 mths of age but under 9 mths of age.

Senior Puppy: for dogs 9 mths of age but under 12 mths of age

12-18 Months: for dogs 12 mths of age and under 18 mths of age

Canadian Bred: for dogs born in Canada; champions in any country excluded.

Bred by Exhibitor: for dogs owned and handled in the ring by the breeder.

Open: for all dogs.

Specials Only: dogs which are registered individually in the records of the Canadian Kennel Club and have attained championship status may be entered in the 'Specials Only' class. **Exhibition Only:** for all dogs over 6 mths of age and eligible for registration with the CKC (non-competitive class).

Veterans: offered Saturday and Sunday only. Veterans will be divided Males and Females with a Best of Breed judged for each. The Best of Breed winner will go on to Best Veteran in Group and Best Veteran in Show. Dogs must be 7 years or older on the day of the show.

Baby Puppy (4-6 Mths): offered all four days. For dogs 4 mths of age & under 6 mths of age – dogs will compete in this unofficial class for Best Male/Best Female, Best Baby Puppy in Breed, Group & Show. They do not compete for Winners.

OBEDIENCE

Pre-Novice: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not earned the title PCD (Pre Companion Dog) title in Canada. Only dogs that have NOT earned the CD title may enter Pre-Novice.

Novice A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has not won the title of CD. Only one dog may be entered in this class by any one exhibitor. The handler in this class must be the owner, co-owner or a member of their immediate families.

Novice B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has not won the title of CD. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the 'sit' and 'down' exercise.

Novice C: for any dog of any recognized or listed breed, mixed breed or unrecognized breed has gained a CD or any higher obedience titles. **Novice Intermediate:** for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned a CD or higher obedience title. Dogs may compete in the Novice Intermediate class indefinitely. Scores earned by dogs competing in this class are NOT eligible for High in Trial.

Open: 12.1.1/12.1.2 & 18A...there will be two classes, Open A and Open B – effective January 1st, 2025

OPEN A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD but has not won the title of CDX. The handler of any dog in these classes must be the owner, co-owner or a member of their immediate families. Only one dog may be entered in this class by any one exhibitor and that person must handle the dog in all exercises. Any person who has exhibited a dog that has earned an OTCH title may NOT handle a dog in this class.

Open B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CD and any dog that has earned the CDX or any higher obedience titles may enter either of the Open B classes. A dog may also be entered in the Utility class in the same trial. Dogs in this class may be handled by any person.

Utility A: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has won the title of CDX but not the UD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. Handlers may enter more than one dog in this class. The same person must handle the dog in all exercises.

Utility B: for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of CDX or UD. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class but the same person must handle the dog in all exercises. No dog may be entered in both the Utility A and Utility B classes at any one trial.

RALLY

Rally Novice A: dogs entered in this class may not have earned a CKC Rally Novice title or any CKC Novice Obedience title other than PCD.

Rally Novice B: Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. No dog may be entered in Rally Novice A and Rally Novice B at any one trial.

Rally Intermediate: for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. Dog handled by owner or any other person. A person may enter more than one dog in this class.

Rally Advanced A: for dogs that have earned the RN title but have not won the Rally Advanced title or any CKC Obedience title other than PCD. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class.

Rally Advanced B: for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class.

Rally Excellent A: for dogs that have earned the RA title but have not won the RE title or any CKC Obedience title other than PCD.

Rally Excellent B: for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

The Canadian Kennel Club Genetics and Medical Committee reminds breeders and owners about the risks of infectious diseases and the Baby Puppy class.

The CKC Rules and Regulations for shows, trials and tests, with some exceptions, have explicit rules to minimize the transmission of communicable diseases.

- ☐ A dog may not be entered or exhibited at a show, trial or test if it has any communicable disease. Dogs entered in a show, trial or test must have current immunization status.
- ☐ No dog may be brought onto the grounds or premises of a show, trial or test if it:
 - (a) is known to have distemper, parvovirus, kennel cough or other communicable disease;
 - (b) has recovered from distemper, parvovirus, kennel cough or other communicable disease with the last 30 days;
 - (c) has been housed within 30 days prior to the show, trial or test on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease;

8.1.3 Where it is found that these rules have been contravened, the dog in question shall be removed from the show, trial or test premises/grounds and **the exhibitor will be subject to disciplinary action.**

Extracts From CKC Dog Show Rules

Chapter 8 Entries and End of Show Section

8.2.5 An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

Section 8.3.1 Entries: Every dog entered in a Championship show must be one of the following:

- registered with the CKC,
- have an Event Registration Number (ERN)
- be eligible for registration with the CKC, or
- if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

Section 8.4.1 Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- that if born in Canada, it is eligible for individual registration;
- that if not born in Canada, is eligible for registration in the records of the CKC.
- that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

Section 8.4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

Section 8.5.1 Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

Section 8.5.3 No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

Section 8.5.4 After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

Section 8.6.1 Refusal of Entries: The authorities of any show may:

- decline to accept entries for just cause, and/or
- refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- in the case of non-acceptance, refund the fee with the reason for non-acceptance.

Section 8.8.2 Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

Section 8.9.1 Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

Section 8.9.2 If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

Section 8.9.3 When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

Chapter 4 Judges Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Section 4.1.5 No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

Chapter 14 Disqualifying or Excusing Dogs

Section 14.1.2 (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form.

Section 14.1.4 Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until

the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. A dog disqualified under section 14.1.2 (b) is not eligible for reinstatement.

Section 14.1.5 Any dog that is disqualified under section 14.1.2(a) shall automatically be disqualified from entering in any CKC event in any other discipline until such time as the dog is officially reinstated, if the dog is eligible for reinstatement.

Championship Points and Cancellations

Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs competing*	1	2	3-5	6-9	10-12	13 & more
Points allocated	0	1	2	3	4	5

**Includes the dog awarded Winners.*

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

Section 15.1.3 If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

Section 15.1.4 If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

Section 15.1.5 If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

Section 15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

Section 15.1.7 The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification: Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

Section 15.1.9 A dog may not be credited with more than 5 championship points in a single show:

Section 15.1.10 A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

Section 15.1.11 A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- earn at least 10 championship points under at least 3 judges; and,
- be individually registered in the records of the CKC or have an Event Registration Number.
- have earned at least one 2 point win either at the breed or group level.

15.2 Grand Champion (GCh)

15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

(a) Grand Champion Point System

Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

*Dogs Competing	1	2	3 to 5	6 to 9	10-12	13 & more
Points Allocated	0	1	2	3	4	5

(b) the following schedule shall be employed in determination of points awarded at Group Level for all GCh:

c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

(d) Only the highest points earned at a single show are carried forward.

15.2.4 Grand Champion Bronze (GChB) The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

Win	Points
Best in Show	5
Best of Breed at a National Specialty Show	5
Reserve Best in Show	4
Best of Breed at a Specialty Show (other than National)	3

(a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.

(b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

(c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

15.2.5 Grand Champion Silver (GChS) The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze

(b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.2.6 Grand Champion Gold: (GChG) The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

(a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.

(b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.

15.3 Grand Champion Excellent (GChEx)

15.3.1 The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

15.3.2 To earn the title a dog must have earned the following during their career as a Special:

(a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed)

(b) three (3) Group 1st, or three (3) breed specialty best of breed wins.

(c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

NOTE: 1. Exhibitors are required to complete the Grand Champion Excellent Record Sheet form located on the CKC website and forward to CKC upon completion of requirements above.

2. Grandfathering of the previous version of the Grand Champion Excellent title will be honoured up until July 1, 2022.

RULES GOVERNING THESE SHOWS

The Northern Alberta Canine Association and the specialty clubs reserve the right to remove from the shows or trials any person or dog for any just cause. Any dog excused by the show superintendent or veterinarian, for any reason, shall not compete in any classes or accept any awards for the duration of the shows or trials. No refund of any fees will be made. If because of riot, civil disturbance or any other acts beyond the control of the show committee, it is impossible to open or complete the show, no refunds shall be made.

Entry fees will be refunded when a bitch entered in Rally/Obedience comes into season after the close of entries if a Veterinarian's Certificate (certifying that the bitch was in season within the 10 day period preceding the trial) is delivered to the Show Secretary before the starting date and the time of the trial. The Club will refund entry, recording and listing fees if the above conditions are met. No refunds will be given for the service fees provided by the dogshow.ca. A 50% refund of entry fees only will be made for a bitch in season without a Veterinarian's certificate with written notification presented to the Show Secretary at least ONE HOUR before the start of the Trials. The bitch must be available to be examined by the Show superintendent to verify she is in season.

- 4.1.5 No person may approach a judge either directly or otherwise, orally, in writing or electronically, to favour his entry. Disciplinary action will be taken against any person who violates this rule, or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the action.
- 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- Dogs must be kept on a leash at all times on the show grounds or within the show building.
 - The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
 - **ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW.**
 - All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by order of the health department and subject to a fine.
 - A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.7.1)
 - A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (5.1.6)
 - There is to be NO SMOKING in the large show tent, nor entrances to it, and NO SMOKING is allowed in the show building.
 - Dogs must be on the show grounds 1 hour prior to judging of their breed.
 - All vehicles are left on the show grounds at your own risk. No security is provided.
 - **No abuse of parking personnel, NACA members or volunteers will be tolerated!!**
 - RV's will not be allowed to travel on the show grounds when judging is occurring. Under special circumstances (in case of emergency) the show superintendent will stop the show and parking personnel will assist in the safe removal of vehicle.

ENTRY AGREEMENT

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the "CKC Dog Show Rules" and that I am (we are) familiar with their content. I (we) agree that the Northern Alberta Canine Association has the right to refuse this entry for just cause, which the Club shall deem to be sufficient. In consideration of the acceptance of entries made in these all-breed shows, obedience trials, agility trials or any of the associated Specialties, and of the holding of these shows and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Northern Alberta Canine Association, associated Specialty Clubs, their members, directors, governors, officers, agents, superintendents, or show secretaries, and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance thereto, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club(s) or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in these shows and trials, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
