## **EXHIBITOR INFORMATION**

All dogs must be on a short leash and under control while on trial grounds except while trialing. **FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS**. Electronic collars/devices are not allowed anywhere on the site- this includes electronic bark collars as well as citronella collars. Head halters are also not allowed at BH trials. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. Dogs MUST run "naked", without a collar/harness. Dogs should be brought into the ring with collars/harnesses which can be easily and quickly removed and replaced.

#### **RUNNING ORDER:**

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.
