NOTE: CKC rules re NSF cheques – tendering of an NSF cheque shall be considered NONPAYMENT OF ENTRY FEES and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. There will be a \$40.00 charge on all NSF cheques received. Credit cards or post dated cheques will not be accepted.

OTHER ENTRY INFORMATION:

- 1. No entry will be accepted unless all particulars called for on the entry form are completed in full and accompanied by a signed waiver and entry fees. Telephone entries cannot be accepted.
- 2. Cheques dated after the close of entries will not be accepted. Tendering of an NSF cheques will be considered non-payment of entry and can result in cancellation of awards. All NSF/returned cheques are subject to a \$40 service charge. There will be no refund of overpayments or duplicate entries.
- 3. An exhibitor has the right to withdraw an entry up to the closing date and time published in the premium list. Written or electronic notification MUST be received by the Event Secretary by the official closing date and time. If written notification is not received by that time, the dog will remain entered in the event(s). Entries that are cancelled before the closing date will be refunded.

CANADIAN KENNEL CLUB INFORMATION

NON-MEMBER PARTICIPATION FEE POLICY

Effective January 1, 2011

- a) A non-member participation fee will be charged to a resident of Canada who is a nonmember of the CKC. The fee will be \$59.40, plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

EVENT REGISTRATION NUMBER (ERN)

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog for breeding purposes as defined in the Animal Pedigree Act, but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with a cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you. Cost is \$59.40, plus taxes.

MIXED AND UNRECOGNIZED BREEDS

These events are open to mixed and unrecognized breeds. In order to compete, mixed and unrecognized breed dogs must have a Canine Companion Number (CCN) from the Canadian Kennel Club and must have a CKC-approved microchip. Mixed-breed dogs must be spayed or neutered. Unrecognized breed dogs do not need to be spayed or neutered. A dog eligible for a CCN may not be entered as a listed dog. If a dog is not registered individually in the CKC studbook it may be entered as a listed dog per CKC rules for this designation, as of July 1, 2018; exhibitors must apply to the CKC for "temporary competition number (TCN), before event closing date". TITLES SHALL BE AWARDED ON THE BASIS OF THE FOLLOWING:

Three titles will be awarded for dogs that pass the Chase Ability Program event the required number of times. For purebred dogs, these are suffix titles that will appear on a dog's pedigree with a higher level title superseding a lower level title.

- 1. Chase Ability (CA) Awarded to a dog that passes the Chase Ability event three times under at least two different judges.
- 2. Chase Ability Excellent (CAX) Dog pass the CA event a total of 10 times (CA + 7 additional passes)
- 3. Chase Ability Excellent 2 (CAX2) Dog passes the CA event a total of 20 times. A higher number title will be awarded for every ten (10) passes.

RIBBONS:


Flat ribbons for qualifying run

Rosettes will be awarded for dogs completing the Chase Ability Program title.

MUST BE PRESENT at AWARDS to receive ribbons/prize.

COURSE, ELIGIBILITY & CONDITIONS COURSE

The club reserves the right to alter the course plan as required by weather and/or field conditions on the day of event. Course will be reversed for the second event.



ELIGIBLE BREEDS:

Chase Ability Program participation is open to all purebred and mixed breed dogs at least 12 months of age that are individually registered with the CKC; or have an Event Registration Number (ERN); or have a Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number (CCN) if it's a mixed breed. Dogs with breed disqualifications are eligible to enter. Females in season may not enter. A dog may enter only once per event. Dogs run as singles.

300-YARD COURSE:

This distance is for dogs shorter than 12 inches at the wither's or brachycephalic ("flat-faced") dogs. Dogs will run one loop.

600-YARD COURSE:

This distance is used for all dogs that do not run the 300 yard course. Dogs will run both loops. If there is a question as to which course a dog will run the judge will decide.

CONDITIONS:

All dogs will run individually. Slip leads recommended when starting your dogs. Muzzles may be used at owner's discretion. Dogs not present at roll call shall be scratched with no refunds.

NO EXCEPTIONS:

Lame dogs or bitches in season during roll call will be excused and their entry fees refunded

CAMPING:

Camping on the field is not available as the field condition may be too soft to accommodate.

DIRECTIONS TO TRIAL:

PLEASE BE CAUTIOUS WITH GPS & GOOGLE MAPS. REFER TO THESE DIRECTIONS TO CONFIRM YOU ARE NOT BEING TAKEN THROUGH THE WOODS.

From NB & YONDER:

Take Trans Canada highway 104. PLEASE NOTE TOLL HIGHWAY (\$4 for cars). Take exit 15 for highway 102 at Truro. Take exit 12 at Brookfield. Follow ramp to the right. Proceed straight at lights. Turn right onto Cloverdale Road. In 500m, turn left onto South Branch Road. At stop sign, turn left onto Ridge Road. Trial is on the right, turn in between barn and house.

FROM HALIFAX:

Take highway 102. Take exit 12 at Brookfield. Follow ramp to the right. Proceed straight at lights. Turn right onto Cloverdale Road. In 500m, turn left onto South Branch Road. At stop sign, turn left onto Ridge Road. Trial is on the right, turn in between barn and house.

LUNCH - Will be available for \$10.00

BBQ lunch will be available to purchase both days. Items include (but are subject to change) BBQ ribs, chicken, cold salad, soda, water. Cash only. \$10 per plate

FIELD CONDITIONS:

- Big field, away from paved roads.
- Field is NOT fenced, but most dogs don't even notice.
- No shade on field, bring your own, as well as drinking water.
- PICKING up after your dog is required.
- PARKING: please only park where directed.

ADDITIONAL INFORMATION:

- Port-a-potty on site, NO poop bags to be put in port-a-potty
- Please bring water for your dogs
- Dogs will run once per event
- There will be a \$10.00 fine for any loose dog interfering with a course in progress.
- Flexi Leads and Electronic Collars are not permitted on the field
- Dogs are expected to be aroused and excited in the presence of the lure, but handlers must be able to control their dogs for everyone's safety or they shall be

refunded their entry and not allowed to run. Additionally, the event committee reserves the right to bar known aggressive dogs from the event site

• ECSA appreciates everyone's cooperation in keeping our site clean. Please see event secretary if you require poop bags.

Whether or not you are an ECSA member, please consider volunteering! You can make a difference, even if you can only help out for an hour.

Easy ways to volunteer at a lure coursing field trial, chase ability or sprinter test (and you don't even have to be a club member):

• Field Setup:

Come early (one hour before roll call) and start by carrying equipment Learn as you go how to place pulleys and tie downs, eventually how the field is set up and how the machine works.

• Field Clerk:

Volunteer to help the field clerk for even one or two breeds. Learn how scores are tabulated and recorded – when you are comfortable with this you will be able start helping the field trial Secretary. Benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

• Runner:

Volunteer to run paperwork from the field clerk to the field trial secretary after each breed. Scores can only be posted as quickly as the paperwork is delivered to the field trial secretary.

• Lure Operator:

Hang around and talk to the lure operator between courses. If you're interested, try running the lure around before the trial, at lunch, or after the trial at practice.

• Lunch:

Volunteer to help set up lunch, serve and collect money.

• Practice:

Give the volunteers who have been working all day a break! Take the practice list, call out the names and collect the money.

• Fundraiser:

It's great when people donate things, but even better if you can organize and execute a fundraiser whether it be a 50/50 draw, raffle, silent auction etc – doesn't have to be complicated or too time consuming.
