EXHIBITOR INFORMATION

All dogs must be on a short leash and under control while on trial grounds except while showing. FLEXI LEASHES ARE NOT PERMITTED INSIDE ANY BUILDINGS. There is NO SMOKING in this facility or on the grounds. If you must smoke you will need to do so inside your vehicle and dispose of the butts in the vehicle also (this is a City Ordinance). Please pick up after your dog and dispose of waste in appropriate containers outside the building.



RUNNING ORDER:

Dogs will be run primarily in height order with dogs being handled by the same person being separated into different staged groups. Please check the running order carefully as move-ups and day of entries may not be in height order.



AWARDS: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. Rosettes will be awarded for first through fourth place in each height category Novice through Master. There is a special prize for Junior Handlers please make a note on the entry form if the handler is a Junior.



Please bring weather appropriate gear. These trials will be held indoors but the facility is affected by the outside temperature. Instinct test will be held outdoors, under a tent if weather demands. Be prepared to crate your dogs outdoors <u>or</u> in your car.



Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded.
