The Gate Code for our Trials will be 7677. Please do not try to advance through the open gate behind another vehicle. We are not sure how long the gate will remain open. The responsibility is yours!

Unfortunately, there will not be "Day of Entries" either day as the trials are full.

NOTE - Please use the main front entrance only. Armbands will be available for pick up at the Front Desk. This is the only entrance that will be used during the trial.

- *Rally Obedience Judging is based on: 15 dogs/hour plus a 10 min walk-through time per class.
- *Exhibitors are advised to check Judge's Sheets when posted and to immediately advise of any inaccuracies. It is the exhibitor's responsibility to know the rules pertaining to the trials.
- *The precincts of the trials will Ace It Canine Academy.
- *All exhibitors will be responsible for the clean-up of their dogs anywhere on the trial site and surrounding areas. Please exercise your dogs on the Ace It side of the street ONLY.
- *No prong or spike collars are permitted on site.
- *All dogs are to be properly supervised or crated at all times. There will be crating in the room adjacent to the trialing area.
- *Dogs should be current on vaccinations as appropriate and in proper health and fit to participate.
- *Parking is ONLY permitted on the Ace It side of the street (between the main parking lot and the second garage door) or in the main parking area.
- *Only indoor shoes on the blue matting; footwear must be worn in the trialing area.
- *Water only on the blue matting (no human food please)
- *No smoking on the premises
- *The Venue will be open at 8:00 am on Saturday and Sunday.
