Being a tracklayer gives you a judge's perspective on plotting and judging exhibitors! When it is your turn to enter a test, you take that knowledge with you.

The **STINKY FEET SEMINAR** will give you that same information! Work with Donna Brinkworth, approved CKC Tracking Judge, all levels, on field and urban tracks.

Having stinky feet is very rewarding. You get to see the joy on tracker's faces as they pass to earn a new tracking title! If this sounds like a fun way to spend a day, bring your STINKY FEET to the seminar!



Cost is \$80.00 for CATS members and \$100.00 for non-members for the day. Graph paper & pencils will be supplied for each participant. A copy of the CKC regulations will be on hand to view. **Limited number of dogs will run a specified number of tracks during seminar. CATS members will be given first chance to run a dog during the seminar, however, all participants may run a dog on a track they plotted afterward.

Please read carefully and sign the waiver below:

I agree to respect the tracking fields and property used in the class. On private property, I will pick up after my dog and myself. For the safety and security of other dogs and participants I will keep my dog under control throughout the seminar on a leash or a line unless instructed otherwise while the seminar is in progress.

I understand that I am responsible for following municipal bylaws regarding leash laws and picking up after my dog. I understand that when my dog is not working, I will be required to confine it in my vehicle or in a crate and that it is my responsibility to ensure my dog's comfort and safety I assume full responsibility for my dog's well being and safety during the seminar and while training.

I understand that this seminar does not qualify my dog or me for Search and Rescue, police or other official tracking services.

I will allow positive photos of my dog and me in these classes to be used by Donna Brinkworth publishing, promotion and presentations. I will respect the copyright of any handouts provided.

I understand that I can ask to videotape my own dog and a critique of my track, but will not videotape other dogs without the consent of the handler/owner, nor will I videotape or record the presenter without their consent. I understand that activities in the seminar will include driving, parking and walking along with activities related to training my dog for the sport of tracking.
