All entries must be submitted to the Trial Secretary by email or Canada Post.

Email - Entry forms must be emailed to showsec@sniffalberta.ca Email entries will be confirmed by email within 72 hours. Once confirmation email is sent, exhibitors will have 48 hours to pay trial fees via e-transfer to treasurer@sniffalberta.ca. Do not pay prior to confirmation of acceptance. If entry fees not are not received within 48 hours of confirmation, the entry is void, and the place will be offered to the next exhibitor in line.

Canada Post – Entries can be mailed to Sarah-Jane Petti (Trial Secretary) – 27 Brightonstone Common SE with fees paid by cheque **payable to Sniff Alberta**. Entries received by mail with a cheque enclosed will receive confirmation of acceptance by email if an email address was provided, or by regular mail if no email address was provided.

Venue:

Langdon Field House is a community association building, located 25 minutes east Calgary. Parking for exhibitors and competition areas will be clearly marked. Indoor Benching will be available. Matting must be used on the indoor flooring under crates. NO EX-PENS ALLOWED.

If your dog needs to be benched at your vehicle, please contact Shelley at shelley.harris@fluor.com so that appropriate plans may be made as this is limited. The competition will be outdoors, so please be prepared for all types of weather.

Volunteers:

Sniff Alberta asks that exhibitors be willing to volunteer to help with the many positions that will need to be filled in order to make this trial fun and successful for all. More information about volunteer positions will be posted on the Sniff Alberta website and Facebook page closer to the Trial date.

Members who have volunteered for a substantial portion of at least one day of Sniff Alberta's previous trial (held in March 2019) and volunteer a substantial portion of at least one day of this trial (held in June 2019) may be eligible for a secured entry for the trial. Secured entries will only be held for one day after the opening date, and entries will be void if payment is not received within 48 hours of notification of confirmation of entry.

For this trial, vehicles are required for searches. Vehicles that are used for competition should not have had odor placed on or in them the week prior to the trial. If you are willing to allow your vehicle to be used for searches, please contact Shelley at shelley.harris@fluor.com.

Exhibitors are requested to keep their area clean, dispose of all dog waste appropriately and leave the event site in the condition they found it.

Move Up forms will be available at the Event Secretary's table. All other corrections to entries must be made in writing to the Event Secretary no later than **1** hour prior to the start of the Trial.

Limits, Wait Lists and Refunds:

These events are **limited.** Once a Trial is full, a wait list will be created for each Trial depending on requests. When the Trial is full a notice to that effect will be placed on both the Sniff Alberta website and Facebook page. Individuals who submit entries after the Trial is full will be asked if they wish to be placed on a wait list. Day of Trial entries will not be accepted.





Entries withdrawn in writing before the deadline of May 17, 2019 at 8:00 pm MDT will be refunded in full. Entries withdrawn after that date will only be refunded if the Trial reaches its maximum entry limit and the entry is filled by a dog from the waiting list. No substitution of dogs will be allowed. Refunds will be provided to an exhibitor should a bitch come in season after May 17, 2019 with veterinary documentation.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee. If, because of weather, riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or complete the show, no refund of entry fees will be made. If, in the opinion of the Event Committee, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions such as, but not limited to, snow storms, hurricanes, tornado, lightning or extreme heat, the host club may cancel or stop the trial before completion, without refund.

General Information:

Pre-Trials: All dogs must earn the Pre-trial (PT) before being allowed to compete at that level in an Individual Element class. Only one pass is required for each Pre-Trial level. Dogs that have passed their Odor Recognition Test (ORT) from the National Association of Canine Scent Work (NACSW) are not required to earn a PT for the odor(s) they have passed in NACSW. Proof of Odor Recognition Tests from the NACSW **must be included** with the entry form when entering any trial if the dog has not earned a PT or any other UKC title for odors that will be used in the trial. Dogs may enter multiple Pre-trial levels in one event.





Dogs must be on leash and under control at all times. No dog-dog interactions for the entirety of the event. Please maintain a minimum space of 15 ft. between dogs at all times. Reactive dogs are welcome. We want to provide a positive environment for all participants, and we need your help to play safe! Per UKC rules, aggression will not be tolerated.

Flat collars or harnesses for searches only. Elimination of team will occur if the dog relieves him/herself during the search.

Entering a UKC Nosework Event: Entries to all events for licensed classes must be submitted using the most current official UKC entry form. Entry forms must be complete when submitted to the Event Secretary, including a valid UKC Permanent Registration number, UKC Performance Listing (PL)/Limited Privilege (LP) number or UKC Temporary Listing (TL) number. Incomplete or unsigned entry forms are invalid and will be refused. It is recommended exhibitors begin the process of obtaining a UKC registration number early. Registration numbers can be obtained through the UKC website: www.ukcdogs.com.

**Please note Sniff Alberta will not be issuing Temporary Listing (TL) numbers at this trial.

Armbands will be provided to exhibitors upon morning of check-in.

Notice to Exhibitors

- 1. All events are held under the rules and regulations of the United Kennel Club Inc. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport. The current Nosework rulebook is available on the UKC website: http://res.ukcdogs.com/pdf/ukc-nosework-rulebook.pdf. A printed copy of the rulebook will be available at the Trial Secretary's table.
- 2. Absolutely no alcoholic beverages, marijuana, or illegal drugs will be allowed on the grounds or in the buildings on the day of a UKC Licensed event.
- 3. It is expressly understood that exhibitors alone are responsible for the behaviour of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior (including excessive barking) may, at the discretion of the Event Committee, be asked to leave the benching area. If the behavior outside the benching area continues to negatively impact the other exhibitors, the offending exhibitor may, at the discretion of the Event Committee, be asked to leave the trial venue/grounds. In that case, no refund of any fees paid will be made.
- 4. UKC, Sniff Alberta, Langdon Field House, their agents and their employees assume no responsibility for any loss, damage, or injuries sustained by spectators or exhibitors, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC, Sniff Alberta and Langdon Field House are not responsible for loss, accidents or theft.
- 5. The "No Smoking" rule will be strictly enforced in all buildings and areas so designated.
- 6. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event





Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the trial venue/grounds.

- 7. UKC will vigorously support any motel that files a complaint about exhibitors who fail to keep their dogs quiet or to clean up after them. In order that the bad conduct of a few exhibitors does not spoil it for the majority of responsible exhibitors, UKC will take strong disciplinary action against any offenders.
- 8. No dogs may be left in an unlatched or unzipped crate.
- 9. Except when being judged or when crated, dogs must be kept on leash.
