EARLY BIRD ENTRY SPECIAL

The Moncton Kennel Club is offering Early Bird Entry. This means that to take advantage of this offer, your entry must be in the hands of the Trial Secretary (with payment), no later than 10pm Wednesday March 25th, 2020. Entries arriving later will be required to pay the Regular Entry Fee.

* LISTING FEES are payable with the entry for dogs that do not have their individual CKC Registration Number or CKC Event Number (ERN). Official CKC Entry Forms MUST be used.

No post-dated cheques will be accepted. A post-dated cheque is one that is dated after the receipt of the entry. ALL NSF cheques will be subject to a charge of \$25. NSF cheques are considered non-payment of entry fee and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the Agility Trials.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation are appreciated. Thank You.

NON-MEMBER PARTICIPATION FEE

A non-member participation fee will be charged to a resident of Canada who is a "non-member" of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. For the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

REFUND INFORMATION

When a bitch comes into season after entry has been submitted to the Trial Secretary, a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial.

No dog may be brought onto the grounds or premises of a trial if it has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days.

If a dog is injured after entry has been submitted to the Trial Secretary, a Veterinarian's certificate, certifying the dog was injured before a 3 day period preceding the trial, must reach the Trial Secretary on or before the start of the trial.

ELIGIBILITY

Every dog entered in an approved agility trial or sanctioned agility match must be one of the following: (a) registered with the CKC; (b) have a Canine Companion Number; (c) have an Event Registration Number; (d) have a Performance Event Number; (e) eligible for registration with the CKC or; (f) have a Miscellaneous Certification Number (MCN) if it belongs to a CKC listed breed; (g) have a Temporary Competition Number (TCN).

To be eligible to compete at approved agility trials or sanctioned agility matches a dog must meet the requirements as outlined in these rules, and: (a) must be at least 18 months of age to participate in approved trials, 12 months of age for sanctioned matches; (b) may be spayed, neutered, or debarked; (c) may not be lame (it is the judge's responsibility to determine whether a dog is lame); (d) may not compete if it has tape or bandages (such a dog must be immediately excused and under no circumstances may it be returned later for judging after the tape or bandages have been removed).

MOVING UP

A dog that has received 3 qualifying scores from at least 2 different judges, may be transferred to the next level provided that a written or electronic request is received prior to the commencement of each trial. Please see the Trial Secretary immediately following the completion of the trial in question for the “move-up form”.

TRIAL RULES AND REGULATIONS

Exhibitors are expected to know the CKC Agility Rules and Regulations. TRIAL SITE RULES AND FOOD

1. Exhibitors are responsible for cleaning up after their dog(s).
2. McDonald’s, Subway, Tim Horton’s, A&W, iHop are all less than 5 minutes away and can provide you with a hot meal if you like. Feel free to bring your own food and beverages to have as you please throughout the day!
3. As usual, small snack items will be available throughout the day in case you get the munchies! We’ll have a basket of goodies that you can easily access in the secretary’s quarters or at the entrance of the building.
4. Masks are always required while you’re in the arena. The only exception to this is when you’re actually running your dog. In other words, please keep your mask on until you’re inside the agility ring.
5. Crating is available outside in beautiful horse stalls adjacent to the facility. They are covered by a roof and separated by wooden walls. There are approximately 10-12 stalls available, but feel free to share with those you feel are “in your pandemic bubble” 🐾 or simply crate in your vehicle.
6. Bathrooms will be available, but we ask that everyone sanitize the toilet seat and sink after each use. There will be sanitizing wipes at your disposal.

7. The building will be clearly marked with regards to ENTRIES (to the registration area and the ring) as well as EXITS (from the registration area and ring). Please follow all signs and arrows as indicated so that we can always maintain social distancing (please see attached document for more specific details).

GENERAL INFORMATION

To make the event a success, volunteering is a must. Please indicate your preferred job on the entry form and we will do our best to accommodate your request. Thanks in advance!

1. Dogs should be ready to run when called. We would like to keep the Agility Trial running smoothly. Please advise the Trial Secretary if your dog is unable to run.
2. Exhibitors must abide by any errors made when entering their dog(s), regardless of how or who made the error(s). PLEASE PRINT OR TYPE YOUR ENTRY CLEARLY AND PLEASE CHECK IT BEFORE EMAILING.
3. The committee reserves the right to refuse any entry, subject to CKC rules.
4. The Trial Superintendent will be in full charge of these events, which are governed by CKC rules.
5. Any dog not entered in the Agility Trials will NOT be allowed within the precincts of the event.
6. The trial committee will use care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident or other misfortune to dogs, volunteer, or patrons. The Moncton Kennel Club will NOT be responsible for any equipment left behind.
7. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

Moncton Kennel Club COVID-19 Guidelines for

CKC / MKC Agility Trials

Safety at CKC / MKC Agility trials depends on everyone following the guidelines.

Competitors must not attend trials if:

- They are experiencing COVID-19 symptoms or you are not feeling well – link to the list of symptoms provided by NB provincial health authority – <https://www2.gnb.ca/content/gnb/en/corporate/promo/covid-19/about-covid-19.html#Symptoms>
- They have come into contact with anyone that is suspected of having COVID-19, or anyone who has travelled outside the country, within the last 14 days.

Moncton Kennel Club will have all competitors complete and sign a MKC COVID-19 Waiver Agility Trials 2020 at the time of entry. At registration, competitors and all attendees must fill out a contact tracing form, confirming that they do not have any COVID-19 symptoms, and provide their contact tracing information.

Competitors are to advise the Trial Secretary if they become ill with Covid 19, within 14 days after the trials.

Accepted Entries:

Entries to be accepted must meet all Atlantic Bubble provincial border travel guidelines.

The MKC Agility Trials are NOT OPEN TO THE PUBLIC, Only Competitors and volunteers are permitted at the venue. (See the Entry Form).

General COVID-19 Measures:

Provincial and Federal Government instructions on handwashing, hand sanitizing, how to don a face mask, self-isolation and self-monitoring, will be posted.

1. Masks are to be worn when physical distancing is not possible and competitors, judges, committee members and volunteers are required to bring their own masks.
2. Crating space is either in your vehicle or tent but cannot be shared with non personal bubble/cohort competitors.
3. Washroom facilities will have hand sanitizing and hand washing. Hand sanitizing stations will be available along with expected cleaning protocols. MKC will provide hand sanitizing stations in common areas and near ring entrance and exits.
4. All competitors must wear masks in order to hear briefings as social distancing is not possible. The early morning COVID briefing each day at 8:30 AM must be attended by all competitors. Course copies will be issued by the Trial Secretary / Score Keeper at check in / registration. Where necessary, walk through will be split. Competitors MUST wear a mask during all walk throughs.
5. Running orders will be posted in convenient, easy to view locations. The gate keeper MUST wear a mask and use hand sanitizer before and after their assignment.
6. To limit leash runner contact with multiple leashes throughout the trial, a pickup or grab stick will be used to place competitors' leashes at the ring exit.
7. Ring crew – each member will be assigned obstacles, of which they are the only crew member that is permitted to touch this obstacle during a class. Hand sanitizing before and after touching a piece of equipment is mandatory. During course changes, helpers MUST wear a face mask and will be assigned specific roles. Full time volunteers, non-competing, will be utilized when possible.
8. Warm up jumps – multiple jumps set at numerous different heights will be made available.
9. The entry and exit to the ring remain the same throughout the trials.
10. Measuring Dogs – competitors are required to enter their dogs in the correct height division for the trial. Measurements will only be completed if a judge, or competitor challenges the height division of a competing dog. If measurements are required, then both competitor and the judge, must wear a mask.

11. Competitors do not have to wear a face mask while running.
12. Judge is NOT required to wear a mask while judging. At any time, where the judge must speak to a competitor, scribe or gate keeper, a mask must be worn, if they cannot safely meet the social distance requirement of 6 feet.
13. Scribe\Timer – must always wear masks, protocols for table and equipment sanitizing before and after class jobs must be adhered to.
14. Ribbons and Prizes – Ribbons and prizes will be distributed at the Ribbon Ceremony at the end of each day by one person.
15. A lunch break will be scheduled. Food services are not available on site; however, a short distance away are A & W, McDonald's, Subway and Tim Horton's.
16. Trial results will be posted near the running orders sites, so please wear a mask when in that area and avoid congregating around the result sheets if possible.
