# UKC AGILITY SEMINAR

**When:** Saturday, Feb 21<sup>st</sup>, 10 am – 5 pm

**Where:** Oxford Dog Sports Training Hall, 491 Hwy 2, Princeton

**Cost:** \$50.00 per handler with one or two dogs.

**Limited to 15 Handlers**

**Overview:** This seminar will be taught by Laurie Soutar, and is designed for handlers and dogs that already have some agility experience, but would like to try the United Kennel Club agility trials. UKC has a number of unique obstacles, and this seminar will give handlers and dogs a chance to work on the new obstacles, both individually, and as part of a course.

## Schedule

**10 am** Lecture: Introduction to the UKC agility program – general philosophies, scoring, and title requirements.

**11 am** Introduction to obstacles – Instruction will cover the correct performance of each obstacle, and participants will have the opportunity to work their dogs on all of the obstacles individually.

**12** Lunch (included)

**1 pm** Fun Match – Judge Pennie Jackson - Participants will have the opportunity to run full competition courses (scored), in both AG1 and AG2 levels, and will be allowed additional runs (not scored) as desired, and as time permits. Entries for the fun match will also be accepted by those not participating in the seminar, at a cost of \$10 per run. Prizes will be awarded.

Please Bring: Chair, indoor shoes, and place crates on the rubber matting, or provide your own tarps or rugs to place under crates or expens. Some extra chairs and crates will be available.
