## GENERAL INFORMATION AND TEST RULES

**ELIGIBILITY:** Purebred or mixed-breed dogs must be at least 12 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Are eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

**ENTRY LIMIT:** Entries will be limited to 60 runs per test.

**Post (day of) test entries will NOT be accepted at this test.** If the tests fill, waiting lists will be kept and dogs from the waiting list may be entered and added.

### ENTRY FEES:

<b>Entry Fees must be received before 6:00 PM, July 11, 2022</b>	
Entries will not be changed and no refunds issued after this time except as specified in the <b>"INSPECTION"</b> section below and according to the Covid protocols.	
Entry fee per test (1 run per test)	\$20
Listing/Temporary Competition fee (in addition to the entry fee)	\$10.50

**NON-MEMBER PARTICIPATION FEE:** The CKC has a tracking fee for non-members. Please refer to the information about this policy on the CKC website:

**INSPECTION:** All dogs will be inspected for fitness prior to being allowed to run. Bitches will be checked to determine if they are in season. Entries deemed unfit or bitches in season will be issued a refund.

**TEST SITE:** Bring water, shade and shelter for you and your dogs. These tests will be run **rain or shine**. All dogs must be under control, on a leash except when running the test. **Flexi leads will not be allowed on the test site.** Clean up after yourself and your dog. A bathroom is available. Food is not available on site.

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. **CKC Regulation:** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is

not subject to indignities of any kind. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

The test will follow a Sprint & Go format. Dogs will run once during each test. Two tests will run concurrently in each flight i.e. all dogs in a flight will run once, in order, for Test 1. They will run again in the same flight in order for Test 2. Handlers will then leave to make room for the next flight.

Handlers will be given an opportunity to indicate a flight preference before the running order is distributed. More instructions regarding logistics will go out to all handlers before the event.

**AWARDS & PRIZES**

Qualifiers will receive flat ribbons.

A rosette will be awarded for new titles.
