### **EXHIBITOR INFO:**

Individuals are required to attend the workshop to register in the fun matches, as per BHA standards. BHA registration numbers will not be required.

No flexi-leashes, pinch, or choke collars will be allowed on site. All dogs must be on a short leash and be under control while on trial grounds. Please ensure crates are well secured, as this is a highly excitable environment.

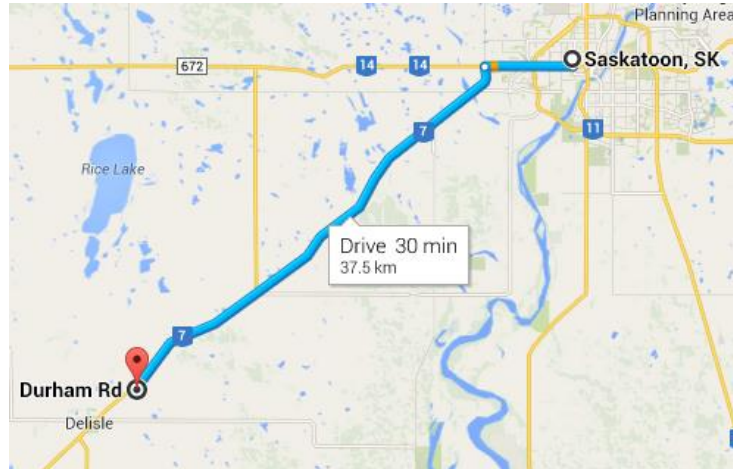
Dogs will be run in height order, with dogs being handled by the same person separated into different staging groups.

Bitches in season are eligible for entry, but must be kept separate from all other dogs, and will be run at the end of the workshop/fun matches.

There will be simple lunch options available for purchase on site. Given the distance from a major centre, guests are also encouraged to bring food with them.

### **LOCATION:**

Workshop and fun matches are located ~30 minutes southwest of Saskatoon, off of highway #7. Follow highway #7, 10kms past Vanscoy. Turn left on Durham Road. Barn hunt location is the first developed farm yard on the left.



**Please note:** the facility is affected by weather conditions, so please bring appropriate gear. This is a farm yard location.

### **ACCOMMODATIONS:**

There is limited camping available on site (primitive – no hookups, dumping, or facility access). If camping, please plan to be self-sufficient. As well, HCKOC reserves the right to remove campers who act discourteously to other campers, the property, or property owner.

There are a number of pet-friendly hotels in Saskatoon, which is a short drive to the site.

### **DOG AGGRESSION:**

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the workshop/matches if justification is found to do so by the judge and/or trial committee.

### **ANIMAL SAFETY:**

The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and are physically able to perform all course elements safely.

### **REFUNDS:**

Refunds offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

### **WHAT TO BRING:**

- Your chair!
- Pen and paper
- Adequate water for you and your dogs
- Weather appropriate gear (ie. Jackets, sunscreen, shade screens for crates)
- Cash for lunch, or a bag lunch
- Plenty of treats!

## **CERTIFICATION OF AGREEMENT UPON REGISTRATION OR ENTRY OF DOG**

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the Barn Hunt Association, LLC in effect at the time of this event, and by any additional rules and regulations appearing in the premium list for this event, and further agree to be bound by the liability waiver enclosed with my entry. I (we) certify and represent that the dog entered is not a hazard (dog or human aggressive) to persons or other dogs. This entry is submitted for acceptance on the foregoing representation and Agreement. I (we) agree to conduct myself (ourselves) in accordance with all Barn Hunt Association, LLC Rules and Regulations and to abide by any decisions made in accord with them.

### **LIABILITY WAIVER**

I (we) agree that the club holding this event, Hub City Kennel and Obedience Club, has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to win prizes, ribbons, and/or trophies, I (we) agree to hold Barn Hunt Association, LLC, the event-giving club, Hub City Kennel and Obedience Club, their members, directors, governors, officers, agents, or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any BHA LLC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
