ENTRIES

Entries close midnight Tuesday, September 8, 2020. Electronic entries only due to COVID-19. Dogs must be 6 months or older. The VSO reserves the right to limit entries. No entry will be accepted from any person not in good standing with the CKC. If your dog has twice qualified with any of our Judges, notify the Test Secretary <u>before</u> the drawing takes place. Entrants are responsible for confirming receipt of their entries.

LATE ENTRIES

<u>FDJ and FD classes only</u>. Use late Entry Form or Online Form. If accepted, they constitute a legal commitment to pay and cannot be withdrawn or refunded. Late entries must reach the Test Secretary no later than 6 PM the day before each test day. PayPal or E-transfer payments only.

DOGS NOT YET REGISTERED WITH THE CKC

Dogs not yet registered with the CKC **must** obtain a **Temporary Registration Number** (TCN) **before** the closing date of entries. Visit www.ckc.ca for information on how to obtain a TCN. There is no charge to obtain a TCN but you must pay a fee of \$11.30 / test which goes to the CKC.

ACKNOWLEDGEMENT, RELEASE, INDEMITY AND WAIVER

All entrants and any authorized individual accompanying the handler to the grounds must read, sign, and submit the VSO's waiver and release on page 6 in this premium before arriving on site to run a dog.

COVID-19

The VSO is implementing safety measures (see page 4) to comply with provincial and local regulations to safeguard as best as possible against COVID-19. Anyone entering these tests or is accompanying a handler must sign the VSO's COVID-19 Waiver and comply with safety measures.

CANCELLATIONS & REFUNDS

Cancellations with full refund must be in writing to field@vsovizsla.org and received before official closing. No refunds after closing or for bitches that come into season after closing. If the VSO cancels the events due to COVID-19, full refunds will be issued. If no bye dog is available for braced classes (FDA, FDX, FDXCh), entries will be refunded.

SUBMIT ENTRY FORMS

NON-PAYMENT OR DISHONOURED PAYMENT

Payment must be made in full and accompany the entry form. The VSO reserves the right to refuse entries from persons who have failed to pay entry fees in full at prior tests. Tendering of a dishonored cheque or declined credit card shall be considered non-payment of entry fees and is an offense punishable by disciplinary action and cancellation of awards. Postdated cheques are not acceptable tender.

MORE INFORMATION

Start times: Saturday: 7:00 AM; Sunday: 7:30 AM.

Running Order: FDX/CH. FDA, FD, and FDJ. FDA or FD dogs may be slotted in between braced classes (FDX) to allow handlers with multiple dogs to rest and to provide breaks for judges.

Course and Game: Single course with bird field. FDA, FDX, FDXCh dogs will run in braces or individually where applicable with a bye dog for backing.

Birds: Chukars will be used in all categories.

Gunning: Official gunners only. All handlers must carry a starter pistol.

Safety Gear: All entrants, judges, gunners, volunteers and spectators who enter or are physically present on the test course, must wear blaze orange clothing <u>and</u> blaze orange head gear in any test where shotguns are used. (Clause 16.2 of CKC *Field Dog and Water Test Rules and Regulations for Pointing Dogs.*)

Indemnity & Waiver: All participants are required to sign the attached VSO waiver on page 6 either in advance of or at the test. No spectators due to COVID-19.

Immunization: All dogs must have current immunization before being entered.

Other: If a dog is not present at its starting point within 5 minutes after it is called for by the Marshal, it may be disqualified. No training or running of dogs on the grounds before and during the tests. Tick spray or meds should be used on dogs and humans.

Bitches in season: are permitted ONLY in FDJ Test# 2 and Test #3 and will be run at the end of the day.

Meals and Refreshments: Due to COVID-19, there will be NO morning coffee or lunch. Entrants must bring their own water, refreshments, snacks, and lunch.

DRAWING & RUNNING ORDER

Draw: Running order draw will take place at the home of Test Secretary in Puslinch, Ontario at 8 PM on Wednesday September 9th. Specific times cannot be guaranteed. **Running Order**: A running order will be e-mailed to all entrants who provide an e-mail address.

MOVE-UPS

Move-ups forms for Test 2 (Saturday) must be submitted in writing to the Test Secretary one hour before Test 2 starts. Move ups for Test 3 (Sept. 13) must be submitted before the Secretary leaves the grounds on Saturday, September 12. Move-up to a braced class is only permitted if another brace mate or bye dog is available.

GOOD SPORTSMANSHIP

All who attend our tests, in any capacity, are expected to display conduct in a manner that reflects credit to themselves, their dogs, and the sport of purebred dogs, regardless of circumstance and location. Under Section 7 of the CKC Field Dog and Water Test Rules and Regulations for Pointing Dogs, the Test Committee as well as Judges have the authority to expel any individual who, in their assessment, displays unsportsmanlike behaviour.

PRIZES AND AWARDS

- New Title Rosette to each dog completing the requirements for a title. These will <u>not</u> be mailed so please notify the Test Secretary at the time of the announcement of scores.

COVID-19 SAFETY MEASURES – VSO FIELD TESTS

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID19 is extremely contagious and is believed to spread mainly from person-to-person via respiratory contact. Federal, provincial, and local governments and health agencies recommend social distancing, wearing of face masks, hand washing, and have, in many locations, limited the congregation of groups of unrelated people. The Vizsla Society of Ontario Inc. (VSO) has put in place preventative measures to minimize the spread of COVID-19. The VSO cannot guarantee that you will not become infected with COVID19. The following information will be shared with and enforced for all handlers, volunteers, and officials attending this event.

- 1. Do NOT attend these tests if you are feeling unwell or exhibiting any COVID-19 symptoms.
- 2. No one is allowed on the grounds other than individuals who are handling a dog, judging, or volunteering in an official capacity. **No spectators and no children.** To keep the number of people in attendance at these tests to a minimum, only 1 person the handler is allowed to attend, with the following **e**xceptions:
 - a. Handlers who are minors, i.e., under the age of 18, who require a parent / guardian to accompany them.
 - b. Handlers who require another person to drive and/or accompany them due to health, mobility, or other legitimate reasons.
- 3. **Physical distancing** (minimum of 2 meters / 6 feet) requirements from people who do not live in your home will be in effect at all times for EVERYBODY.
- 4. At present, it is <u>not</u> required to wear a mask <u>outdoors</u> BUT all handlers, judges, and volunteers etc. are asked to bring / have a face mask on their person for everyone's protection if the 2-metre rule can't be adhered to.
- 5. Bring your own:
 - a. water, lunch, snacks. NO communal coffee or lunch will be provided;
 - b. water for your dogs;
 - c. lawn chair;
 - d. hand sanitizer but do not share it with others.
- 6. Hand sanitizer, paper towels and spray disinfectant will be situated by the Porta Potty. Signs will be posted on the Porta Potty regarding using this stuff! Read the signs and comply!
- 7. The area where the Test Secretary is situated will be cordoned off for her safety. Please respect this area and do NOT enter her workspace.
- 8. Instructions will be posted on the grounds regarding score sheets and ribbons.
- 9. As soon as you are done for the day, hug your dog, leave the test site, and go home.
- 10. Additional COVID-19 safety measure details / instructions may be emailed to handlers with the running order or posted on the grounds.
- 11. The Field Chair/Marshal/Secretary has the authority to enforce the safety measures imposed for these tests. Anyone failing to comply will be asked to leave the grounds immediately and forfeit all runs for the day. Please don't make them do that!
