## CLINIC INFORMATION

1. The clinic will be held indoors in an unheated barn on concrete floors. No indoor crating is available.
2. There is parking adjacent to the barn and additional parking elsewhere on the Exhibition grounds.
3. The Crazy 8s Clinic is being held in conjunction with multiple CKC events. Barn Hunt rules apply within Barn 3, the designated parking lot and the immediate area. CKC rules apply beyond those areas.
4. **Smoking is not permitted anywhere in the Barn Hunt precincts.**
5. Dogs must be on lead (maximum 6') except in the ring and under control at all times. Dogs can become highly excited. Be proactive in managing your dog(s) and respect the needs of other dogs and handlers.
6. Electronic collars, bark collars, head halters and muzzles may not be used in the Barn Hunt area. Dogs may not be brought to the ring on flexi-leads or prong collars. Dogs will run naked in the ring.
7. Bitches in season may participate, but must wear panties at all times while on the Barn Hunt grounds. **Advise us as early as possible if you will be bringing a bitch in season.**
8. No refunds after the closing date (May 8) except for sick or injured dogs with submission of a veterinarian's note.
