Jessica teaches using the Justine Davenport handling system. This handling method works on finding the dog's line so you can be ahead of your dog – great for dogs needing more control and also for those needing more drive.

It is not a requirement to have taken previous training using this system, unless you want a Masters Working Spot in the Saturday and Sunday afternoon sessions.

Four (4) sessions will be offered. There will be something for every level of dog and handler.
