GENERAL INFORMATION

"It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred".

Eligibility to Compete - To be eligible to compete in these trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN, CCN, Eligible for registration with the CKC, or a CKC Miscellaneous Certificate number (MCN) if it belongs to a CKC listed breed. A dog may be spayed, neutered or debarked. Dogs must not be lame or must not compete if tape or bandages may impair its working ability. Dogs with physical challenges are eligible to compete, in the opinion of the judge; they display no signs of physical discomfort and can safely complete the search.

Bitches in season - Bitches in season are not permitted to compete under CKC Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Scent Detection Levels offered – Instinct and Novice (Containers, Interior and Exterior). Exhibitors can compete in all four components.

Scent Detection Prize List - Flat ribbons will be given for all qualifying scores. Rosettes for titles will be available.

Important Notice to Exhibitors – For the NGDC first scent detection trial, exhibitors will only be allowed to enter one dog, per handler in a multiple dog household, unless in different components. Once dogs are competing at different levels, multiple dog household entries will be accepted.

Penalties issued by club - Dropping food while rewarding is considered a contamination. Contamination of the search area will result in a non-qualifying score and any dog who urinates, defecates or vomits within the search area will be excused from the competition and a monetary penalty may in enforced in either situation. Destruction of trial property (excessive scratching or subsequent breaking of an item) will have a monetary penalty enforced.

Tendering of a dishonoured cheque for entry fees shall be considered non-payment of entry fees, and is an offence punishable by disciplinary action and cancellation of awards

CKC Non-Member Participation Fee / Non-member participation fee

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC (\$63.90). The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.
