The starting dog in the first series of the Amateur stakes will be determined by using the last two digits at closing of the Toronto Stock Exchange (TSE) S&P/TSX composite index 2 days preceding the trial. There will be a system of rotation for running order in both stakes.

Any entry scratched after the catalogue has been printed, will require a veterinary certificate for any refund. A \$5.00 administration fee will be deducted from all refunds.
