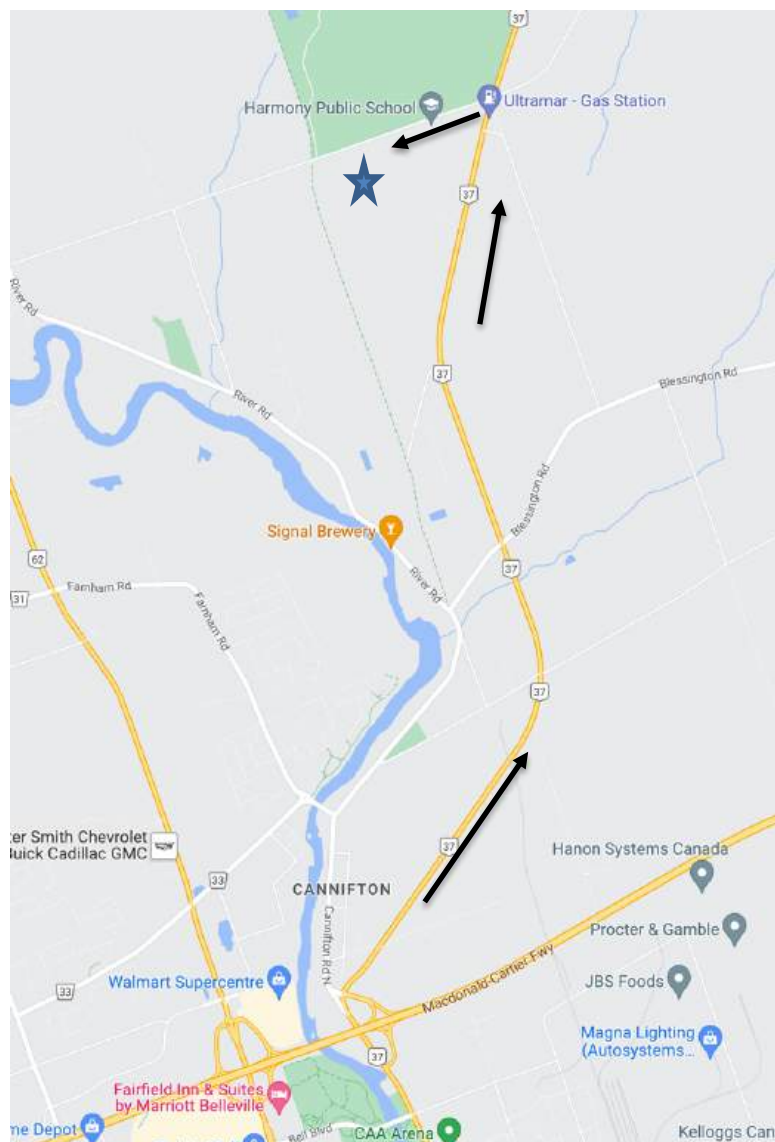

## Directions

From Hwy 401: From the East or West: Take Exit 544. At the end of the exit ramp turn right and go north 5.6 km on Hwy 37. Turn left at Harmony Road (traffic light). Go 1 km. The park entrance is on the left. Look for signs for the trial.



With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs", and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN.

While there is no fee to obtain a TCN, exhibitors will still **be required to pay TCN Fees** (formerly called listing fees) when entering events using this number.

All particulars called for on the entry form must be complete. Any telephone calls required to confirm information will be made COLLECT. Exhibitors must abide by errors made in entering their dog/s regardless of how or by whom the entries were made. No entry will be accepted unless accompanied by full entry fees. The B&DKC cannot accept fax or phone entries and reserves the right to refuse any entry, subject to CKC rules. If because of riots, civil disturbances or acts beyond the control of the Trial Committee, it is impossible to open or complete the trial, no refund of entry fees will be made. All entry confirmation and judging schedules will be e-mailed as soon as possible after entries close.

*Attention U.S. Exhibitors:* We will accept U.S. cheques (checks) as noted in entry fees. Due to the constantly fluctuating currency rates, discounted checks will not be accepted. Personal checks will be accepted; however, they must be made payable in U.S. funds in amounts noted under entry fees.

**Listing Fees:** A CKC TCN fee of \$11.30 including HST Can. or US per dog per trial is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, PEN (Performance Event Number), ERN (Event Registration Number), or Miscellaneous Certificate Number (MCN).

**Eligibility:** To be eligible to compete in this trial, a dog must be at least 18 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN or have a CKC MCN (Miscellaneous Certificate Number). In addition, Mixed Breed with a CCN (Canine Companion Number) may compete. Bitches in season are not permitted to compete in the trial however, entry and listing fees will be returned, providing a veterinarian's certificate stating that the bitch was in season within the 10- day period preceding the trial is submitted to the Trial Secretary on or before the day of the trial.

"It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred". (4.1.3 t)

#### **Awards and Prizes: (for qualifying scores, only)**

**Ribbons:** Flat ribbons will be offered for all first to fourth place in each jump height in each class as well as for all qualifying scores.

Rosettes will also be offered for any new title earned at this trial.

**Precincts of the trial:** All grounds within 100' of the ring area or the fenced area of the grounds, whichever is less, shall be considered the trial grounds. Rings are fenced with 2ft snow fencing and there are two 3 ft high accordion style gates per ring that are closed during the run.

**Course Familiarization:** Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class. There will be a 3 to 5 minute break between the end of the walk-through and the first dog on the line. Warm-up jump/s will be provided in proximity to the ring area.

**Exhibitor Information:** There will be no leash runner. You may carry your leash in your pocket provided it is completely concealed or you may leave a second leash near the exit.

A wading pool and hose will be available for cooling your dog.

**Equipment familiarization:** There will be supervised contact equipment familiarization for dogs entered in the Novice class each day just before the Novice Standard class. No food or toys allowed in the ring.

**Move-up option:** Dogs may be moved up to the next class between trials on the same day, by filling in the required move-up form.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the **CKC Agility Rules and Regulations Effective January 2023**, a copy of which may be obtained by calling the Central Order Desk of CKC at 1-800-250-8040

**Check-in** will start Friday at 3:30 pm followed by PAD and Jumps and Tunnels 1 &2, Steeplechase.

Trial 1 first dog will be on the line at 4:00 pm.

Saturday and Sunday check in begins at 8:00 a.m., with the first dog on the line at 8:30 am.

**Food:** No food is available on the grounds during the day.

## Changes in the 2023 CKC Agility Rules

### Fix and Go On

At any time during a run the handler may immediately fix a single obstacle one time. The action shall be judged as an elimination, which shall be marked as an “FG” on the scribe sheet and indicated by the judge with raised crossed arms, resulting in a non-qualifying score (NQ). The handler may go back a few obstacles prior to the fix (to a maximum of 3). If a jump bar is knocked, the handler may reset it, but the reset is limited to one jump. The dog may not be verbally or physically corrected for the error. Weave poles may be immediately re-attempted three times and not be considered as “Fix and Go On”, but if the dog is brought back to obstacles prior to the weave poles, it will be considered the one-time Fix and Go On attempt. Once handlers have used the one-time Fix and Go On option, they must immediately finish the course or exit the ring. The judge shall not judge the dog’s run after the fix but will continue to watch the run to ensure that the handler is going on to complete the course correctly, is not using harsh commands or corrections and that the run is being done safely. The judge will immediately whistle to excuse the team from the ring for any of these infractions.

### For Fun Only Class

A dog entered in any class at the trial, may be moved to FFO at the handler’s discretion during the trial. When the handler enters the ring, he must inform judge it is an FFO run, and the judge then tells the scribe who writes this on the scribe sheet, so the secretary knows. The secretary will note in the catalogue moved to “FFO”. The entry fee originally paid to enter will stand and the recording fee for that run will be paid to CKC as if the dog ran as entered.

### Other Changes

- A-frame to be set at 5ft for dogs jumping 16”.
- Dogs and/or handlers may enter classes under a judge who resides in the same household or who is a family member, or a member of the same agility club.
- Handlers are allowed to carry a leash on their person during a run with the proviso that it is fully concealed.
- Ascending double jump is approved for use and may replace the Double Jump on a course. The Ascending Double Bar Jump consists of two ascending bars 5 feet in length where the back bar is positioned at the jump heights specified for the Bar Jump. The front bar is set 4” lower than the back bar. It may be built as a special jump or assembled from two Bar Jumps. In addition, one bottom bar, 5 feet in length, must be placed under the back bar and angled to the ground. All other specifications are the same as for the Bar Jump.
- For the Intermediate level: equipment includes Panel Jump or Wall Jump, Double Bar Jump or Ascending Double Bar Jump, one set 12 weave poles, used once
- No Backside approaches are allowed at the Intermediate level.
- For the Excellent/Masters level the table is optional.
- Two (2) spread type jumps may be used in succession in Excellent/Masters;
- There is a limit of 2 backside approaches that may be used on a course in Excellent/Masters.

Clubs may apply to the CKC to have courses designed by one judge and judged on site by a different judge. Both judges must be approved by the CKC. We will not be exercising this option this year.

- Novice class is open to dogs that have not acquired an Intermediate leg in the class entered.
- Intermediate class is open to dogs that have acquired the Agility Novice title, and to those dogs which have not yet acquired a qualifying score towards the Agility Excellent title in the class entered.
- Excellent class is for dogs that have acquired the Agility Intermediate title, but have not yet earned a qualifying score towards an Excellent title in the class entered.
- Master Excellent class is for dogs that have acquired the Agility Excellent title in the class entered.

**Height Divisions**

Handlers are responsible for entering the correct height division. The judge may request any dog be measured.

***Selected*** Class dogs will jump one height lower than the equivalent regular class height shown in the table below and dogs who measure 10" or below will jump 4" in the Selected Class. ***Veteran*** dogs may jump one or two heights lower. The following jump height divisions shall be use in all regular classes.

8 inches for dogs 11 inches and under at the withers
12 inches for dogs 11 to 14 inches at the withers
16 inches for dogs 14 to 18 inches at the withers
20 inches for dogs 18 to 22 inches at the withers
24 inches for dogs over 22 inches at the withers

**Obstacles:**

Agility obstacles meet the requirements of the CKC Agility Rules

*Note:* A-Frame, Dogwalk, Teeter and Table have rubber surfaces and the tire is a breakaway self-healing type. There will be no required position on the table and the count will be continuous. Six weave poles are in all Novice Classes. One bar jumps may be used at any level. A Frame is set at 5' for dogs jumping 16" or less and for the Steeplechase class and 5'6" for other all other classes.

**Electronic timing** will be used at these trials. There will be two rings running alternately.

**Camping**

Overnight dry camping allowed at the trial site. No services but water will be available for fill-up. Cost: \$10.00/day. Generators Allowed. Indoor flush toilets available.
