- Be sure to be on time for your walk through/event and have your dog ready when your number is called.
- Dogs must be crated at all times, except when performing their event or in the ready ring. We want to keep the building entrance and aisle way clear for accessibility to the ring and exit.
- The warmup ring will be marked out and the next dog in the ring will be given priority for warming up.
- Remember to pick up after your dog. The building entrance and the Nadin lot are not potty areas. Go to the north end of the building to potty and please, please pick up. Garbage cans are located outside for your use.
- Owners are responsible for crate outbursts/continuous distracting noise by their dogs and will be asked to monitor their dogs closely or move them to wait in a vehicle. Please familiarize yourself with the new 2018 CKC rules regarding canine behavior at event sites.
- Be sure you have made yourself familiar with the new 2018 CKC rules regarding performance classes. Please be patient, as the trial officials work with these rules.

**3.4.2 Replacement Judge

- (b) All those who have entered dogs under the advertised judge shall be allowed to withdraw at any time prior to judging of that trial. All requests for withdrawal shall be in writing and all entry fees and listing fees will be returned to the owner or the authorized agent of the dog. When possible, the trialgiving club will attempt to notify exhibitors of the judging change at the time the judging schedule is sent out.
- 3.4.3. In all cases, changes in judges will be posted in a prominent location at ringside.
- 3.4.4 A qualifying score earned under a substitute or replacement judge will be considered as having been earned under the advertised judge
