Judges' Biographies



Mr. David Kill

It is with great excitement that I look forward to judging for you in July 2025. Yet another dream coming true.

I have been engaged in the showing and breeding of pedigree dogs since the age of 10, way back in the 1960s.

My current breed passion is the Irish Water Spaniel breeding under the 'Bunyarra' prefix, 13 years in the breed but English Cockers, English Setters, Pointers, Border Collies and Whippets have also been major parts of my life.

I commenced judge's training over 45 years ago and I am now qualified as an ANKC and FCI International All Breeds judge, officiating all around Australia, Philippines and New Zealand where I was chosen to judge the Finals of the New Zealand Dog of the Year 2024 event. Canada will be my first adventure into the Northern Hemisphere.

I have been asked to judge quite a variety of breed specialties including Cocker Spaniel Club, Bullmastiff Club, French Bulldog Club and the Brussels Griffon club to name just a few..

I offer totally unbiased and honest opinion when judging without fear or favor. Judging is a privilege that I hope I never take for granted. I love it. Looking forward to day 1 in Canada



Mrs. Janet and Mr. Joe Lobb - Dobenhause Reg & FauxPaw Reg

Joe and Janet Lobb live in a small village approx. 2 1/2 hrs west of Toronto, Ontario, Canada. We have two children, a daughter and a son, a son-in-law and are proud Grand Parents of two beautiful granddaughters. Now both retired, Janet enjoyed a 30-year career in Data Base administration for a Window and Door Manufacturer. Joe was involved in the Farm Equipment industry in Sales and Territory Management for over 45 years.

As far as Dog Show involvement, we are 'Life' members of the Canadian Kennel Club and belong to the 'Canadian Dog Judges Association'. We were founding members of the 'all breed' Bluewater Kennel Club which existed for over 35 years. We are currently members of the American Fox Terrier Club and very active members with the German Shepherd Dog Club of Canada. We are past members of DPC Canada, Lake Effect Fox terrier Club NY and Black and Tan Coonhound Club of America.

We have limited our breeding and showing for many years now due to our judging. We try to attend major Dog Events and Specialties in the U.S.A. and Canada for education & observation purposes. We are also quite interested in All Livestock exhibitions and attend these events as much as possible.

Janet started judging (1996) a few years earlier than Joe and is CKC licensed for 'All Breeds'. Joe continued to show dogs for others for a couple more years due to some handling commitments, before jumping into the 'Judging ring' (2002) but is now also licensed to judge 'All Breeds'.

As for dogs, we recently lost our elderly Smooth Fox Terrier and Black and Tan Coonhound and for the first time in 48 years we are living without a dog in our home. We are missing them terribly and hope to bring in a new household member if an opportunity arises.

Of note, one of our fox terriers and our first B&T coonhound were the 'top dogs' in Canada in their respective breeds in 2006, the only year they were shown to any degree. Our last SFT was Canada's Top Smooth Fox in 2013. All attained American Championships with some very nice wins along the way. Another point of interest, is that our first Coonhound is the only multi 'best in show' winning bitch in breed history in our country. Our last B&T coonhound male finished his Canadian title with two Best in Shows from the classes and obtained his Grand Championship in the USA with great success and multiple groups and RBIS along the way.

We started "in dogs" in 1974 with a Doberman dog of show quality. Our first litter was whelped in 1977 under the 'Dobenhause' prefix. We were always a small kennel breeding only one litter per year. There have been many champions along the way from all litters, with many highlights. These include, group winners, best in show puppy awards, several "awards of merit" at national specialties, best of winners at the Canadian national and "best in show" at the Doberman Pinscher club of Canada National Specialty in 1991. All of these dogs were breeder/owner handled. We also bred and owned the top producing female in Canada in 1990, with 7 champions finished that year, which in turn tied us with Wrath-Liberator Kennel for Pedigree Pal Breeders of the year for Dobermans in Canada. In the late 1990's we were also co-breeders of Canada's Top Doberman.

In 1988 we added the smooth fox terrier breed under the "FauxPaw" prefix to our kennel. We started with a Ch.Tarb the Brat granddaughter, who gave us multiple Canadian and American champions in her two litters. We have had Canada's 'top smooth' on several occasions, and dogs that were either owned or bred by us have won the Canadian National Specialty three times. A particular win of note would be AOM at the American National (Montgomery) in an entry of one hundred and sixty-seven. Also, Pedigree Pal Top Breeder in Canada award in 1997.

Mrs. Janet and Mr. Joe Lobb - Dobenhau Reg & FauxPaw Reg

Over the years we have had many excellent dogs of other breeds in our household and in our charge, some of which we owned and some we handled for other breeders and owners.

We handled professionally, (Joe primary and Janet more as assistant and backup) for twenty-five years. This consisted of some of Canada's top or top ranked dogs Handled breeds of note were Dobermans, Bernese Mtn dogs, Boxers, Australian cattle dogs, German Shepherd, Bouvier, Collies, Smooth fox terriers, Wheatens, Pugs, Chins, Setters, Springers, Golden, Labs, Greyhounds, B&T Coonhound. We also owned, exhibited, and are involved with the German Shepherd breed and handled at many Specialty events in the earlier years.

Handling highlights would include winning All Breed BIS and Specialty BIS (incl National events) with many of the above-mentioned breeds. Joe piloted a Canadian bred Bernese Mtn. Dog to Best in Show at the American National Specialty as well.

To date we have judged in Canada, USA, Australia, Bermuda, China, Mexico, Colombia, Argentina, Japan, Slovenia, Finland, Ireland, New Zealand, Sweden, Peru, Chile, South Africa and Wales. We've been honoured to have awarded "BIS" in many of these countries.

Assignments have included many 'Specialty' events...including national/regional/chapter club shows for Dobermans, Bernese Mtn Dogs, Alaskan Malamute, Siberians, Rottweilers, Boxers, Aust Cattle Dogs, German Shepherd, Chesapeake Bay Retrievers, English Setters, Vizslas, Labradors, Weimaraners, Borzoi, Basenji, Newfoundlands, Eng Toy spaniel. We have also both enjoyed judging "Rare Breed" Shows in Canada in past years as this has exposed us to many other well-known breeds from around the world. We've been honoured to have officiated at "Special" events including Canada's "Show of Shows" (Joe and Janet-2009) and the "Atlantic Top Dog Awards" (Janet-2010 & 2012)

We judged the 50th anniversary Specialty of the New Zealand Dominion Doberman Club in 2017. We were asked to create and present a seminar on Dobermans for judges in Japan in 2014 with a record attendance at that point. This same seminar info was requested by the Kennel Club of Peru.

We were honoured to be asked to assist with the mentoring of AKC Judges at the DPC of America National in the Chicago area in 2018.

In 2022 we were very honoured to go to Wales and judge the Golden Anniversary Championship Show (50th) for the Welsh Doberman Club. Joe - Dogs Janet - Bitches. Best of Breed was decided between the two of us, and no easy feat, as both sexes were excellent.

Both of us have also judged multiple Specialties and are well known in the Bernese Mtn Dog and German Shepherd World. Obviously, many of the Terrier breeds have also been of keen interest for us, and we've been fortunate to have had some great assignments involving them.

Specialty assignments are taken very seriously, as we fully understand the impact our evaluations and ultimate decisions may have on the breed.

Officiating around the world has allowed us the opportunity to judge most breeds, and it is very interesting noting the similarities and differences encountered in many different countries outside of Canada and USA.. It's also great to experience many breeds that we don't have here in North America. All assignments have been very rewarding and enlightening and continue to provide broader knowledge and experiences with all breeds.



LEYDA L PEREZ

Colombia

Leyda L Pérez is an all-rounder judge with FCI since 1998; she is also licensed by the American

Kennel Club to judge all breeds, as well as by the Canadian Kennel Club and the Australian

National Council.

Leyda has been involved with dogs all her life, since she comes from a “dog family”. She grew up

with many dogs, from hounds to Pokes as well as her beloved companion, a Springer Spaniel.

She was introduced to the world of dog shows in 1978, when her mother purchased a show quality Shih Tzu and a Scottish Terrier. When the Scottie went on to win a BIS, she was hooked.

Leyda purchased her first Yorkshire Terrier in 1982. In these 42 years, she has bred, owned and shown her dogs to more than 200 championship titles, under her kennel name LLYLL.

Leyda is extremely proud of her homebred Multi BIS Multi CH Llyll's Pretty Woman, who was Colombia's top dog all breeds in 2002 and also won the “AMERICAS INVITATIONAL RANKING”.

She also bred and owner-handled her Multi RBIS Multi Ch Llyll's Champs Elysees to top Terrier in 2008.

Her other home bred ADULT Best in Show winners include Llyll's Cross-Over, Llyll's Guardian Angel, Llyll's Mon Amour, Llylls J'Adore, Llyll's Brigitte Bardot, Llyll's Hermione Granger and Llyll's Ottawa.

She has also been involved with other breeds, including a Multi BIS, Multi Ch Japanese Chin, a Multi BIS Multi Ch Papillon, group winning Chihuahuas, Italian Greyhound, Whippet, Azawakh, Basenji and Scottish Terriers.

Leyda is a founding member of the Corporación Club Canino del Valle (located in Cali, Colombia) where she currently works as the Executive Director. She is a member of the ACCC (Colombian Kennel Club) and the Yorkshire Terrier Club of America.

Leyda has judged in almost all countries in Latin America, Canada, United States, Australia, South Africa, Japan, Korea, Italy, Spain, Sweden and Bulgaria. She has judged Toy Specialties in the United States, as well as all-breed shows. She has also judged the Eukanuba Cup in Mexico, the SICALAM show in Guatemala. She was the ONLY Colombian judge invited to the Americas and Caribbean show held in Colombia in 2016, where she judged Best in Show and received a standing ovation.

Sunday, July 27, 2025 (lunchtime)

Held under CKC Rules. Judge to be announced the day of the show.

Sponsored by Best In Show Dog Supplies, MJN Show Services, Bonnie Greer (Mostly Pewter) & Dogs in Design.

Class Structure (Age Requirements)

- 1. PEE WEE**
For handlers 4 years of age up to 6 years of age. Optional and non-competitive. No placements are to be awarded, participant ribbons, rosettes and token trophies may be presented.
- 2A. JUNIOR NOVICE**
For handlers 7 to 10 years who have not won six first places in the same class with competition.
- 2B. JUNIOR OPEN**
For handlers 7 to 10 years of age, who have won six first places with competition in the Junior Novice Class, OR any handler wishing to enter this level. It is understood that once that handler has entered and competed in the Open Class, he/she may not compete in the Novice Class again.
- 3A. INTERMEDIATE NOVICE CLASS**
For handlers 11 to 14 years of age, who have not won six first places in the same class with competition.
- 3B. INTERMEDIATE OPEN CLASS**
For handlers 11 to 14 years of age, who have won six first places in the same class with competition.
- 4A. SENIOR NOVICE CLASS**
For handlers 15 years of age and up to 18 years of age, who have not won six first places in the same class with competition. Handlers from the Intermediate levels progress to this class.
- 4B. SENIOR OPEN CLASS**
For handlers 15 years of age and up to 18 years of age, who have won six first places with competition in the Senior Novice Class and for any handler who has progressed through the Intermediate Open level and feels that he/she has enough experience to compete at this level.
- 5. BEST OVERALL**
Optional at the discretion of the host club.

All dogs must be entered in one of the Official Classes or Exhibition Only on the day of competition. Entry to be made at the show.

Dogs being used in the competition must be of appropriate size and temperament for the Junior Handler. If Pee Wee handler cannot lift dog, it is not appropriate in size for the competitor.

No Baby Puppies can be used for Junior Handling.

2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
3. The Club and MJN Show Services will not be responsible of cash sent through the mail.
4. The Club reserves the right to refuse any entry subject to CKC rules.
5. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
6. Entry fees shall not be refunded in the event that the dog is absent, excused by a Veterinarian or Judge, disqualified or barred from competition by action of the bench Committee.
7. Alterations, substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials or unfinished Specials back to the classes is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs already registered in the Canadian Kennel Club Stud Book, or eligible for such registration, can be entered. The committee reserves the right to refuse any entry subject to CKC Rules. **Entries close 8 P.M. (ET) Wednesday, July 2, 2025, and must be in the hands of the Show Secretary by that date.**
8. Identification cards and judging schedules will be e-mailed as soon as possible after the entries close.
9. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. **Any NSF cheques will be subject to a \$35 service charge.**
10. All dogs must be attended to by its owner and/or handler day and night (24hrs). No dogs are to be left unattended on the premises and/or buildings of the events.
11. The Limestone City Kennel & Obedience Club and its Executive/ Members will not be responsible for, or assume liability in the event of theft.

USA Exhibitors

Bank drafts or money orders in Canadian Funds and personal cheques, payable in U.S. funds, and for the full amount of the entry will be accepted. Personally discounted cheques will not be honoured. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par" as such items are not cleared through the banks. Your cooperation is appreciated.

General Information

1. The Show Superintendent will be in full charge of the show, which will be governed by CKC Rules.
2. The Limestone City Obedience and Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
4. Dogs may arrive any time prior to their scheduled time of Judging. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Owners/Agents are responsible to have their dogs present when their classes are called to be judged.
5. Judging start times to be specified in the judging schedule. Starting time of each ring will be specified in judging schedule.
6. SHOW PRECINCTS: Lombardy Agricultural Fairgrounds. Dogs not entered in these shows will **not** be allowed within the show precincts.
Rule: To ensure a healthy and enjoyable environment for all attendees, the use of any drugs and the smoking of cannabis products are strictly prohibited within the defined show precinct of the Lombardy Fairgrounds. This includes, but is not limited to, all buildings, tents, outdoor spaces within the event boundaries – show precincts. Violators may be subject to removal from the premises and further action as deemed necessary by fairground or event organizers. No monetary compensation for entries/expenses will be provided to handler, owner, attendee, exhibitor and/or breeder; and violators will be banned from any future shows held by this club.
7. Exhibitors are requested to keep their grooming and crating areas clean and tidy. The Show Superintendent has the authority to ask exhibitors to move or take down crates and private exercise pens, etc. Failure to do so when requested could result in disciplinary action.

Refund Policy

If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.

Exhibitors, handlers, judges and assistants are expected to participate with honesty, fairness and integrity, ever mindful of the practice of "good sportsmanship," before, during and after this show. Any person engaging in an activity that might be considered malicious, threatening or constitutes bullying, including but not limited to social media, will be asked to leave this show without compensation and will be banned from any future shows held by this club.

Temporary Competition Number (TCN)

A Temporary Competition Number (TCN) allows dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

A TCN must be obtained before submitting an entry for an event.

The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN.

TCNs can be obtained through your CKC member portal or by contacting the CKC.

Note: There is no CKC fee to obtain a TCN. However, a TCN 'listing' fee is required each time a dog with only a TCN is entered in an event.

Event Registration Number (ERN)

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, and do not have a CKC registration number, will require an Event Registration Number (ERN).

The ERN number MUST be applied for within 30 days of the first day of entering a CKC event.

Fee is \$64.00 per dog, plus applicable taxes.

Non-Member Participation Fee

Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$170.00 plus applicable taxes.
 - b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
 - c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
 - d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

CH and Champion Points

Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs competing*	1	2	3 to 5	6 to 9	10 to 12	13 or more
Points allocated	0	1	2	3	4	5

**includes the dog awarded Winners*

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge SHALL NOT be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points, provided that a dog was defeated at the group level.

Section 15.1.11 A class dog awarded Best in Show at an all-breed Championship show will be credited with five points inclusive of any points earned at the breed or group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned 10 championship points under at least three (3) different judges, with at least one 2-point win either at the breed or group level.

GCH and Grand Champion Points

Section 15.2.1 The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

15.2.2 Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

Section 15.2.3 To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

- a) Grand Champion Point System Points towards the Grand Champion title, are attained at breed level and are awarded to Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level for all levels of GCh:

- c) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age. In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.
- d) Only the highest points earned at a single show are carried forward.

Section 15.2.4 Grand Champion Bronze (GChB)

The title of Grand Champion Bronze may only be earned after the completion of the CKC conformation title Grand Champion is attained.

- a) Points for this title are only accumulated after the completion of the Grand Championship, and do not include the points earned in attaining the Grand Championship.
- b) To be awarded a Grand Champion Bronze title, a dog must attain a minimum of 50 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/Specialty level. Only the highest points earned at a single show are carried forward.
- c) Points accumulated prior to July 1, 2021 may be used to attain the GChB title, however, a minimum of five (5) points must be earned after July 1, 2021.

Section 15.2.5 Grand Champion Silver (GChS)

The title of Grand Champion Silver may only be earned after the completion of the CKC conformation title Grand Champion Bronze is attained.

- a) Points for this title are only accumulated after the completion of the Grand Champion Bronze is attained, and do not include the points earned in attaining the Grand Championship Bronze.
- b) To be awarded a Grand Champion Silver title, a dog must attain a minimum of 100 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

Section 15.2.6 Grand Champion Gold (GChG)

The title of Grand Champion Gold may only be earned after the completion of the CKC conformation title Grand Champion Silver is attained.

- a) Points for this title are only accumulated after the completion of the Grand Champion Silver is attained, and do not include the points earned in attaining the Grand Championship Silver.
- b) To be awarded a Grand Champion Gold title, a dog must attain a minimum of 200 points, which must include a minimum of two wins of at least two (2) points each. Points must be gained at breed, group or Best In Show/ Specialty level. Only the highest points earned at a single show are carried forward.

GCHEX and Grand Champion Excellent Points

The title of Grand Champion Excellent may be granted only after the completion of the CKC Grand Championship Silver Title. Exhibitors will be required to submit to Shows & Trials the Grand Champion Excellent Record Sheet documenting the additional requirements. The Grand Champion Excellent Record Sheet Form is located on the CKC website.

Section 15.3.2 To earn the title a dog must have earned the following during their career as a Special:

- a) one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed).
- b) three (3) Group 1st, or three (3) breed specialty Best of Breed wins.
- c) a CKC performance title from any CKC Event. Titles excluded are: CGN, Herding Novice Tested Certificate, all Instinct titles from all events, as well as all Sprinter titles and all Chase Ability Program titles.

Section 15.3.3 Best in Show, Best of Breed at a National Specialty, 3 Group wins, or 3 Specialty Best of Breed wins, must be attained after the completion of a regular championship. The performance title may be attained at any time in the dog's career.

Altered Champion and Altered Points

Section 13.8.1 Championship points will be awarded as per Chapter 15, with the exception of 15.1.11. The winner of an Altered Best in Show shall be awarded points according to the total number of dogs in competition following the point schedule in Section 15.1.2.

Section 15.1.12 In order for a dog to be recognized as a Champion [Alt] and its owner provided with a Championship Certificate, the dog must have earned at least one 2-point win either at the breed or group level.

Conformation Show Rules and Regulations

The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club.

Section 4.7.1 of the Conformation Show Rules and Regulations states: A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Moving Class Dog to Specials Only

Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only," providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the judging of your breed by the owner or handler.

When one or more all-breed and/or specialty shows are held on the same day, in the same venue, the request for moving of class dogs to Specials Only must be made a minimum of one (1) hour prior to the breed judging scheduled start of the show for which the dog is being moved up to Specials Only.

Moving from Specials Back to the Classes

Section 8.10.5 A dog can be moved back into the classes from a Special if it has been entered incorrectly, only where the shows have already closed.



HEALTH REMINDERS

No dog may be brought onto the grounds or premises of an event if it:

1. Is known to have distemper, parvovirus, kennel cough or other communicable disease;
2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease within the last 30 days (prior to the event);
3. Has been housed within 30 days prior to the event on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

Clubs do have the right to remove a dog from the event premises and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

At events where judges will be checking bites, judges should be encouraged to have the exhibitors show the bite. If the judge insists on checking bites themselves, they are expected to use hand sanitizer or soap and water in between each exhibit. Please ensure that sanitizer wipes and bottles of hand sanitizer are available at all times at events.



ZERO TOLERANCE – Any individual initiating bullying tactics at the Limestone City Obedience & Kennel Club Events will be asked to leave the Event grounds premises immediately and for the remainder of the event (no refunds). A report will be filed with CKC and the Disciplinary Committee shall have the authority to take such action as it deems fit.

Definition of Bullying: Refers to a range of behaviors in which targeted individuals are repeatedly, and over time, treated in a mean, insulting or abusive way. Bullying can be initiated deliberately or unconsciously. The affected person may feel upset, afraid, isolated, or humiliated. The bully sometimes acts alone and sometimes as part of a group of people.

Examples include:

- *insulting a person's skills, looks, or habits*
- *spreading false or malicious rumors, gossip, or innuendo*
- *berating/belittling an individual*
- *unwarranted criticizing or ridiculing, especially in the presence of others*
- *giving insulting Nicknames*
- *engaging in practical jokes that humiliate*
- *undermining or deliberately impeding a person's work*
- *physical gesturing that intimidates, offends, degrades, or humiliates*
- *mocking a person's accent, abilities or mannerisms*
- *yelling or shouting which intimidates, coerces, or belittles*
