Exhibitor Information

Eligibility

To be eligible to compete in these trials a dog must be 18 months of age or older and have a CKC Registration number, CCN, MRN, MCN, PEN or a TCN. Bitches in Season are not allowed to compete and will be refunded their entry and listing fees provided a veterinarian's note stating that the female was in season within 10 days before the start of the trial and is submitted to the Trial Secretary on or before the day of the trial.

Listed Dogs

Dogs without an individual CKC registration number must obtain a Temporary Competition Number (TCN). The TCN allows a dog that is eligible for CKC registration or an Event Registration Number (ERN), to participate in CKC events. Temporary Competition Numbers must be obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid.

While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees when entering events.

Non-Member Participation Fee

An annual non-member participation fee will apply to any exhibitor who is a Canadian resident and a non-member of the CKC earning awards/titles. To protect awards/titles earned the non-member will have to pay \$64.00 for each dog being tracked by the CKC or become a CKC member within 30 days or notification. Failure to comply will result in loss of awards/titles.

Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Discounted cheques will not be accepted. Cheques in US funds are accepted for the full amount of the entry and no exchange will be refunded. Please do not mark cheques "payable in Canadian funds" or "at par". Bank drafts and money orders in Canadian funds are recommended.

Other Information

Please take the time to read through

- Flat **ribbons** will be awarded for qualifying scores and for 1st through 4th placements. New title rosettes will be available.
- **New CKC rule**: Senior handlers (65 years and over) and handlers with disability may request a modified course time. A handler must indicate on the entry form if entering as senior/disabled handler (check S/D box) to receive modified times.
- **New CKC rule**: Dogs can run in <u>For Fun Only (FFO) class</u> in any category. The owner would be allowed to take their dog into the ring with a toy. Toys are allowed but the toy must be identified to the judge prior to entering the ring. A maximum course time of 60 seconds is allotted, and course direction must be followed.
- **Course Familiarization**: Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class. There will be a 5-minute break between the end of the walk-through and the first dog on the line.
- **Equipment Familiarization** will be available for the Novice dogs before the start of the first Novice STD class.
- **Equipment**: The Table, Teeter, Dog-Walk and A-Frame are all rubberized. Tire is breakaway style. 24" weave poles will be used. Timing is electronic.
- **Steeplechase** is a fast-paced game designed to emphasize speed and control on a Jumpers style course which contains the two most dynamic obstacles the A frame and Weave Poles. This class is open to any dog eligible to compete in any CKC agility class regardless of previous levels of achievement. To qualify the run must be under the standard course time for the jump height.
- **Food** trucks and fast food are available off site within a few minutes from the venue. You are responsible for your own food
- **No treats** allowed in the ring. Food cannot be within 10 ft of ring.
- Please pick up after your dogs or risk excusal from the grounds
- No provision for inclement weather
- **NSF cheques** will be subject to a \$35 service charge
- Judging schedule and covid protocols will be emailed after the closing date
- Move-ups will be allowed after the closing date and in between trials
- **Dr. Laura McKeown** (<u>www.petchiro.ca</u>) will be available in the afternoon
- Classes run quicker with the more **volunteers** we have. Family and friends are welcome to help unless we are limited in the number of people allowed. Liability and COVID waivers must be signed. Sign-up sheets will be available at the trials. We need course builders, scribe, timer, gate and bar setters. Training provided!



COVID-19 Safety Protocols

Final protocols will be sent with the judging schedule

- > Stay socially distant from others including during walk throughs, judge's briefing and from anyone who is not in your bubble
- Walk throughs might be done in small groups and masks might be required
- Use hand sanitizer (provided near rings) as often as possible (before and after course building, before and after timing or scribing, before and after handling the gates, before and after being ring crew)
- Chairs will be provided for ring crew, but you are welcome to use your own in the ring or to wipe down the existing chair
- > Crating and personal chairs must be at your vehicle. Exception for trial committee
- As per CKC rules you must enter and exit the ring on leash. However, there will not be a 'leash person'. You may: use a small lead that fits in your pocket, use two leashes one that you throw over the fence at the start line and one that you leave on the fence at the exit prior to entering the ring or use one leash that you throw towards the exit once you have entered the ring, as long as it is not on the course. You <u>cannot</u> carry a leash in your hand while on course.
