- 1. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules.
- Any dog excused by the Show Superintendent or the Show Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show. Any female excused because of being in season shall not be allowed to compete in any class for any award.
- 3. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
- 4. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the show and it shall be the duty and obligation of the Club holding the show to see that this rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the rules, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated.
- 5. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds.
- 6. Dogs must be on the grounds one hour before the judging of the breeds, and may be removed when not required for further judging.
- 7. DOGS MUST BE READY FOR JUDGING. The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of breed or class judging. No ring shall be held up waiting for exhibitors or handlers. Exhibitors & Handlers with more than one dog shall have substitute handlers available so the judging will not be delayed.
- 8. The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog, regardless of how or by whom the entry was made.
- 9. A dog once disqualified for any reason at a championship show held under these rules cannot again be shown at a show held under these rules until the dog has been examined by an official committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$50.00 plus GST which shall be forfeited to the CKC if the examining committee is satisfied that the dog should remain disqualified. All awards earned at a dog show in violation of this rule shall be canceled by the CKC and the owner of the dog is subject to disciplinary action.

CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS

SECTION 2. The schedule to be employed in the determination of the number of points to be allocated to a dog awarded WINNERS shall be as follows: (*Includes the dog awarded Winners.)

Dogs Competing* 1 2 3 to 5 6 to 9 10 to 12 13 or more Points Allocated* 0 1 2 3 4 5

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above.

NEW: A dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall be included in the calculation for championship points. Further section 15.1.12 {C} has been added and states the dog must: "have earned at least one 2 point win either at the breed level or group level."

The system provides for additional points if a dog awarded winners also places in the Group as listed hereunder.

A class Dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more that five (5) points at a single show.

CLASSIFICATION - CONFORMATION

The following classes will be provided, divided by sex.

REGULAR CLASSES

JUNIOR PUPPY - 6 months & under 9 months on the day of the show SENIOR PUPPY- 9 months & under 12 months on the day of the show 12 – 18 MONTH CLASS 12 months and under 18 months on the day of the show. CANADIAN BRED - for dogs born in Canada, Champions in any country excluded.

BRED BY EXHIBITOR - shall be for dogs owned and handled in the ring by the breeder.

OPEN CLASS - shall be for all Dogs.

SPECIALS ONLY - This class will NOT be divided by sex and open to dogs which have a recorded CKC registration or Event Registration Number and have attained the required points for Championship status. All awards earned at the show will be cancelled if it is found that a dog is not registered or has not completed the requirements for a CKC Championship. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

NON-REGULAR CLASSES

EXHIBITION ONLY - Dogs entered in this class may not compete in the regular breed classes.

CLASSIFICATION – RALLY

Rally Novice A – Dogs competing in this class may not have won a CKC Rally Novice (R.N) title or any CKC Novice obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A and Rally Novice B at any one trial.

Rally Novice B – Any dog may complete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class

Rally Advanced A – This class shall be for dogs that have won the Rally Novice (R.N.) title but have not won the Rally Advanced (R.A.) title or any CKC Novice obedience title. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

Rally Advanced B – This class will be for dogs that have won the Rally Novice (R.N) title. A dog completing the Rally Advanced (R.A.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A – This class will be for dogs that have won the Rally Advanced (R.A.) title, but have not won the Rally Excellent (R.E.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families.

Rally Excellent B – This class will be for dogs that have won the Rally Advanced (R.A) title. A dog completing the Rally Excellent (R.E.) title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

CLASSIFICATION - OBEDIENCE

NOVICE "A" - No licensed handler, no trainer, nor any person who has previously exhibited a dog through its U.D. Title in Canada or Elsewhere shall be allowed to compete. When a dog is wrongfully entered in this class, any score awarded will be canceled.

NOVICE "B" - Dogs in this class may be handled or exhibited by the owner or any other person & shall be for pure-bred dogs of any breed which have not won the title of C.D. in Canada

OPEN "A" - No licensed handler, no trainer, nor any person who has previously exhibited a dog through its U.D. title in Canada or Elsewhere shall be allowed to compete. When a dog is wrongfully entered in this class, any score awarded will be cancelled. The dog must have earned it C.D. Title to enter this class.

OPEN "B" - Dogs in this class may be handled or exhibited by the owner or any other person & shall be for pure-bred dogs of any breed which have not won the title of C.D. in Canada. The dog must have earned it C.D. title to enter this class.

UTILITY - This class shall be for purebred dogs of any breed, which have won the title of C.D.X in Canada. Handlers, trainers & kennel employees may compete in this class.

VETERANS- the veterans' class is performed under the rules described for the novice class. Dogs must be 7 years of age or older PRIOR to the closing of entries. Dogs must also have a minimum CD tile. Dog must be entered in a regular class or for exhibition only.

PRE-NOVICE – shall be for any dog which has not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs in this class may be handled by the owner or any other person.

PLEASE NOTE: We will refund entry fees for bitches entered in Obedience that come in season after entries close, with a vet certificate.

<u>Intermediate Open Class</u> From ages 11-14 years who HAVE won six firsts in the same class with competition.

This class is for handlers 15 yrs of age as of Dec 31st of the year preceding the competition year and up to 18 years of age.
