Non-Member Participation Fee :

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply with in 30 days of notification will cause all awards and titles to be cancelled.

Attention Foreign Exhibitors: ERN numbers must be applied for within 30 days of the first day of entering a CKC event. A CKC ERN registration form can be downloaded from the CKC website: http://www.ckc.ca

The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
