All entries paid by credit card MUST be sent via Dogshow.ca. No other entry service is authorized to accept entries for these events. The BSDCCAS does not accept credit cards for payment.



**DogShow.ca Refund Policy was updated on April 7, 2021 to reflect that their service fees are no longer refundable for any reason.**

To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Trial Secretary after the closing time and date.

All entry fees must be in the hands of our Trial Secretary prior to closing date. Personal cheques and money orders for full value only will be accepted and must be made payable to the **Belgian Shepherd Dog Club of Canada Atlantic Section**. No post-dated cheques accepted. All NSF cheques and declined credit cards will be subject to a charge of \$40.00. NSF cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the trial. A copy of the Obedience and Rally Rules is available from the Canadian Kennel Club. Each exhibitor is responsible for knowing and complying with the rules of the Canadian Kennel Club regarding their events.

**Temporary Competition Number** - \$11.40 "A TCN fee as established by the Canadian Kennel Club must accompany the entry of a dog which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form."

**Fees** are payable to: **BSDCCAS**. Post-dated cheques will not be accepted. NSF cheques are considered non-payment of entry fees and will be charged a fee of \$25.00. Please note that fees are due and payable in Canadian dollars. Bank drafts or INTERNATIONAL money orders payable in Canadian funds are acceptable. Your understanding and cooperation is appreciated.

BSDCC will use all reasonable care to ensure the safety of dogs and persons at the test. However neither BSDCC nor any individual will accept the responsibility for loss or injury, however caused, to any dog, person or property.

### GENERAL INFORMATION

1. The Trial Chairperson will be in full charge of the event which will be governed by CKC rules.
2. Judging schedules and Armband Nos. will be sent as soon as possible after the Closing Date.
3. The BSDCC will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for or assume any liability in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
4. If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or to complete the Trials, no refund of entry fees will be made.
5. **All exhibitors will be responsible for clean up on the grounds and surrounding areas for their own dogs and/or dogs they are handling.**

6. Precinct includes the entire property. BSDCC and Ace It Academy will not be responsible for equipment left overnight.
7. A judge officiating at a trial shall not be subject to indignities of any kind during the progress of the trials and it is the duty and obligation of the trial-giving club to see that this rule is effectively carried out. (Dog Show Rules, Sec. 4.1.3)
8. No person may approach a judge, either directly or otherwise, orally or in writing, to favour their entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act. (Dog Show Rules Sec. 4.1.6)
- 9. Bitches in season** shall not be eligible to enter the trial (please see refunds/duplicate entries - #10 General Information).
- 10 There will be no refunds on duplicate entries or overpayments:** Entry fees will be refunded when a bitch entered in the Rally Obedience trials comes into season after the close of entries, if a Veterinarian's Certificate (certifying that the bitch was in season within the 10-day period preceding the trial) is delivered to the Trial Secretary before the starting date and time of the trial.
- 11 Crating for the trials will be in a room adjacent to the ring. There will be no crating in the trialling room.
12. The rally ring size is 40' x 60'
