GENERAL INFORMATION:

Please NOTE the email address for entries and payment– northgowerdogclub@gmail.com

Eligibility to Compete - To be eligible to compete in these trials, the dog must be:

- a) Registered with the CKC or;
- b) Have an Event Registration Number (ERN) or;
- c) Have a Temporary Competition Number, and must be eligible for registration with the CKC.

The entry of a dog that is improperly entered in a class for which it is not eligible cannot be altered to another class after entries close except as outlined here:

a) Exhibitors incorrectly entered in the A class are permitted to move the dog to the corresponding B or C class up to one hour before the start of the trial. b) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial. c) Exhibitor entered in the Open H classes are permitted to move to the Open 18 classes and vice versa up to one hour before the start of the trial. 6.9.8 d) Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.

Bitches in season - Bitches in season are not permitted to compete under C.K.C. Rules. We will refund all entry and listing fees if a bitch comes into season after closing date, upon presentation of a veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trials. This certificate must be delivered to or reach the Trial Secretary before the trial commences.

Rally Obedience Classes offered - All regular classes will be offered (Rally Novice A & B; Rally Intermediate; Rally Advanced A & B and Rally Excellent A & B and Master).

Rally Obedience Prize List - Flat ribbons will be available on a table for all qualifying scores, upon exit of the ring. Rosettes for Titles will be available.

Important Notice to Rally Obedience Exhibitors - There is no limitation on the number of trials at which a dog may be entered as a 'listed dog', except that a dog which has obtained three qualifying scores at obedience trials held under C.K.C. rules, may not continue to compete at licensed obedience trials held under the Club's rules until the dog is registered individually with the C.K.C. Foreign born and owned dogs, please refer to Event Registration Number (ERN) information listed elsewhere.

Rally Obedience Trial Rules and Regulations - The Exhibitor is responsible for knowing and complying with the Rally Obedience Rules and Regulations of the Canadian Kennel Club. Section 20.7 of the Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an Obedience or Rally Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indication that this has occurred.

If the entry has no CKC individual registration number, an E.R.N. or a P.E.N. is required and must appear on the entry form. A listing fee of \$11.30 per entry is also required.

CKC Non-Member Participation Fee / Non-member participation fee - An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. The Premium List must carry a note stating that “these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

From the West: HWY-401 E toward **Cornwall**. Merge onto **HWY- 416 N** via **exit 721A** toward **Kemptville/Ottawa**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. Turn right on to Fourth Line Road and in 8km you will reach the destination - 6361 Fourth Line Road. **From the East: HWY- 401 W** toward **Kingston**. Merge onto **HWY-16 N** via **exit 721** toward **HWY- 416 N/Kemptville/Ottawa/RTE-416 N**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. COVID-19 General Required Practices @ Dog Ranch Inc/North Gower Dog Club

1. All individuals, judges and exhibitors are required to follow Federal, Provincial, Local and facility laws/rules. Any change in guidelines between the posting of this premium List and the starting of the trial will also be followed.
1. YOU WILL BE ASKED FOR PROOF OF 2ND VACCINATION PRIOR TO ENTRY INTO THE TRIAL VENUE. DO NOT FORWARD YOUR VACCINATION PROOF PRIOR TO BEING ASKED.
2. Social distancing must be practiced. Maintain a distance of 6 feet / 2 Metres or more.
3. Masks are required.
4. There will be hand sanitizer available around the facility for personal use and sanitizers will be provided in the porta-potty area.
5. You may bench your dogs in your vehicle if you wish ensuring you bring proper shade, ventilation, and water for your dogs. Crating indoors MAY be an option and will be communicated prior to the event date. This will depend on number of entries/exhibitors.

General Information applicable to all participants

1. Each trial has been limited to 40 registrants. **Please note that there are limited spots for Trial 1. If you are considering to enter Trial 1 and 2, please double-check with the secretary prior to completion of your entry and sending fees.**
2. Score sheets may be available immediately after your run or placed on a table shortly thereafter.
3. Your Q ribbon will be available immediately after your run. Title ribbons will be available.
4. The running order will allow you to run your class in a limited-time onsite manner. i.e. Novice classes may be run in the morning and the remainder in the afternoon or vice-versa.

Trial Practices for the NGDC

1. Each exhibitor will provide a completed waiver of liability for North Gower Dog Club and Dog Ranch Inc. Waivers will be given to the trial secretary as part of your entry at check-in. No one will be allowed to participate who has not completed the required waiver.
2. Anyone exhibiting COVID symptoms will be asked to leave the trial premise and will not be allowed to return. No refund will be issued.
3. Please carefully read the CKC's recommended COVID obedience and rally obedience protocols document carefully.
3. It is required that all exhibitors wear a mask.
4. The running order board will be available outside and near the ring for exhibitors to indicate they are present and running in the class. A steward will mark you as present and make any run order changes that are needed.
5. Exhibitors will remove and retrieve their own leashes. A chair or other object will be placed in the ring for the leash.
6. MAINTAIN 6 Feet / 2 Metre SPACING at all times.
7. Equipment will be minimally handled.
8. You will be scheduled for your arrival time/trial time, by class. You will be notified via email of this, one week prior to the trials.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/ COVID-19
