# **Directions to Trial Site**

From Calgary:

Take **#2** South, then head West on **#3**, then head South on **#6** -Pincher Creek. You will be skirting the edges of town so be sure that when you come to the traffic circle you go <sup>3</sup>/<sub>4</sub> of the way around that will keep you on **#6**. At the traffic lights, there is only one set, take an odometer reading as it is **16.5 K on #6 South** to the turnoff. You will be going South toward Waterton Lakes National Park. You will be turning west (right) onto **Township Road 45 - A**. It is a gravel road. Follow for **2k**. As you come over the hill you will see the farm. If you go under a train trestle you have gone too far! Turn around come North and take the first turn to the west (left). We have a lot of deer, elk and moose in this area so watch for them when driving from Pincher Creek to the farm please. I will have bright orange Cardigan's marking the trail from the highway.
