## Mary Woodward

1930 – 2021



Farewell Mary, from your many friends at the Alberta Kennel Club

Mary was born on July 5, 1930 in Okotoks, AB.

She will be remembered for her sense of humor and determination in life.

Mary and her husband Charlie were active members of the Alberta Kennel Club since the early 1960s. Mary would soon become the voice and face of AKC as Chair of the Judges' Committee as the Club invited new judges from all parts of the world. Mary's idea was "invite them and they will come", and come they did. Many not knowing where Calgary was until they looked it up on a map. Mary enlisted Charlie as Hospitality and Transportation representative. Joe Fleming came on board to present White Hats and acted as liaison with the ever-growing judging panels. Shows were growing larger and larger.

Mary was elected treasurer of the AKC at about the same time she became Judges' Chair. She had a firm hand of fiscal restraint on all parts of AKC. Many of the Club traditions of Western Hospitality began in the 1970's instituted by the Woodwards. Some people become the soul and glue that holds a club together; for the AKC, that person was Mary Woodward. After retiring from her position as supervisor at Trans Alta Utilities, Mary still had a full-time job devoting endless hours to each and every show that the AKC hosted. She taught the group known as the Alberta Kennel Club Show Secretaries well and they ran their own shows for years. When Mary finally retired as an active member of the AKC, it took more than one volunteer to match her contribution.

Mary and Charlie bred and exhibited white Standard and Miniature Poodles under the Marichar prefix. Mary did the grooming and ring presentation was handled by Charlie at local shows beginning with the unforgettable "Oliver" from Alekai Standard Poodles. Oliver was a delight and a true show dog, winning Groups and Best in Shows on both sides of the 49<sup>th</sup> parallel. Such was the Woodward's influence in the poodle ring that, at a show, a small but noticeable error in the body coat pattern on their dog appeared overnight on both competing Specials! How hard it was to keep a straight face.

# Susan Marie Badick

December 1943 – May 2021



Interested in dogs from an early age, Susan won the Alberta Kennel Club Junior Handling Championship in 1958. The breeds she has shown in the conformation ring include: Labrador Retrievers, Pembroke Welsh Corgis, Scottish Terriers, Salukis, All Dachshund varieties, and Whippets.

For forty years, Susan worked at the University of Calgary retiring from Library Acquisitions and everyone in the library knew Sue. After retirement in December, 2004, she was able to dedicate even more time to her passion - dogs. She bred and showed many champion wire-haired mini dachshunds and co-bred whippets with her daughter Carla, under the registered name Nasusa.

Together, Carla and Susan started the Stampede City Whippet Club. Susan was a founding member of the Alberta Sporting Hound Association.

She was involved for thirty years in the Alberta Kennel Club and was informally known as one of the "Three Mary's" along with Mary Woodward and Mary Driscoll. Formidable ladies, all.

She acted show secretary for many clubs, was a valued member of the DogShow team, and also traveled internationally as an All-Breed Judge and mentor to many.

Gaye Sjoberg, a friend of Susan and her daughter Carla, remembers Susan:

Many in the dog show world have already heard the incredibly sad news that our dear friend Susan Badick left us suddenly on May 24. Susan - of the CKC Kennel Nasusa, Perm. Reg'd, mini wire-haired dachshunds and whippets; the whippets co-bred with her daughter Carla Badick.

A mutual friend had recently remarked, "If you're in whippets and don't know who Susan Badick is, then you haven't done your research. You're not really in whippets."

Susan WAS "dog show", show secretary for so many clubs, her work impeccable. A highly respected all-breed judge for over 40 years, her assignments took her around the world. She had many struggles over the past 15 years, including the deaths of both her children, yet kept moving forward.

Sue, your knowledge was vast, opinions often known, judging highly respected, mentorship coveted. You treated me like family for 30 years - most often in a good way - and for that I am eternally grateful. I will miss our movie outings, drives to events, conversations in your living room and delicious holiday meals expertly prepared. When you had had enough of the tomfoolery, your "Get out!" was always followed by, "I love you!". I think I'll miss that the most.

RIP my surrogate mom. Thank you for so many years of love and advice. You have left behind a legacy in the dog fancy world and a massive hole in the hearts of so many. We can only imagine the incredible reunions at the rainbow bridge. Until we meet again .... Godspeed.

## IMPORTANT INFORMATION REGARDING THIS SHOW

The Alberta Kennel Club is pleased to welcome you to our 2021 Summer Classic, redefined for the circumstances that we presently face as a community.

**THIS INFORMATION WILL BE AMENDED AS DIRECTIVES ARE RECEIVED FROM ALBERTA HEALTH SERVICES.**

**Updates will be included in the Judging Schedule**

By entering the AKC Shows you are agreeing to the regulations that have been designed to keep us safe while together. The requirements are non-negotiable and will be strictly enforced. If you have personal objections to our restrictions which are based on the most current guidelines from Alberta Health Services, then please do not enter this show. Any breach of the requirements will result in dismissal from the show with no right of entry fee refund.

There will be a PHOTOGRAPHER at this show they will have their own COVID-19 Protocols in place.

### COVID-19 WAIVER/DISCLAIMER

- Chief Medical Officer of Health order 05-2020: 2020 COVID-19 response legally obligates any person who has the following core symptoms of cough, fever, shortness of breath, runny nose, or sore throat (that is not related to a pre-existing illness or health condition) to be in isolation for 10 days from the start of symptoms, or until symptoms resolve, whichever takes longer, or they receive a negative COVID-19 test.
- If they are exhibiting any of these symptoms, it is suggested they complete the COVID-19 Self-Assessment online tool to determine if they should be tested.
- If you exhibit any of these symptoms or the symptoms on the COVID-19 Assessment Tool, you will NOT be allowed to attend the show. If you feel unwell at all, you must not attend the show.
- The AKC COVID-19 waiver/disclaimer must be signed and presented your first day at the show. The daily health screening questionnaire found in this Premium List will be required EACH DAY you are entered in the show.
- When you arrive for the first time, please fill out the WAIVER/DISCLAIMER, in this Premium List and bring it to the Screening Station. Do not wait until just before you need to be in the ring with your dog, to be screened and get your wristband for the day. The AKC volunteers are not responsible for poor timing on your part and the COVID-19 Screening will take priority over everything else. Abusive language or behavior will not be tolerated.

### THE SHOW GROUNDS

- There will be signs indicating Entrance and Exits of the official Show Grounds.
- All entrances will have Screening Stations.
- There will be hand sanitizing stations provided in all areas.
- Porta-potties will be situated on the grounds with hand sanitizing stations.
- There will be NO lost and found.
- Judges' tables and other touch surfaces will be sanitized regularly.

### MASKS

- Masks are mandatory at all times while in the ring and on the show precincts. Masks must be worn completely covering both mouth and nose.
- Face shields, neck warmers, masks with exhalation valves, handkerchiefs and any other loose fitting face coverings are NOT masks and are not recommended by Alberta Health Services. Face Shields are acceptable only when the exhibitor has a medical exception letter.



- Anyone unable to wear a mask due to a medical condition will require a medical exception letter from an authorized health professional. You must be able to show the letter at the Screening Station.
  - The medical exception letter must come from a nurse practitioner, physician or psychologist.
  - The medical exception letter may be presented when in a public setting if requested by enforcement officials, or retrospectively in court if a ticket is issued.

- If you do not bring a mask, one will be provided for you at a cost.

## SOCIAL DISTANCING

- Maintain SOCIAL DISTANCING (6 feet) while at the show venue. We are providing extra space in the rings to maintain these distances so you do not encroach upon the person in front of you, be respectful.
- There will be a staging area for each group, do NOT encroach on other areas or rings.
- Due to COVID-19 protocols, there will be a maximum number of people allowed at each one of the show fields at one time.
- No hugging or handshaking permitted on any of the official grounds of the show

## WRIST BANDS

- Every day, before you can enter the show venue, you will fill out the COVID-19 Assessment Tool located in this Premium List and bring it to the Screening Station. At this time, **please present your DogShow receipt which confirms your entry & arm-band number** (on an electronic device or printed by you).
- Upon acceptance, an AKC volunteer will give you a wristband and watch you place the wristband on your wrist. The wristband is ONLY GOOD for one day. The COVID-19 Screening can be done at any time throughout the day, at any Screening station.
- You will need to show your wristband to the ring steward along with your arm-band before you can enter the show ring with your dog.
- The AKC will refuse entry into the show precincts and rings to anyone without a wristband.
- Each exhibitor will receive a maximum of ONE wristband only per entry. NO replacement wrist bands will be issued.

## SHOWING / TRIALING

- Exhibitors should arrive on the grounds ONE HOUR prior to their scheduled show/trial time and allow time for COVID-19 screening. **The COVID-19 screening stations will be open one hour before show time.**
- Once screened, stay outside your designated field until 15 minutes before the posted show time for your breed.
- 15 minutes prior to your breed judging, go directly to your staging area and stay there until your breed is called into the ring.
- **No X-pens, floor mats or tables will be allowed at ringside or in the holding areas.**
- Once you have finished showing your breed, you will be required to leave the show field promptly if you have no other dogs to show within the next 15 minutes.
- You may return 15 minutes before your next breed or Group judging, etc.
- If you are unable to attend/exhibit due to COVID-19 or any other ailment, it is your responsibility to find an alternative handler for your dog, if you wish your dog to participate.

## BENCHING

- **There will be benching available (please see pg 32).** If you are showing more than one dog you may bring a crate to a holding area to confine your dogs while you wait for your next ring time. This crate must be removed immediately upon completion of your breed judging.

## **BATHING FACILITIES**

- The wash bay will only be available in 15-minute intervals. There will be a sign-up sheet at the entrance to the bays.

## **FOOD**

You will not be able to eat in the building. The concession may or may not be operating. To be determined whether if there will be food trucks available if the concession is closed.

## **REFUND POLICY**

- If the Alberta Kennel Club is required to CANCEL the show due to any Alberta Government, City of Calgary or Canadian Kennel Club guidelines, policies, or directives, a partial refund of entry fees (less our unrecoverable costs) will be offered; payments for merchandise (RV Parking, on-site benching, and E-catalogues) will be fully refunded. All DogShow.ca service fees are not refundable.
- If you are refused entry due to you not passing the COVID-19 Assessment Tool- Daily Screening Questionnaire, you will not be given a refund.
- If you cannot travel to the show due to a government restriction on travel, entry fees will not be refunded.
- Credit card and Dogshow.ca charges will not be refunded (DogShow.ca policy)

Violation of any of these rules and procedures will result in your entries for the weekend being cancelled with NO refund of entry fees.

There will be NO EXCEPTIONS AND NO EXCUSES.

Be respectful to each other, the AKC volunteers and let us keep each other safe.

If you have personal objections to or feel unable to comply with our restrictions which are based on the most current guidelines from Alberta Health Services, then please do not enter this show.

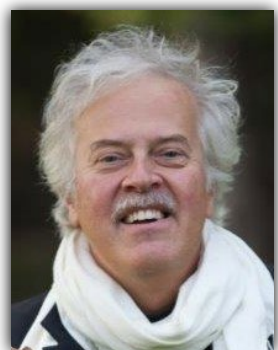
**Yvonne Savard**

The Alberta Kennel Club will not allow the use of spike or pinch collars on its show grounds.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

### ***MOVING A CLASS DOG TO SPECIALS***

A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a championship in accordance with these rules but at the time of closing of entries for the show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner/handler at least one (1) hour prior to the opening of the show. When one or more all-breed championship shows and/or specialty shows are held on the same date in the same venue, the request for moving of class dogs to specials must be made a minimum of one (1) hour prior to the scheduled start of the show for which the dog is being moved up to.

### ***ATTENTION FOREIGN EXHIBITORS***

#### **EVENT REGISTRATION NUMBER**

Effective Jan/1992 all dogs that are foreign-born and foreign-owned and enter Canada for the sole purpose of entering CKC (Canadian Kennel Club) events will no longer require a CKC registration number but will require an ERN - Event Registration Number. This ERN does not register a dog with CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables a foreign-owned dog to be awarded titles by the Canadian Kennel Club. Each dog must have its own number. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/MasterCard number (expiry date, cardholder's name and signature). Provide your complete address for return of the ERN to you.

### ***Mixed Breed or Unrecognized Breed Entries in Performance Events***

Amendments have been made to the Agility, Obedience and Rally Obedience Rules & Regulations such that mixed or unrecognized breed dogs are allowed to participate in the CKC Performance Events of Agility, Obedience and Rally Obedience Trials. The amendments are effective July 1, 2014.

## Extracts From CKC Dog Show Rules

### Chapter 8 Entries and End of Show Section

**8.2.5** An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

**Section 8.3.1** Entries: Every dog entered in a Championship show must be one of the following:

- registered with the CKC,
- have an Event Registration Number,
- be eligible for registration with the CKC, or
- if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

**Section 8.4.1** Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- that if born in Canada, it is eligible for individual registration;
- that if not born in Canada, is eligible for registration in the records of the CKC.
- that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered.

**Section 8.4.2** Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

**Section 8.5.1** Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

**Section 8.5.3** No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

**Section 8.5.4** After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

**Section 8.6.1** Refusal of Entries: The authorities of any show may:

- decline to accept entries for just cause, and/or
- refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- in the case of non-acceptance, refund the fee with the reason for non-acceptance.

**Section 8.8.2** Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

**Section 8.9.1** Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

**Section 8.9.2** If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

**Section 8.9.3** When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

**Chapter 4 Judges Section 4.1.3** A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

**Section 4.1.6** No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

### Chapter 14 Disqualifying or Excusing Dogs

**Section 14.1.4** Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. Note: for information on reinstatement, see Chapter 14 Section 14.3 of the Dog Show Rules.

## Championship Points and Cancellations

**Section 15.1.1** A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

**Section 15.1.2** The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

| Dogs competing*  | 1 | 2 | 3 -5 | 6-9 | 10-12 | 13 & more |
|------------------|---|---|------|-----|-------|-----------|
| Points allocated | 0 | 1 | 2    | 3   | 4     | 5         |

\*Includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

**Section 15.1.3** If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

**Section 15.1.4** If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

**Section 15.1.5** If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

**Section 15.1.6** If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

**Section 15.1.7** The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

**Clarification:** Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

**Section 15.1.8** In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

| 5                                       | 2                 | 1                  | 1                 | 1                  |
| 4                                       | 2                 | 1                  | 1                 | 0                  |
| 3                                       | 2                 | 1                  | 0                 | 0                  |
| 2                                       | 1                 | 0                  | 0                 | 0                  |
| 1                                       | 0                 | 0                  | 0                 | 0                  |

**Section 15.1.9** A dog may not be credited with more than 5 championship points in a single show:

**Section 15.1.10** A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

**Section 15.1.11** A dog awarded Winners which also places Best in Show at an all-breed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

**Section 15.1.12** In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- earn at least 10 championship points under at least 3 judges; and,
- be individually registered in the records of the CKC or have an Event Registration Number.
- have earned at least one 2-point win either at the breed or group level.

**Section 19.7** It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred

### 15.2 Grand Champion (GCh) (47-06-12)

**Section 15.2.1** The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

**Section 15.2.2** Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship.

**Section 15.2.3** To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward.

(a) Grand Champion Point System

Points towards the Grand Champion title, at breed level, are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level:

| *Dogs Competing  | 1 | 2 | 3 to 5 | 6 to 9 | 10-12 | 13 & more |
|------------------|---|---|--------|--------|-------|-----------|
| Points Allocated | 0 | 1 | 2      | 3      | 4     | 5         |

| 5                                       | 2                | 1                 | 1                | 1                 |
| 4                                       | 2                | 1                 | 1                | 0                 |
| 3                                       | 2                | 1                 | 0                | 0                 |
| 2                                       | 1                | 0                 | 0                | 0                 |
| 1                                       | 0                | 0                 | 0                | 0                 |

Best in Show (5 points)

(b) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

### 15.3 Grand Champion Excellent (GChEx) (48-06-12)

**Section 15.3.1** The title of Grand Champion Excellent may only be earned after the completion of the CKC grand championship title.

**Section 15.3.2** Points for this title may be accumulated at any time after the completion of the CKC grand championship but does not include the points earned in attaining the conformation championship or the grand championship.

**Section 15.3.3** A minimum of 100 points, which must include one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed) plus three (3) Group 1st or three (3) breed specialty wins.

Grand Champion Excellent point system

| Win  | Points |
|--|--------|
| First in Group or Best in Specialty Show   | 5      |
| Second in Group or Best of Opposite Single-Breed Specialty Show                                  | 4      |
| Third in Group   | 3      |
| Fourth in Group<br>(Note: No points are acquired if no other dog is present in the group.)       | 2      |
| Best of Breed<br>(To earn the breed point, at least five (5) dogs must be shown at breed level.) | 1      |
| Best in Show or Best in National Specialty Show  | 10     |

**Section 15.3.4** Only the highest points earned at a single show are carried forward. For example, a dog that wins first in group and then wins Best in Show, earns 10 points, not 15.

**Section 15.3.5** The title of Grand Champion Excellent shall not be awarded retroactively. However, dogs that have been awarded the Grand Champion title prior to January 1, 2013, will be awarded the Grand Champion Excellent title on application to the CKC.

#### Section 15.3.6 Additional Requirements

To attain a Grand Champion Excellent title, a dog must have been awarded a CKC performance title from any CKC event. A CGN, Herding Tested certificate or Chase Ability Program title are not considered performance titles for the awarding of this title.

## CKC Update Re: New Grand Championship Levels

### Grandfathering of GCh. and GChEx. Points

Did your dog earn its Grand Championship but since then has been sitting at home acting like a couch potato? It's time to start getting back into competition shape!

Thanks to our members' fantastic feedback, effective July 1<sup>st</sup>, 2021, we're adding three additional Grand Championship title levels: Bronze, Silver & Gold.

- **Grand Champion Bronze:** Awarded after an additional 50 points are earned after completing a Grand Championship and other qualifiers.

- **Grand Champion Gold:** Awarded after an additional 200 points are earned after completing a Grand Championship Silver and other qualifiers.

Competitors can begin to earn points for these new titles after July 1<sup>st</sup>, 2021. **Have you already earned additional Grand Champion Points? Those can be used towards your Grand Champion Bronze title; however, you must earn a minimum of 5 points towards this title after July 1<sup>st</sup>, 2021.**

We've also **improved the Grand Champion Excellent title.**

- **Grand Champion Excellence:** awarded after achieving a Grand Champion Silver Title, a Best in Show or Best of Breed win at a National Specialty (minimum number of dogs required to be competing), 3 Group 1<sup>st</sup>'s or 3 Best of Breed Specialty Wins, as well as a CKC Performance Title (excluding any instinct level titles, Sprinter, Chase Ability, Herding Novice or CGN).

With the new version of the Grand Champion Excellent title, no additional points are required to be counted. You can find more information on the upcoming changes in the July 1<sup>st</sup>, 2021 version of the Conformation Show Rules and Regulations.

*Don't worry!* For those **currently working towards a Grand Champion Excellent title, the current qualifications will still be honored until July 1<sup>st</sup>, 2022** (this date is subject to review based on COVID-19 restrictions). 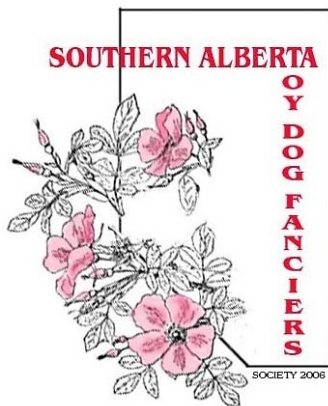
