ELIGIBLE ENTRY

The trials are open to the following breeds Afghan Hound, Azawakh, Basenji, Borzoi, Greyhound, Ibizan Hound, Italian Greyhound, Irish Wolfhound, Pharaoh Hound, Rhodesian Ridgeback, Saluki, Scottish Deerhound or Whippet that is one year of age or older on the date of the trial. Dogs eligible for individual registration or an ERN that are breeds designated as Sighthounds are eligible to enter, provided they have a Temporary Competition Number (TCN)

All entrants must

- (a) be individually registered with the CKC (have a CKC registration number),
- (b) have an Event Registration Number (ERN),
- (c) have a Performance Event Number (PEN),
- (d) be eligible for registration with the CKC

Hounds with breed disqualifications, altered or neutered are eligible to enter the lure coursing field trial. Hounds presently disqualified under CKC, AKC or ASFA coursing rules are ineligible for the Open Stake.

IMPORTANT NOTICE

Hounds entering their first trial in Canada must be tested with another dog of the same breed or a breed with a similar running style (preferrable not a kennel mate) and certified running clean by a licensed judge (R & R 7.1.1 a). The CKC Hound Certification form, available from the Trial Secretary must be completed and submitted with the entry at the hound's first trial. Hounds with the following are exempt ASFA (FCh or LCM), AKC (QS, SC or DC), BUT are still required to submit the Hound Certification form at their first Canadian trial with their name and exempt title(s) circled.

RUNNING ORDER Dogs will be run by breed in alphabetical order on Saturday and reverse alphabetical order on Sunday. Mixed stakes will be run at the end. The running order is subject to change by the judges if this makes the running more efficient. Official Singles run last on Sunday.

Puppy runs will be run after all other runs on Saturday.

BITCHES IN SEASON shall not be eligible to enter a field trial.

STAKES OFFERED

Open: All hounds, including Field Champions.

Mixed: Multiple breeds with entries of three or less, with the owners' agreement.

Single Stake (Official, considered a regular stake): CKC points awarded. Limit 5 entries **Best In Field held on Sunday:** Best of Breed (BOB) winners and Mixed Stake winners eligible from both Saturday and Sunday may compete (no points toward titles) at the end of Sunday trial.

Puppy Stake: Offered on Saturday and limit 5 dogs only. This is open to dogs aged 6 to 18 months on the day of the event.

Kennel Stake: Saturday only, determined by a tally of scores. This is open to any 2 hounds entered in the regular stakes owned and kenneled by the same person. Total of scores earned in the regular stake shall determine the winner.

Breeder Stake: Sunday only, determined by a tally of scores.

Stakes are defined in section 9.1 of the rulebook.

Note: R & R 7.1.1 (d) Any dog in competitive singles is not required to be certified and 9.1.2 (f) A hound entered in the official (regular) single stake (Sunday only) shall be barred from competition in the Open or Veteran stakes at the same trial.

RIBBONS AND PRIZES

Ribbons will be offered for all placements First place through to Next Best Qualified (NBQ). Rosettes and/or Prizes will be awarded to BOB winners and First in Mixed Stake, and to the Best In Field, Kennel Stake and Breeder Stake winners.


LURE FIELD TRIALCHAMPIONSHIP POINTS


Per CKC Lure Field Trial Rules & Regulations, Chapter 9, Section 5.1

First place – four X number competing to a maximum of 40 points. Second place - three X number competing to a maximum of 30 points. Third place - two X number competing to a maximum of 20 points. Fourth place - one X the number competing to a maximum of 10 points. NBQ - no points awarded.

COURSE PLANS

Drawings are not to scale and may be altered due to weather or field conditions.





ADDITIONAL INFORMATION

- These trials will be run rain or shine.
- Hounds not present at Roll Call will be scratched and entry fee not refunded. Bitches in season and lame hounds will have their entry refunded provided notice is given at or before Roll Call.
 The Club requests all competitors or spectators NOT to bring a bitch in season onto the grounds.
- R & R 9.2.6 Roll Call may be conducted before running of the text dog at the discretion of the
- Stakes will be split if the entry in any breed reaches 20 or more at Roll Call.
- All handlers must use a slip lead when releasing their hounds. Hounds may wear muzzles and/or catch collars at their owners' discretion.
- Leg wraps must be in neutral colours.
- Do not release your hound before the "T" in "Tally-ho" or the dog may be assessed a pre-slip penalty of between 1 and 10 points for that run by each judge.
- Please pick up after your hound. Dog bags available at Trial Secretary Table. We want to
 leave the farm field the way we received it so we are invited to use in the future. \$10 fine if you
 fail to pick up after your hound.
- Please properly dispose of your trash (e.g. cigarette butts, dog poop) As courtesy to those who
 transport all trial equipment and garbage cans, please do not let your dog mark on the garbage
 cans.
- Bitches in season or lame hounds will have their entry fee refunded provided that notice is given at or before Roll Call.
- Hounds not present at Roll Call will be scratched. Entry fee will not be refunded.
- All dogs must be under control, on a leash except while running in the field coursing.
- A \$10 fee will be charged to owner/handler for any loose hound on the farm property.
- Flexi leads will not be allowed on the trial grounds.
- A portable toilet will be provided but there will be no running water on site. Bring water for yourself and your hounds.
- Bring your own shade/rain tents for cover.
- Please park in designated areas as directed by Club or Trial Executive. We want to minimize field damage.

IMPORTANT

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. CKC REGULATION It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

TRIAL SITE: No food available on site. Be prepared: bring food, water, and shelter for you and your dogs. Wear appropriate footwear for traction and protection. Only park where Club Trial Executive indicate exhibitors can park.

COVID 19 PROTOCOLS

Please, let's keep everyone safe!

The following protocols align with guidelines and orders from the BC Provincial Health Office. As the protective measures have been somewhat lifted, we urge you to continue to take care, wear masks if you wish, and abide by the rules - not everyone is fully vaccinated!

- Anyone who identifies as having symptoms, been out of the country within 14
 days, testing positive or having been in proximity with someone testing positive
 will be given a refund and will not be allowed to attend the event.
- Handlers will receive a refund of entry fees if this event is cancelled due to changes to BC Provincial Health Officers orders or guidelines in effect closer to the event.
- Everyone arriving at the event will check in before proceeding to the field.
- Spectators, other than those coming with handlers to help with dogs are not encouraged to attend, in order to keep the numbers down.
- Continue to be aware of Social Distancing. Handlers need not approach volunteers (e.g. lure operator, huntmaster, field clerk, secretary)
- Handlers will check their own bitches for being in season and show the tissue to the inspection team.
- Judges and field clerks may choose to wear masks.
- Dogs will be released as usual. Handlers may wear masks when releasing and catching their dogs.
- A portable toilet with a hand washing station will be available. Handlers are encouraged to bring their own hand sanitizers.
