

DARTMOUTH KENNEL CLUB JUDGING SCHEDULE

SATURDAY, May 12, SUNDAY, May 13, 2012

- Judging will start promptly and adhere as closely as possible to this schedule.
- Handlers of several different breeds **must** arrange for alternate handlers, should judging of their different Breeds conflict. **Schedule changes will not be made.**
- It is the responsibility of the exhibitor to be at ringside when their classes are called. It is not the responsibility of the ring steward to locate dogs. **Judges will not wait for any dog or handler delaying a class.**
- Group judging will follow **immediately** upon completion of the breed judging within each group.
- The figures following the Breeds indicate the number of dogs entered in - (1) Male Classes, (2) Female Classes, (3) Specials Only, Male & Female, (4) Total in Breed and (5) Exhibition Only.
- Time for Conformation Judging is based on 20 - 25 dogs per hour. Obedience Judging is based on: Utility - 6 dogs/hour, Open - 7 dogs/hour, Novice A, B, C & Intermediate - 8 dogs/hour & Pre-Novice – 9 dogs/hour. Rally judging is based on 20 dogs/hour plus 10 min walk through time.
- **Junior handling** will be held on Saturday. A fee of \$2.00 is required for junior handling at time of registration. **Registration will be from 9:00 am to 11:00 am.**
- Due to space restrictions at the show venue site X- Pens will be limited to exhibitors/agents with 4 or more dogs entered at the maximum number of 1 xpen/4 dogs. This will be strictly enforced by the DKC Show Superintendent. Thank you for your co-operation.

CLEANUP: All exhibitors will be held responsible for clean-up on the show site and surrounding areas for their own dogs or dogs they are handling. Anyone caught not cleaning up after their dogs WILL BE PROHIBITED FROM SHOWING OR TRIALING their dog or dogs at this event.

THE BUILDING WILL OPEN AT 6:30 EACH DAY AND WILL CLOSE 1 HOUR AFTER BEST IN SHOW JUDGING. SETUP TIME FOR EXHIBITORS WILL BE FRIDAY, 3:00 to 8:00 PM
