Two-day Herding Clinic on sheep. This clinic is designed for dog and handler teams who have previous experience with working sheep and are participating in herding trials.

Fee: \$375 per dog and handler for two days. Lunch and snacks provided. The clinic is limited to 8 dog and handler teams. Auditing will be available on clinic days for a cost of \$75 per person for one day, \$100 for two days or \$125 including the Intro Clinic. No dogs belonging to auditors will be permitted to work the stock.

Sue Jewel has been involved in herding for over 25 years. She is a CKC and AHBA Herding judge and is a member of CKC, AHBA, CBCA. Her dogs have won numerous High in Trials and Championships.
