Continue travelling north through Embro.

Turn left at Road 84, (also called Oxford County Road 16) and go west.

Property is on the southwest corner of Road 84 and the 35<sup>th</sup> Line.

Driveway is on Road 84.

If using GPS and it doesn't like "Embro", try "Zorra."

Plenty of parking available at the trial venue. No indoor crating.
