NON MEMBER PARTICIPANT FEE

(April 20, 2011)

This fee applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

- ***A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC.***
- ***The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.***
- ***In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.***
- ***These forms are available from the show secretary.***

Major Class Changes From 2012:

Pre-Novice – Deleted: Circle Left and Circle Right. Added: Figure 8. Posts to be 12 feet apart.

Novice A – The dog must be trialed by the owner/co-owner or a member of their immediate family. Only one dog per handler is allowed in this class. No person who has previously exhibited a dog that has earned a CDX title shall be allowed to handle a dog in this class. Stand for examination will be done off leash. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises.

Novice Intermediate – Drop from heel has been moved to follow Stand for Examination. Both a command and signal are allowed for the drop. Honor Exercise: removed. Replaced with Recall over the High Jump holding the Dumbbell.

Open A – Exercises will be performed in the usual order. For any dog that has earned the CD title but not a CDX title. The handler of any dog in this class must be the owner/co-owner or a member of the immediate family.

Open B – Exercises will be done in random order. Order will be posted approx 30 minutes prior to judging. Dogs which have earned the CDX title or UD must enter in the Open B class.
Dogs in this class may be handled by the owner or any other person.

Utility A – For dogs which have not earned the title of U.D. No person who has earned a MOTCH title may handle dogs in this class. The handler of any dog in this class must be the owner or a member of their immediate families. Exercise will be performed in the usual order.

Utility B – Exercises will be done in random order. Order will be posted approx 30 minutes prior to judging. Anyone, immediate family member or not, can trial a dog in the "B" classes.
A person may enter or handle more than one dog in this class. The same handler must handle each dog in all 7 exercises unless he has 2 or more dogs entered. In such case, he must have an additional handler for each extra dog when they are judged together in the Group Exercises.

Veteran dogs - at the option of the handler, may jump 3/4 of the height required for their breeds. Veteran dogs must be 7 years of age or older on the day of the trial.
