Day-of-Trial Entries:

If time permits, Day of Trial entry may be available for the Second Trial only on each event day. Completed entry forms with full payment in accordance with the fee schedule must be submitted, in person, to the Trial Secretary by the owner or handler at least sixty (60) minutes before the start of the Second Trial.

General Information for Exhibitors

In order to make everyone's visit a safe and enjoyable one, The Poodle Farm has a few rules:

- 1. No outdoor shoes allowed on the turf indoors.**
Please ensure you bring a clean, dry pair of indoor only shoes.
- Please do not arrive before 8 am.
- Indoor crating is not available. There is a warm up area inside, however you should be prepared to crate from your vehicle.
- Dogs must be on a leash at all times except when competing in the ring. No "Flexi" lines allowed on the property.
- 5. There is a facility fee of \$60.00 for any occurrence where a dog eliminates on the turf. Fee is the responsibility of the Handler.**
- Please keep your dog under control and out of other dogs 'faces', give other dogs the room they may require.
- Please pick up after your dog's waste. Please pick up after yourself. There are waste containers for your trash.
- Please do your best to keep barking to a minimum.
- No smoking, vaping or Cannabis anywhere on the property.
- Per CKC rules, only dogs officially entered are permitted within the Trial Precincts.
- Per CKC rule 6.7.3 "There shall be no intensive or abusive training of dogs within the venue of the



trial." The "venue" being the entirety of The Poodle Farm property.

12. Rally course maps will be posted outside, paper copies may be available only by request in advance.
13. Outdoor shade/rain tents may be setup on any grassy area in the event of inclement weather.

Judges are not required to wait for dogs. The Handler of each dog is solely responsible for having it ready at the ring area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of locating dogs that are not brought into the ring when required.

Please note that the Judging Schedule is accurate at the time of publication, and is intended to serve as a guideline only for estimating when each class might begin using the standard calculation as defined in the CKC rulebook. It is subject to change based on entries formally withdrawn after this publication and their replacement as well as absentees and/or additions and/or changes of class on the "day-of".
