Where: Laurelwood – 42 Col. Williams Lane, south of Bethany ON

Directions: from Toronto go east on Hwy 401 past Bowmanville – go north on Hwy 35/115 and stay on 115 after 35 splits off to Lindsay – take Rd 32/Porter Rd exit and go north towards Bethany – go right at Solanum Way to Col. Williams Lane – go to end of this short road, over private RR crossing and see # 42 – continue over bridge and follow signs to parking. Venue is about one hour from Yonge and 401. **For other directions contact Laurel.**

Eligible Dogs are all Group 4 Terriers and Miscellaneous Group Terriers (PRs), all Dachshunds, JRs and any mixed breed dog able to enter a 9” tunnel.

Our Instructors/Trainers will be our judges for our CKC Tests hosted by Victoria County Kennel Club on the following 2 days (June 22 & 23) and the following weekend June 29/30 for our North American Mixed Breed (NAMBR) Tests at this venue.
