**RULES:**

A copy of the January 1, 2024, CKC Scent Detection Trial Rules & Regulations may be obtained from the Canadian Kennel Club. It is the exhibitor's responsibility to know the rules pertaining to these events.

**REFUNDS:** No refunds will be issued for cancelling after the closing.

**IMPORTANT NOTES:**

- We will not be offering resets at this Trial. Only one dog per handler per class will be allowed.
- MKC respectfully reminds exhibitors that anyone discussing hides before the end of the Trial will be excused and asked to leave as per CKC rules.
- The only dog permitted in Trial area is dog being tested.
- Be prepared to crate from your vehicle. There will be no crating inside the building. There will be a designated parking area.
- Overnight recreational parking will be allowed in the parking lot. Lutz Mountain Heritage Museum will also offer electric hookup for \$25. Please book your RV parking with Trial Secretary Louise Richard by emailing: [oreobobo@icloud.com](mailto:oreobobo@icloud.com) before closing August 1.
- Due to space limitations, there will not be a designated spectator area at this event.
- All dogs must be under control on a leash except during the test and only if permitted by the Judge. All persons must exercise care and control of any dog in their possession.
- Please give every dog and handler space.
- No prong collars.
- The MKC reserves the right to refuse an entry subject to CKC rules.
- All entry fees must be in the hands of the Trial Secretary prior to closing date.
- **Judging Schedules and Arm Band Numbers** will be sent out by **email** a few days prior to the Trials.
- Please advise if you are bringing a bitch in season. They must run last in their class and wear clean, properly fitted panties.
- No exhibition classes will be offered.
- Dogs must be at least 6 months of age and registered with the CKC and have a registration number, or an ERN, TCN, PEN, CCN or Misc. certificate number. \*
- The Trial Superintendent will be in full charge of the event that will be governed by CKC rules.
- The Moncton Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, however MKC will not be responsible for or assume any liability in the event of accident, or other misfortunes, to either dogs, exhibitors, or patrons.
- Exhibitors will be responsible for clean up on the grounds and surrounding areas for their dogs.

- It shall be the duty and obligation of the Trial-giving club to see that a Judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Event Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- No food will be available at the venue except for the volunteers. Several fast-food outlets are located nearby.
- If it is impossible to open or to complete the event because of riot, civil disturbance, extreme weather or other acts beyond the control of the Moncton Kennel Club, no refund of entry fees or service fees will be made.

#### **Registration number:**

Every dog entered in this event must be one of the following:

- (1) Registered with the CKC
- (2) Have an Event Registration Number (ERN)
- (3) Have a Performance Event Number (PRN)
- (4) Eligible for registration with the CKC, and have a Temporary Competition Number (TCN)\*
- (5) Have a Miscellaneous Certification Number (MCN) if it belongs to a CKC listed breed
- (6) Have a Canine Companion Number (CGN)\*\*

#### **\*Temporary Competition Number (TCN): (if not CKC registered)**

Temporary Competition Number (TCN) must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for dogs that will require a Performance Event Number (PEN) or Canine Companion Number (CCN). Listed Breeds that do not yet have a Miscellaneous Class Number (MCN) number will be eligible to apply for a TCN.

There is no fee to obtain a TCN however exhibitors will still be required to pay TCN Fees (formerly called Listing Fees) when entering events using a TCN.

TCN Numbers may be obtained online via the CKC website where the number is issued instantly. Exhibitors may also mail in a printed application or contact CKC Shows and Trials by phone for a number. How to apply for a TCN Online:

#### **\*\*Non-Purebred Dogs require a CCN to complete their entry:**

These Trials are open to non-purebred dogs. If entering your non-purebred dog (includes mixed-breed and unrecognized breeds) in these Trials, your dog will be required to have a Canine Companion Number to complete the entry form.
