- **Gamblers:** Consists of 2 parts. Part 1 Dogs earn points for each obstacle performed correctly (obstacles may be performed twice successfully). Part 2 Bonus points can be earned by working away from handler through a series of obstacles, while handler stands behind a designated line.

- Standard: All obstacles must be performed in order & in the time set by the judge
- **Starters & Advanced Jumpers:** Course consists of only jumps & tunnels. Tunnels are a numbered course consisting of tunnels only.
- **Steeplechase:** Demonstrates a dog's ability to maintain a high speed while jumping, performing the A-frame and weave poles with control. The Steeplechase must incorporate at least 6 jumps, a tunnel, the A-frame, 12 weaves poles, the tire jump, and the spread jump with either the weave poles or A-frame being used twice.
