GENERAL INFORMATION AND TEST RULES

ELIGIBILITY: Purebred or mixed-breed dogs must be at least 12 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Are eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

ENTRY LIMIT: Entries will be limited to 40 runs per test.

Post (day of) test entries will NOT be accepted at this test. If the tests fill, waiting lists will be kept and dogs from the waiting list may be entered and added.

NON-MEMBER PARTICIPATION FEE: The CKC has a tracking fee for non-members. Please refer to the information about this policy on the CKC website: https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Non-Member-Participation-Fee-Form-Form-No-150-00-5

BITCHES IN SEASON: Bitches in season shall not be eligible to enter the test.

BORDER CROSSING: A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

TEST SITE: Bring water, shade and shelter for you and your dogs. These tests will be run **rain or shine**. All dogs must be under control, on a leash except during the test. **Flexi leads will not be allowed on the test site.** Remember that this is a public park used by families. Clean up after yourself and your dog.

The test site is not fenced. No dogs are allowed near the washrooms or food area. Dogs may be created in the pavilion.

Bathroom facilities and food are available on site.

REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Sprinter Test Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

CKC Regulation: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

The test will follow a Chase & Go format. Dogs will run once during each test. Two tests will run concurrently in each flight (e.g. all dogs in flight 2 will run once, in order, for Test 1. They will run again in flight 2 in order for Test 2. Handlers will then leave to make room for the next flight.

Handlers will be given an opportunity to indicate a flight preference before the running order is distributed. More instructions regarding logistics will go out to all handlers before the event.

AWARDS & PRIZES

Qualifiers will receive flat ribbons. A rosette will be awarded for new titles.



COVID 19 PROTOCOLS

The following protocols align with guidelines and orders from the BC Provincial Health Officer at the time this premium list was drafted. Please review these to ensure that you will be able to abide by them before entering the event:

- An online Covid 19 screening questionnaire will be made available ahead of time to all handlers to be completed before they are allowed down at the field. Anyone who identifies as having symptoms, been out of the country within 14 days, attended a large gathering, testing positive or having been in proximity with some testing positive will be given a refund and will not be allowed to attend the event.
- Handlers will receive a refund of entry fees if this event is cancelled due to changes to BC Provincial Health Officers orders or guidelines in effect closer to the event.
- Everyone arriving at the event will check in by the barn before proceeding to the field.
 Anyone who has not completed a Covid screening questionnaire will be questioned prior to being allowed down to the field.
- Handlers will be instructed when they may drive down to the field.
- Teams will run in flights of 10 during specific blocks of time. Handlers will run their dogs once for each test entered and leave unless they're in another flight or volunteering. Handlers will be provided with running orders ahead of time. There will be a 30 minute gap between flights to allow for the exchange of vehicles.
- Spectators, other than those coming with handlers to help catch or release dogs will not be allowed.
- Cars will be spaced out in the parking area near the field.
- Social distancing of at least 6' between people not traveling in the same vehicle will be required and enforced. Handlers will not approach volunteers (e.g. timers, photographer, huntmaster, paddock master)
- Handlers of dogs that need to be measured must wear a mask. An agility height card will be acceptable in lieu of measuring.
- Handlers will check their own bitches for being in season and show the tissue to the inspection team.
- Day of results will not be available. Results will be calculated after the event and distributed to all handlers online.
- A portable toilet with a hand washing station will be available. Handlers are encouraged to bring their own hand sanitizers.
- There will be no day-of entries.
- Ribbons will be handed out after each flight using gloves.

Anyone disobeying the rules must leave and will not receive a refund.
