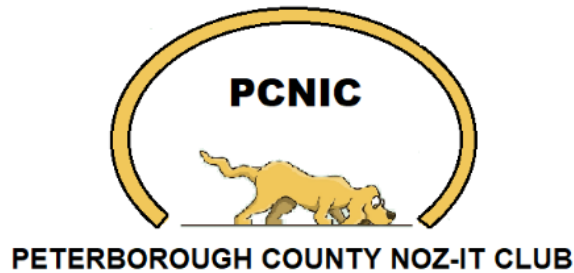

General Information

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.

To make everyone's visit a safe and enjoyable one, we have just a few rules:

- 1) Park only in the MAIN parking lot area. Please respect boundaries and roped off areas.
- 2) No indoor crating space. Please crate in your car.
- 3) No wet or muddy shoes allowed inside. Please bring a clean dry pair of indoor shoes
- 4) Dogs must always be on leash unless directed by the judge at the time of a search.
- 5) NO flexi leashes allow to be used on trial grounds
- 6) Please do your best to keep barking to a minimum
- 7) PLEASE RESPECT: Not all dogs love other dogs. Please keep your dog under control and out of other dogs' faces, even if your dog is not dog aggressive. There is NO nose-to-nose contact at this event.
- 8) Dog airing area will be posted. Do not let your dog eliminate outside of this area
- 9) Please pick up your dog's waste.
- 10) Please clean up after yourself. There are waste containers for your trash.
- 11) No smoking anywhere on the trial site.
- 12) Be kind to our judges and volunteers. Remember if you want to be treated with respect, give others the same respect

Eligibility

Scent participation is open to all purebred and mixed breed dogs at least 6 months of age that are individually registered with the CKC, or have an Event Registration Number (ERN) or a Performance Event Number (PEN) or eligible for the registration with the CKC or have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed, or have a Canine Companion Number (CCN) if it's a mixed breed.

Bitches in season

Females in season may not enter and are not allowed on the event grounds. When a bitch comes into season after the entry has closed, a veterinarian's note certifying the bitch was in season within the 10-day period preceding the event must reach the secretary on or before the start of the event. A full refund of entry fees and listing fees will be given.

EVENT

Verification that your entries have been received will be emailed to you no later than six days before the event date. PLEASE contact us prior to the event date if you have not received an emailed confirmation from us.

Scent Detection Levels Offered

Instinct, Novice, Open, Excellent and Masters (Containers, Interior and Exterior).
Limited class entries.

Element order is planned to begin at the Master Level.

Element order is subject to change based on entries. Entrants will be notified on the days schedule via email after trial closing.

Exhibitors CANNOT compete in the same component at the same level with multiple dogs.

Move ups will be permitted. MOVE UP ENTRY FORM MUST BE SUBMITTED BY END OF TRIAL 1 FOR TRIAL 2.

NOTE Instinct is an entry on its own or can be combined with Novice only. It cannot be combined with Open, Excellent or Masters levels.

CKC Non-Member Participation Fee

Non-member participation fee /TCN Number

The CKC requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

As per the CKC rules:

“If anyone is found to be discussing a search before the class has ended, both parties in the discussion (speaker and listener) will be penalized with a “Not Qualified” score (NQ) for the class. Additionally, at the discretion of the Event Committee, persons discussing a search may be excused from the trial and asked to leave the trial grounds.”

If dog is not present for assessment, a note signed by a veterinarian will be required for any refund or credit consideration. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to start or to complete this event, no refund of entry will be made.

Entries are considered complete when entry form, signed liability form and full payment is received.

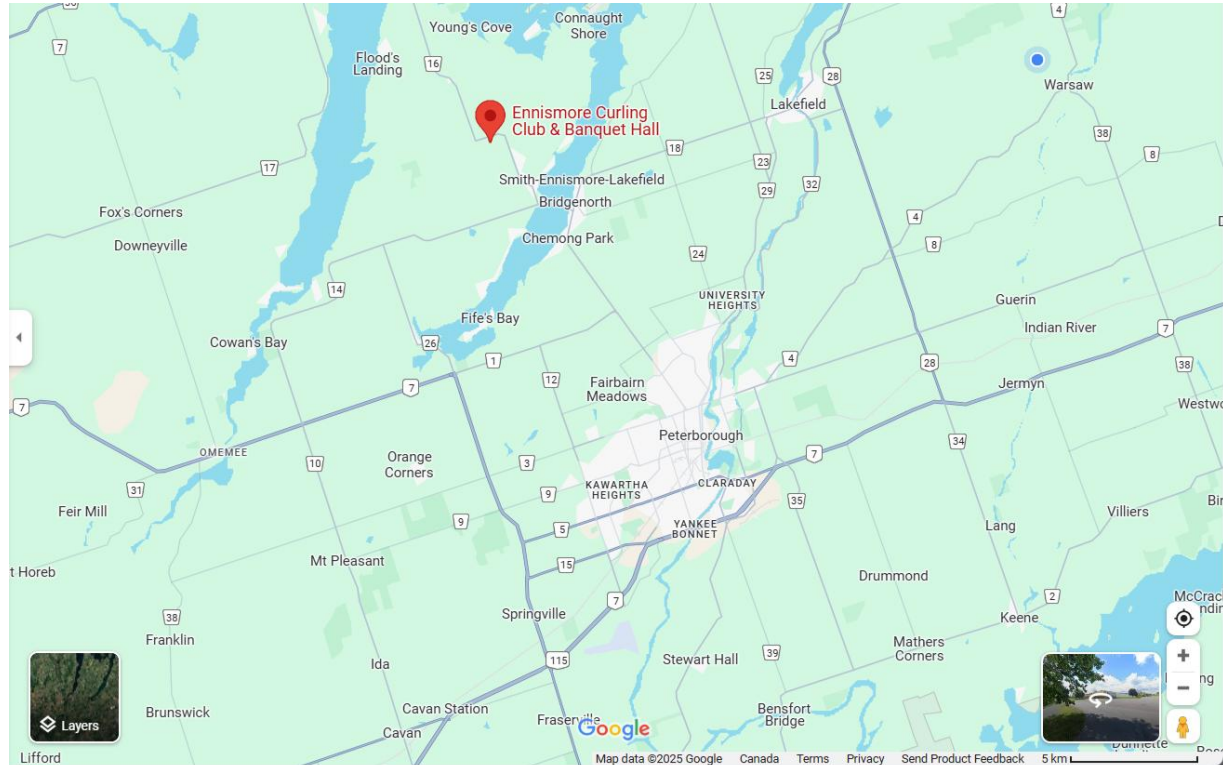
AFTER 6.3 KM, TURN RIGHT ONTO YANKEE LINE, COUNTY ROAD 14.
