Limited Entry Obedience:

Entry in each obedience trial will be limited to the capacity of the judge to judge at an hourly rate of 9 Pre-Novice dogs, 8 Novice dogs, 8 Novice Intermediate dogs, 7 Open dogs, and 6 Utility dogs. The judge will be limited to 7 hours total judging time for the day of the trial. Once the judge has reached his capacity, entries for that trial will be closed even if the closing date has not been reached. In the case of the entry limit having been reached, remaining entries will be assigned a position (by class) on a waiting list. Exhibitors will be notified of their position on the waiting list. If the entry of a bitch in season is pulled after entries are closed, it may be substituted with one from the waiting list up to and including the day of the trial. If the entry of another dog is pulled prior to the trial, it may be substituted with one from the waiting list up to 24 hours prior to the trial.

Limited Entry Rally Obedience

These events are limited entry only. Entries are limited to 40 entries per trial and/or 80 entries overall per day. A judge may not be assigned more than 7 hours of judging.

**Important Notice: Minors under the age of 16 are not permitted to enter/handle dogs at this trial. Parent or guardian signature and accompaniment is required for permitted minors under the age of 18. ### **Obedience Trials Rules and Regulations**

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club. Section 19.7 of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

### **Rally Obedience Rules & Regulations Chapter 20.7:**

*It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.*

### **Bitches in Season Rules and Regulations Chapter 6.5:**

*Bitches in Season are not permitted to compete. The judge of a trial must remove from competition any bitch in season, or any bitch which appears so attractive to males as to be a disturbing element. When a bitch comes into season after entry of the bitch has been submitted to the Trial Secretary and a Veterinarian's certificate that the bitch was in season within the ten day period preceding the trial, the Trial giving club will refund entry, service charges and listing fees.*
