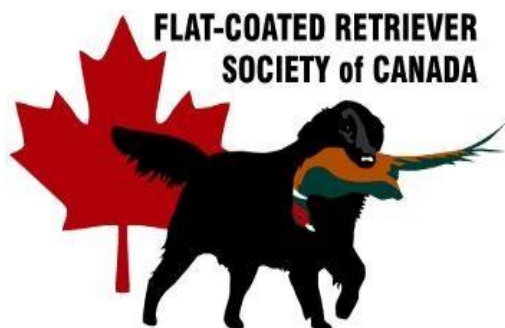

GROUNDS

Hunt Test grounds located at 161 Lundstrom Road. From show site, take Hwy 11/17 west through Kakabeka Falls for approximately 10 km. Turn right (east) on Lundstrom Rd, right at end of road.

Working Certificate grounds located at 1811 Hwy 588. From show site, take 588 for approximately 18 km to #1811.

GENERAL ENTRY INFORMATION

1. Entries will be accepted by Cash or Cheque.
2. For Canadian entries only, you may e-transfer funds to tbagilitydogs@gmail.com. Be sure to identify yourself and the dogs you are entering in the comments section of the transaction.
3. Cheques should be dated no later than the closing date. **PLEASE MAIL EARLY**, cheques are to be made out to **FC Specialty 2020**

5. ENTRIES CLOSE May 21st, 2020, NOON EST. No entries may be accepted, altered, cancelled or substituted after the official closing date and time for entries except as provided for in the rules.
6. Draw will take place at 7 pm, May 21st, 2020.
7. **A separate entry form for EACH dog in EACH stake is required (official CKC entry form).** Available **Editable** Online Entries with ability to save on your computer may be found on the CKC website under CKC Events / Forms. You may also use entry form provided here. Non-CKC members please read note below.
8. All entries must be accompanied by the entry fee, and Temporary Competition Number TCN fee of \$11.30, if applicable. A TCN number is required for all owners of unregistered, recognized breeds entering events. A TCN number replaces "listed dogs", and must be obtained PRIOR to submitting an entry.
9. **NO PHONE OR FAX ENTRIES WILL BE ACCEPTED.**
10. **Note to All Canadian Residents Only CKC Rule:** Non-member participation fee, for awards and titles will be charged to a Canadian non-member of CKC. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
11. Lunch facilities will not be available on site, so bring your own food.
12. Day of Entries accepted up until 8 am prior to the commencement of the tests. Each stake will cost an additional \$5.00 over standard cost, for day off entries.

AWARDS

Standard CKC Rosettes and a prize will also be provided for all qualifying dogs in each event.

SCRATCHES

Scratches for a bitch in season shall be refunded in full. All other scratches will be refunded at the test committee's discretion, other than a scratch fee of \$10.00. Prior to paying such a refund, the club may require an appropriate veterinary certificate. Refunds must be requested in writing to the Test Secretary prior to the start of the test event, explaining the reason for the scratch.

Release and indemnification of Landowners and the FCRSC
