## Discipline re Indignities

As per CKC rules and regulations, it shall be the duty of the test-giving club to see that a judge, club official, steward, volunteer or competitor at a Draft Dog test is not subject to indignities. The Draft Dog Test Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

## AS A REMINDER:

No dog may be brought onto the grounds or premises of an event if it:

1. Is known to have distemper, parvovirus, kennel cough or other communicable diseases.
2. Has recovered from distemper, parvovirus, kennel cough or other communicable disease with the last 30 days prior to the event.
3. Has been housed within 30 days prior to the event on premises on which any of the above existed.

Clubs have the right to remove a dog from the event premises and the exhibitor may face disciplinary action if it is found that CKC rules have been contravened.

A dog that bites or attempts to bite another dog or a person may be removed from the event grounds or premises for the duration of the event by the Draft Dog Test Committee Chair. Please ensure that your dog is under control at all times. Please, no flexi-leads on the test grounds, leashes should be no longer than 6 feet.

If a combination of DDX/BDDX entries has not been received by the closing date these openings may be filled with additional DD/BDD entries. **Entry fees will not be refunded after the closing date.** If the limit is reached prior to closing date, a list of alternates will be kept to fill any vacancies created due to early (prior to closing) cancellations. Entry fees will be refunded within 10 days following the test to all withdrawals replaced by an alternate and to all alternates that did not participate in the test. Email confirmation of receipt of entry will be provided to entrants who provide a valid, legible email address on their entry form.

**Foreign born/ owned dogs:**

A dog not individually registered with the CKC may be entered at a test held under these regulations as a "Listed" dog, provided it has an event registration number (ERN) or obtains this from the CKC within 30 days of the first test entered otherwise scores will be cancelled. **Non-member Participation Fee:**

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

**If travelling from the east on Hwy. 401, QEW, or 403**

- Take Hwy 407 W/Express Toll Route/ON-407 W and ON-403 W to **Rest Acres Rd/ON-24 S** in Brant. **Take exit 27** from ON-403 W (about 48 min/86.7 km)
- Continue on ON-24 S. Take Brantford Rd/Regional Rd 4 to ON-3 W through Delhi.
- Quance Park will be on your left. (you will see the Tobacco Museum) Go down the hill.

**If travelling from the west on Hwy 401**

- 401 E to Plank Line/ON-19 S to Ostrander Rd/County Rd 19 in South-West Oxford
- Continue on County Rd 19. Take Potters Rd/County Rd 37 to Oxford 59 S in Norwich
- Turn right onto Oxford 59 S.
- Turn left onto Talbot Rd/On-3E.
- Just over the bridge

## General Information and Test Rules:

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing.

Copies of the CKC Draft Test Regulations are available from the Canadian Kennel Club (Tel: 416-675-5511)

*As per the Draft Dog Test Rules and Regulations, the group option as stated in section 11.2, may be offered at this test.*

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Test Secretary after the official closing date as published in the premium list or after the maximum number of entries has been received.

No Entry will be accepted unless all particulars called for on the Entry form is shown thereon. Incomplete entries will be returned.

No Entry will be accepted unless accompanied by the entry fee.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.

Cancellations of any entry after the closing day are non-refundable.

The Club reserves the right to refuse any entry, subject to CKC Rules.

Armband numbers and judging schedules will be e-mailed as soon as possible after entries close.

**Eligibility:** Open to all purebred CKC recognized & CKC Miscellaneous breed (MCN), and non-recognized dogs eighteen months of age or older on the day of the event. Every dog entered must be one of the following: Registered with the CKC; have an Event Registration Number (ERN); eligible for registration with the CKC; have a Performance Event Number (PEN); or a Canine Companion Number (CCD).

Entries in the Draft Dog Excellent Test must have a CKC Draft Dog (DD) Title. Entries in the Brace Draft Dog Excellent Test must have a CKC Brace Draft Dog Title. The Judges must excuse a dog at any time during a test for lack of physical capacity.

**Entry Limit:** There is a limit of a combination of 10 Draft Dogs/10 Brace Draft Dogs and 5 Draft Dog Excellent/5 Brace Draft Dog

Excellent entries which will be accepted on a first come, first served basis.

**Entries:** Entries must be complete, signed & submitted to **The Entry Line**. The order of competing shall be the order that entries are received except those dogs handled by the same person will be separated when possible. No delays will be permitted for handlers entering more than one dog and entrants doing so must have an alternate handler available for the group down exercise if a conflict arises.

**Bitches in Season:** Bitches in season are allowed to compete but all exercises will be judged after all other dogs have been tested. Bitches in season must be kept away from the test site prior to testing.

**Equipment:** Each entrant must supply his or her own equipment and apparatus. The test committee will supply the freight load. DDX Entrants must provide their own backpacks and backpack weight.

## Test Regulations:

**All dogs entered in the Draft Dog Test must go through the basic control exercise, regardless of obedience titles held.**

## Effective January 1, 2024

The CKC will not consider a request for any corrections to results if received more than 90 days following the date(s) of the event(s). Exhibitors can verify the results at the event, watch for unofficial results to be posted on Canuck Dogs, or review the official results on your CKC portal where dogs are listed.
