GENERAL INFORMATION AND TEST RULES

ELIGIBILITY: Purebred or mixed-breed dogs must be at least 6 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Are eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

ENTRY LIMIT: Trials are limited to 39 Novice, Open or Excellent runs per trial. Day of trial entries will NOT be accepted at this event. If the tests fill, waiting lists will be kept and dogs from the waiting list may be entered and added.

Handlers may only enter 1 dog in each component at each level. Dogs can only be entered in Open and Excellent if they have already obtained the preceding level title.

MOVE UPS: Same day move ups for the next trial are allowed. Exhibitors must already be entered at the current level to move up. Same trial move ups will not be allowed.

NON-MEMBER PARTICIPATION FEE: The CKC has a tracking fee for non-members. Please refer to the information about this policy on the CKC website: https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Non-Member-Participation-Fee-Form-No-150-00-5

EQUIPMENT: The dog may wear a buckle, snap or martingale collar and/or body harness in the ring. Collars/harnesses with tags may be worn in the ring. Harnesses may have the leash attached to the front clip or on the back. Electronic training and pinch collars are not allowed on the rounds.

BITCHES IN SEASON: Bitches in season are not permitted to compete. If a bitch comes into season after entries have closed, the club will refund the entry fee providing the event secretary receives, on or before the event, a veterinarian's certificate declaring that the bitch was in season within the 10 day period preceding the trial.

BORDER CROSSING: A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

TEST SITE: No indoor kenneling. These tests will be run **rain or shine**. All dogs must be under control, on a leash except during the trial where off leash searches are permitted. **Flexi leads will not be allowed on the test site.** Remember that this is a public park used by families. Clean up after yourself and your dog.

Bathroom facilities are on site. A concession is available at Planet Ice within walking distance of the venue.

REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

CKC REGULATION: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
